- 1 AN ACT Relating to authorizing the growing of industrial hemp;
- 2 adding a new chapter to Title 15 RCW; creating a new section; and
- 3 providing an expiration date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature intends to authorize the
- 6 growing of industrial hemp as a legal, agricultural activity in this
- 7 state.
- 8 NEW SECTION. **Sec. 2.** The definitions in this section apply
- 9 throughout this chapter unless the context clearly requires
- 10 otherwise.
- 11 (1) "Grower" means any person or business entity growing
- 12 industrial hemp.
- 13 (2) "Hemp products" includes all products made from industrial
- 14 hemp including, but not limited to, cloth, cordage, fiber, food,
- 15 fuel, paint, paper, particle board, plastics, seed, seed meal and
- 16 seed oil for consumption, and certified seed for cultivation, if the
- 17 seeds originate from industrial hemp varieties.
- 18 (3) "Industrial hemp" means all parts and varieties of the plant
- 19 Cannabis sativa, cultivated or possessed by a grower, whether growing
- 20 or not, that contain a tetrahydrocannabinol concentration of 0.3

- 1 percent or less by weight, except that the THC concentration limit of
- 2 0.3 percent may be exceeded for licensed industrial hemp seed
- 3 research.
- 4 (4) "THC concentration" means percent of total THC, which is the
- 5 combined percent of delta-9 tetrahydrocannabinol and
- 6 tetrahydrocannabinolic acid in any part of the plant Cannabis sativa,
- 7 regardless of moisture content.
- 8 <u>NEW SECTION.</u> **Sec. 3.** Industrial hemp is an agricultural product
- 9 that may be grown, produced, possessed, and commercially traded in
- 10 the state.
- 11 <u>NEW SECTION.</u> **Sec. 4.** (1) Subject to receiving federal or
- 12 private funds for this purpose, Washington State University shall
- 13 study the feasibility and desirability of industrial hemp production
- 14 in Washington. In conducting the study, the Washington State
- 15 University shall gather information from agricultural and scientific
- 16 literature, consult with experts and the public, and review the best
- 17 practices of other states and countries worldwide regarding the
- 18 development of markets for industrial hemp and hemp products. The
- 19 study must include an analysis of:
- 20 (a) The market economic conditions affecting the development of
- 21 an industrial hemp industry in the state;
- 22 (b) The estimated value-added benefit that Washington's economy
- 23 would reap from having a developed industrial hemp industry in the
- 24 state;
- 25 (c) Whether Washington soils and growing conditions are
- 26 appropriate for use of hemp in the rotation of other crops and
- 27 whether soils and growing conditions are appropriate for farming
- 28 industrial hemp at economically viable levels;
- 29 (d) The agronomy research being conducted worldwide relating to
- 30 industrial hemp varieties, production, and use; and
- 31 (e) Other legislative acts, experiences, and outcomes around the
- 32 world regarding industrial hemp production.
- 33 (2)(a) Washington State University shall report its findings to
- 34 the legislature by January 14, 2016.
- 35 (b) The report must include recommendations for any legislative
- 36 actions necessary to encourage and support the development of an
- 37 industrial hemp industry in the state of Washington.
- 38 (3) This section expires August 1, 2016.

- 2 constitute a new chapter in Title 15 RCW.
