## SENATE BILL 5857

State of Washington 64th Legislature 2015 Regular Session

Read first time 02/05/15. Referred to Committee on Health Care.

- 1 AN ACT Relating to registration and regulation of pharmacy
- 2 benefit managers; amending RCW 19.340.030 and 19.340.010; adding a
- 3 new section to chapter 19.340 RCW; adding a new section to chapter
- 4 48.02 RCW; prescribing penalties; and providing an effective date.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 19.340.030 and 2014 c 213 s 2 are each amended to read as follows:
- 8 (1) To conduct business in this state, a pharmacy benefit manager 9 must register with the ((department of revenue's business licensing 10 service)) office of the insurance commissioner and annually renew the 11 registration.
- 12 (2) To register under this section, a pharmacy benefit manager 13 must:
  - (a) Submit an application requiring the following information:
- 15 (i) The identity of the pharmacy benefit manager;
- 16 (ii) The name, business address, phone number, and contact person 17 for the pharmacy benefit manager; and
- 18 (iii) Where applicable, the federal tax employer identification 19 number for the entity; and
- 20 (b) Pay a registration fee of two hundred dollars.

1 (3) To renew a registration under this section, a pharmacy 2 benefit manager must pay a renewal fee of two hundred dollars.

- (4) All receipts from registrations and renewals collected by the ((department)) commissioner must be deposited into the ((business license account created in RCW 19.02.210)) insurance commissioner's regulatory account created in RCW 48.02.190.
- NEW SECTION. Sec. 2. A new section is added to chapter 19.340 RCW to read as follows:
  - (1) The commissioner shall have enforcement authority over this chapter and shall have authority to render a binding decision in any dispute between a pharmacy benefit manager, or third-party administrator of prescription drug benefits, and a pharmacy arising out of an appeal regarding drug pricing and reimbursement. The commissioner shall not be bound by any arbitration agreements between a pharmacy benefit manager and a pharmacy and shall not be bound by any mediation or arbitration decisions.
  - (2) Any person, corporation, or third-party administrator of prescription drug benefits, pharmacy benefit manager, or business entity which violates any provision of this chapter shall be subject to a civil penalty in the amount of one thousand dollars for each act in violation of this chapter or, if the violation was knowing and willful, a civil penalty of five thousand dollars for each violation of this chapter.
  - (3) Any pharmacy or pharmacist shall not be billed or paid at or below the cost of the drug to the pharmacy. Any pharmacy or pharmacist injured as a result of a violation of this chapter may bring an action against that person, corporation, or third-party administrator of prescription drug benefits, pharmacy benefit manager, or business entity violating this chapter for the recovery of all actual damages occurring as a result thereof, plus attorneys' fees.
- **Sec. 3.** RCW 19.340.010 and 2014 c 213 s 1 are each amended to 33 read as follows:
- The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
- 36 (1) "Claim" means a request from a pharmacy or pharmacist to be 37 reimbursed for the cost of filling or refilling a prescription for a 38 drug or for providing a medical supply or service.

- 1 (2) <u>"Commissioner" means the insurance commissioner established</u>
  2 in chapter 48.02 RCW.
  - (3) "Insurer" has the same meaning as in RCW 48.01.050.

- 4  $((\frac{3}{3}))$   $\underline{(4)}$  "Pharmacist" has the same meaning as in RCW 5 18.64.011.
- 6 (((4))) (5) "Pharmacy" has the same meaning as in RCW 18.64.011.
- 7  $((\frac{(5)}{)})$   $\underline{(6)}$ (a) "Pharmacy benefit manager" means a person that 8 contracts with pharmacies on behalf of an insurer, a third-party 9 payor, or the prescription drug purchasing consortium established 10 under RCW 70.14.060 to:
- 11 (i) Process claims for prescription drugs or medical supplies or 12 provide retail network management for pharmacies or pharmacists;
- 13 (ii) Pay pharmacies or pharmacists for prescription drugs or 14 medical supplies; or
- 15 (iii) Negotiate rebates with manufacturers for drugs paid for or 16 procured as described in this subsection.
- 17 (b) "Pharmacy benefit manager" does not include a health care 18 service contractor as defined in RCW 48.44.010.
- 19  $((\frac{6}{}))$   $(\frac{7}{})$  "Third-party payor" means a person licensed under RCW 20 48.39.005.
- NEW SECTION. Sec. 4. A new section is added to chapter 48.02 22 RCW to read as follows:
- 23 (1) The commissioner shall accept registration of pharmacy 24 benefit managers as established in RCW 19.340.030 and receipts shall 25 be deposited in the insurance commissioner's regulatory account.
- 26 (2) The commissioner shall have enforcement authority over 27 chapter 19.340 RCW consistent with requirements established in 28 section 2 of this act.
- NEW SECTION. Sec. 5. Section 1 of this act takes effect January 30 1, 2016.
