- 14 $((\frac{3}{3}))$ (c) Any sale or exchange of all or substantially all of the property and assets of the association not made in the usual and

- 17 not including a sale pursuant to an order of a court having
- 18 jurisdiction in the premises or a sale for cash on terms requiring
- 19 that all or substantially all of the net proceeds of the sale be
- 20 distributed to the members in accordance with their respective
