# **House Bills**

HB 1000 by Representatives Blake and Kretz

Concerning water rights appurtenant to land managed by the department of fish and wildlife.

Requires the department of fish and wildlife to maintain and annually update an inventory of water rights appurtenant to each parcel of land owned or managed by the department.

Creates the habitat enhancement and leasing account.

Funding education first.

Requires appropriations for K-12 basic education, together with appropriations for other K-12 education programs, to be passed as separate legislation by both houses of the legislature and delivered to the governor at a specified point in the regular legislative session.

Directs the legislature to make provision for full funding of these K-12 appropriations from within existing revenue sources without relying on new tax sources or rates.

# HB 1002 by Representative DeBolt

Prohibiting unfair and deceptive dental insurance practices.

Addresses limited health care service contractors that offer coverage for dental care services.

HB 1003 by Representatives Hawkins, Lytton, Magendanz, Bergquist, Hayes, Robinson, Parker, Ortiz-Self, Harris, Reykdal, Johnson, Senn, Muri, Farrell, Klippert, Pollet, Nealey, Manweller, Kretz, and Hargrove

Concerning the development of a model policy on natural disaster school infrastructure recovery.

Requires the state school directors' association to: (1) Develop a model policy addressing restoration of the safe learning environment disrupted by natural disaster impacts to school district infrastructures; and

(2) Distribute the model policy to school districts, with encouragement to adopt the model policy locally and review the safe school plan.

Expires September 1, 2016.

Clarifying provisions that allow for the tasting of alcohol by students under twenty-one years of age.

Addresses special permits that allow the tasting of alcohol by certain persons who are at least eighteen years of age.

### HB 1005 by Representatives Cody and Schmick

Addressing third-party payor release of health care information.

**HB 1006** by Representatives Sawyer, G. Hunt, Dunshee,

Providing damages for wage violations.

Increases the penalty for certain wage violations.

HB 1007 by Representatives Fey, Kochmar, Clibborn, Muri, Bergquist, and Klippert

Limiting the use of automated traffic safety cameras to detect speed violations not in school zones to certain cities.

Authorizes a city with a population of more than one hundred ninety-five thousand located on the west side of the Cascade mountain range to operate an automated traffic safety camera to detect speed violations subject to certain limitations.

## **HB 1008** by Representatives Smith and Hudgins

Authorizing the state auditor to conduct audits of state government and local agencies' data storage and management practices thereby protecting privacy and securing personal information from computer hacking or misuse of data.

Authorizes the state auditor to conduct an audit of a state or local agency's data management and storage practices.

Requires state agencies and local governments to report known or suspected computer breaches to the state auditor's office.

Jan 12 First reading, referred to Gen Govt & Info Tech (Not Officially read and referred until adoption of Introduction report).

# HB 1009 by Representatives Manweller and Hawkins

Allowing rural counties providing emergency medical services to locations with a rural amphitheater to impose an additional admissions surcharge.

Authorizes the legislative authority of a county with a rural amphitheater to levy and fix an emergency medical services surcharge of up to one dollar per person.

Requires the attorney general to appear for and represent a county imposing the surcharge with respect to an action or proceeding arising from the imposition of the surcharge.

Addresses state-licensed optometrists' referrals of medical cases to occupational therapists.

# HB 1011 by Representatives Short, Takko, Springer, Buys, Kretz, and Shea

Assigning counties to two climate zones for purposes of the state building code.

Updates certain statutes to be more reflective of modifications in the 2012 international energy conservation code.

# HB 1012 by Representative Appleton

Expanding the duties and obligations of manufactured/mobile home community landlords.

Addresses rental agreements, landlord duties, and prohibited conduct with regard to manufactured/mobile home communities.

# **HB 1013** by Representatives Appleton, Johnson, Hansen, and Takko

Authorizing regular meetings of county legislative authorities to be held at alternate locations within the county.

Authorizes regular meetings of county legislative authorities to be held at a location outside of the county seat but within the county if the county legislative authority determines that holding a meeting at an alternate location would be in the interest of supporting greater citizen engagement in local government.

Concerning antifreeze products.

Authorizes a person to apply to a sentencing court for a vacation of his or her record of conviction for certain alcohol driving violations if certain conditions have been met.

Authorizes a person to apply to a sentencing court for vacation of the records of conviction for more than one misdemeanor or gross misdemeanor offense at one time, if not otherwise prohibited.

# HB 1018 by Representative Appleton

Preventing breed-based dog regulations.

Prohibits the breed of a dog from being considered when declaring a dog dangerous or potentially dangerous.

Prohibits a local jurisdiction from prohibiting possession of a particular breed of dog or declaring a breed of dog to be dangerous or potentially dangerous.

Directs the legislature to appoint a work group of at least twelve medical cannabis stakeholders to study the potential benefits and drawbacks of a voluntary patient registry or uniform identification system compared to the current required valid documentation.

# HB 1021 by Representative Appleton

Creating a silver alert system.

Requires the Washington state patrol to develop and implement a plan, commonly known as a silver alert plan, for voluntary cooperation between certain parties to enhance the public's ability to assist in recovering senior citizens aged sixty-five or older, with a diagnosis of Alzheimer's disease, dementia, or other mental disability.

Requiring the submission of a waiver to the federal government to create the Washington health security trust.

Creates the Washington health security trust to provide coverage for a set of health services for all residents.

Requires the joint select committee on health care oversight to contract for an actuarial analysis of the funding needs of the Washington health security trust and recommend a funding mechanism to the appropriate legislative standing committees and the governor.

Directs the legislature to enact legislation implementing the recommendations of the joint select committee during the 2016 regular legislative session.

Creates the reserve account, the displaced worker training account, and the benefits account.

Provides contingent effective dates.

Authorizes a federally recognized Indian tribe, tribal organization, or urban Indian organization to train, employ, or contract with or for the services of a dental health aide, including a dental health aide therapist.

Directs the state health care authority to coordinate with the centers for medicare and medicaid services to ensure the dental health aide services are eligible for maximum federal funding of up to one hundred percent.

(2) Meet the state's need for individuals with higher education degrees and certificates that are in demand by employers, such as in the fields of science, including health science, technology, engineering, and math.

Creates the Washington advance higher education loan account.

Provides a July 1, 2021, expiration date for the pilot program.

# HB 1032 by Representatives Blake and Hurst

Encourages habitat projects that provide a public benefit by providing an exemption for the application fee for a hydraulic project permit or permit modification.

Requires the department of fish and wildlife to use money made available to it under section 2(7) of this act to fund a program designed to assist private landowners in mitigating the damages and expenses incurred due to allowing public access to their lands for hunting.

Allows a person convicted of a misdemeanor marijuana offense, who was twenty-one years of age or older at the time of the offense, to apply to the sentencing court for a vacation of the applicant's record of conviction for the offense.

# HB 1044 by Representatives Santos, Morris, and Smith

Increasing the regulatory oversight and accountability of the office of minority and women's business enterprises.

Requires the office of minority and women's business enterprises to identify state agencies and educational institutions: (1) In the lowest quintile of utilization of minority and women-owned contractors as a percentage of all contracts issued by the agency;

- (2) In the lowest quintile of the dollar value awarded to minority and women-owned contractors as a percentage of the dollar value of all contracts issued by the agency; and
- (3) That are performing significantly below their established goals, as determined by the office.

Establishes an investigation unit within the office for the purpose of detecting and investigating fraud and violations.

HB 1045 by Representatives Tharinger, Harris, Van De Wege, Rodne, Moeller, Clibborn, Cody, G. Hunt, and Jinkins

Concerning the practice of East Asian medicine.

Creates the Washington state East Asian medicine advisory committee.

Requires the committee to advise and make recommendations to the secretary of the department of health on standards for the practice of East Asian medicine.
