HB 1010-S by House Committee on Health Care & Wellness (originally sponsored by Representatives Johnson, Cody, Harris, Moeller, Manweller, Walsh, Clibborn, Robinson, Tharinger, Riccelli, Rodne, Short, Gregerson, and Buys)

Concerning referral of medical cases to occupational therapists.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses state-licensed optometrists' referrals of medical cases to occupational therapists.

Jan 30 HCW - Majority; 1st substitute bill be substituted, do pass.

HB 1045-S by House Committee on Health Care & Wellness (originally sponsored by Representatives Tharinger, Harris, Van De Wege, Rodne, Moeller, Clibborn, Cody, G. Hunt, Jinkins, Gregerson, Santos, and Riccelli)

Concerning the practice of East Asian medicine.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Creates the Washington state East Asian medicine advisory committee.

Requires the committee to advise and make recommendations to the secretary of the department of health on standards for the practice of East Asian medicine.

Requires East Asian medicine practitioners and licensed acupuncturists to, in an emergency: (1) Initiate the emergency medical system by calling 911;

(2) Request an ambulance; and

(3) Provide patient support until emergency response arrives.

HB 1053-S by House Committee on Health Care & Wellness (originally sponsored by Representatives Kirby and Schmick)

Concerning the filing of group health benefit plans other than small group plans, stand-alone dental plans, and stand-alone vision plans by disability insurers, health care service contractors, and health maintenance organizations.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Enhances competition and creates regulatory uniformity in the filing requirements for group plans other than small group health benefit plans, as well as stand-alone dental plan and stand-alone vision plan rates and forms.

Jan 30 HCW - Majority; 1st substitute bill be substituted, do pass.

Feb 3 Referred to Rules 2 Review.

HB 1100-S by House Committee on Technology & Economic Development (originally sponsored by Representatives Morris, S. Hunt, Hudgins, Ormsby, and Fey)

Creating new appliance efficiency standards.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses new energy efficiency standards for the following new products sold, offered for sale, or installed in the state: (1) Certain halogen lamps;

(2) Certain battery charger systems;

(3) Small diameter directional lamps;

- (4) State-regulated LED lamps; and
 (5) HVAC air filters.

Providing access to the prescription drug monitoring database for clinical laboratories.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes the department of health to provide data in the prescription monitoring program to the personnel in certain test sites.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Includes in the crime of assault in the third degree, assault of a utility worker, or employee of a publicly or privately owned utility company or agency, who is at the time of the act engaged in official duties.

Clarifying the authority of local law enforcement agencies to use unmarked vehicles.

Clarifies the authority of local law enforcement agencies to use unmarked vehicles.

Concerning the transfer of school district territory initiated by school district boards of directors.

HB 1954 by Representative Pike

Creating a task force on the Columbia river gorge commission.

Creates the legislative task force on the Columbia river gorge commission.

Requires the task force to meet and work with the Columbia river gorge commission and a corresponding task force authorized by the state of Oregon to address a range of topics relating to the Columbia river gorge national scenic area act.

Expires December 30, 2016.

Provides a definition for "satisfactory academic progress" for purposes of chapter 28B.92 RCW (state student financial aid programs).

Creating independent review organizations.

Creates independent review organizations.

HB 1957 by Representatives Walkinshaw, Bergquist, Pollet, and Carlyle

Concerning the maximum total dollar amount that may be awarded under a job order contract for cities with a population of more than four hundred thousand.

Specifies that the maximum total dollar amount that may be awarded under a job order contract for cities with a

population of more than four hundred thousand is six million dollars per year for a maximum of three years.

HB 1958 by Representatives Zeiger, Pollet, Haler, Stambaugh, Hargrove, Magendanz, Buys, and Bergquist

Limiting the cost of assigned textbooks for institutions of higher education.

Prohibits an institution of higher education from assigning a student to purchase a textbook that costs more than one hundred dollars unless certain circumstances exist.

HB 1959 by Representatives Dunshee, Riccelli, Walsh, DeBolt, MacEwen, and Ormsby; by request of Public Works Board

Changes the composition of the public works board.

Requires the public works board to: (1) Establish policies and procedures designed to manage the public works assistance account in such a way as to ensure sustainability of the account; and

(2) Implement policies and procedures designed to maximize local government use of federal funds to finance local infrastructure projects.

Requires preconstruction and construction loans that fund projects involving repair, replacement, or improvement of a wastewater treatment plant or other public works facility for which an investment grade efficiency audit is obtainable, to include a condition that the loan recipient undertake an investment grade efficiency audit.

Addresses low interest and interest-free loans and numerically ranking public works projects.

HB 1960 by Representatives Sullivan, S. Hunt, Ortiz-Self, Pettigrew, Bergquist, and Santos

Concerning the Washington community learning center program.

Expands the purpose of the Washington community learning center program to include: (1) Supporting the creation, expansion, and quality improvement of community learning centers that target communities of color, rural communities, and low-income communities;

(2) Providing smaller independent after-school programs a greater opportunity to access grant funds; and

(3) Implementing the field-driven quality standards for after-school, summer, and youth development programs.

Requires the office of the superintendent of public instruction to create the Washington community learning center advisory council.

Decodifies, expires, and makes nonsubstantive changes to community and technical college provisions.

HB 1962 by Representatives Griffey, Peterson, Harmsworth, Wilson, Scott, Van Werven, Stokesbary, Condotta, and Hayes

Regulating disclosure of process server social security numbers.

Prohibits a county auditor that collects social security numbers from process servers from displaying or releasing a process server's social security number on any document or web site issued or maintained by the auditor.

HB 1963 by Representatives Griffey, Dent, Short, Van Werven, Young, Blake, Wilson, Fagan, and Buys

Requiring that the departments of fish and wildlife and ecology use empirical science to support agency actions affecting land use.

Requires significant agency actions by the department of ecology and the department of fish and wildlife to be supported with empirical science acquired through proper use of the scientific method, peer review, reproduction of results, and journal publication.

HB 1964 by Representatives Blake, Haler, MacEwen, and Ormsby

Addressing the public employees' collective bargaining act as applied to commissioned officers of the department of fish and wildlife.

Specifies that the public employees' collective bargaining act applies to the state with respect to commissioned officers, except for captains, of the department of fish and wildlife.

 (2) Licenses relating to marijuana.
 Creates the licensing and enforcement system modernization project account.

 Excludes from the definition of "to manufacture," with regard to business and occupation taxes, the production of compressed natural gas or liquefied natural gas for the sole purpose of providing fuel for vehicles operated by a public transportation benefit area or a public transportation system.

 (2) Planned permanent living arrangements.

 Revises requirements of the Washington charter school commission when authorizing charter schools.
 Addresses successor members of the Washington charter school commission.

 Regulates the professional conduct of licensed health care providers with respect to performing sexual orientation change efforts on patients under age eighteen.

Creating an open education pilot program at Eastern Washington University.

Creates the Washington open education pilot program at Eastern Washington University to reduce students' cost of attendance by creating an open educational resources program.

Requires the Eastern Washington University libraries to award up to ten grants per year to faculty members to develop or obtain open educational materials and resources.

HB 1974 by Representatives Stambaugh, Sells, Muri, Klippert, Senn, Robinson, and Tarleton

Requires three educational service districts to implement a pilot program to create regional school safety and security centers in each of the districts.

Expires December 31, 2017.

HB 1975 by Representatives Blake, Hurst, and Vick

Exempting distillers from certain licensing fees.

Exempts from license issuance fees, holders of a distiller/rectifier license that distill and manufacture spirits.

Feb 4 First reading, referred to Commerce & Gaming (Not Officially read and referred until adoption of Introduction report).

HB 1976 by Representatives Vick, Blake, Hurst, and Tharinger

Concerning marketing opportunities for spirits produced in Washington by craft and general licensed distilleries.

Authorizes certain distilleries to: (1) Serve samples and sell spirits produced in this state for consumption off the premises;

(2) Apply to the state liquor control board for an endorsement to sell spirits of its own production at retail for off-premises consumption at a qualifying farmers market; and

(3) Apply to the state liquor control board to deliver or ship its spirits to a person within the state.

HB 1977 by Representatives Moscoso, Orcutt, Clibborn,

Bergquist, Zeiger, Pollet, and Tarleton

Creating a tuition and fees exemption for children and surviving spouses of certain highway workers.

Exempts children and surviving spouses of highway workers employed by a transportation agency from paying tuition fees and services and activities fees.

HB 1978 by Representative Appleton

Amending the patient bill of rights to ensure continuity of care.

Requires each health carrier to cover services of a hospital, whose contract with the plan is being terminated by either the plan or the hospital, through the duration of the plan year for all enrollees enrolled in products allowing in-network access to the hospital at the time of termination.

HB 1979 by Representatives Kilduff, Hurst, and Ormsby

Prohibiting legislators from accepting meals.

Prohibits a legislator from accepting a meal from a lobbyist, a lobbyist employer, or anyone seeking to influence.

Feb 4 First reading, referred to State Government (Not Officially read and referred until adoption of Introduction report).

HB 1980 by Representative Springer

Implementing recommendations of the sunshine committee.

Implements the sunshine committee's recommendations on exemptions from disclosure with regard to: (1) A guardian ad litem's background information record that contains results of a criminal background check and the criminal history from the federal bureau of investigation;

(2) Certain financial information identifiable to an individual that concerns the amount and conditions of his or her assets, liabilities, or credit;

(3) Information contained in a local or regionally maintained gang database; and

(4) Proprietary reports or information obtained by the Washington pollution liability insurance program director in soliciting bids from insurers.

Allows participants' names, general locations, and e-mail addresses to be disclosed to other persons who apply for ride-matching services and who need that information in order to identify potential riders or drivers with whom to share rides.

HB 1981 by Representative Pollet

Creating an elementary science education program pilot project.

Creates the elementary science education program pilot project to provide elementary students with strong science instruction by creating a system of support for teachers and students.

Requires the office of the superintendent of public instruction to develop a competitive application process for the project.

Expires June 30, 2018.

HB 1982 by Representatives Pollet, Walkinshaw, Gregerson, Carlyle, Tarleton, and Orwall

Enhancing student completion through advising, mentoring, recapture initiatives, remedial programs, and accelerated precollege instruction and creating the innovations for student completion program.

Creates the innovations for student completion program to determine whether student support services, such as advising, mentoring, recapture, and accelerated precollege instruction, boost student retention, completion rates, and the number of degrees and certificates awarded at institutions of higher education.

Requires the state board for community and technical colleges to administer: (1) The program for the state's community and technical colleges;

(2) A competitive grant program for the community and technical colleges that want to pursue innovative advising, mentoring, and service learning programs; and

(3) An innovative grant program for community or technical colleges to expand their integrated basic education and skills training program to adult basic education and English as a second language students.

Requires the baccalaureate institutions of higher education to each administer an innovations for student completion program on their campuses.

Requires the student achievement council to administer a competitive grant program for the baccalaureate institutions of higher education that want to pursue innovative advising, mentoring, and service learning programs.

Requires an attendance pilot project to be established at a community or technical college to be selected by the state board for community and technical colleges.

HB 1983 by Representatives Pollet, Zeiger, S. Hunt, Haler, and Bergquist

Creating the TEACH pilot project of financial assistance for teachers taking basic skills and content tests for teacher certification programs.

Creates the teacher endorsement and certification help pilot project to develop an expandable program that

provides grants to teachers taking basic skills and content tests for teacher certification programs.

Requires the student achievement council and the professional educator standards board to make financially needy students aware of the pilot project.

Expires June 30, 2021.

HB 1984 by Representatives Pollet, Appleton, Ryu, Stanford, and Gregerson

Concerning the use of certain chemicals in food.

Prohibits manufacturers, wholesalers, and retailers from manufacturing, selling, offering for sale, or distributing for use in this state, bottles, cups, or reusable food and beverage containers that contain phthalates individually or in combination at more than 0.10 percent by weight or one thousand parts per million or bisphenol A.

Prohibits persons and entities from manufacturing, selling, or distributing in commerce in this state, food intended for or marketed to youth that contains or is stored in food packaging that contains phthalates individually or in combination at more than 0.10 percent by weight or one thousand parts per million or bisphenol A.

HB 1985 by Representatives Pollet, Ryu, Van De Wege, Gregerson, and Tharinger

Protecting human health by labeling foods exposed to human sewage.

Prohibits the sale, at wholesale or retail, of food or food products grown in sewage, sewage sludge, biosolids, compost derived from or containing human waste, or any form or amount of human waste, unless the food or food products are labeled with the words "Grown in Sewage Sludge."

HJM 4006 by Representatives Shea and Taylor

Petitioning for the creation of a new state in eastern Washington.

Petitions for the creation of a new state in eastern Washington.

Senate Bills

SB 5083-S by Senate Committee on Early Learning & K-12 Education (originally sponsored by Senators McAuliffe, Litzow, Rolfes, McCoy, Billig, Darneille, Kohl-Welles, Frockt, and Fraser)

Enacting the sudden cardiac arrest awareness act.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Establishes the sudden cardiac arrest awareness act.

Requires the Washington interscholastic activities association to work with member schools' board of directors, a nonprofit organization that educates communities about sudden cardiac arrest in young athletes, and the University of Washington medicine center for sports cardiology to develop and make available an online pamphlet that provides youth athletes, their parents or guardians, and coaches with information about sudden cardiac arrest.
