#### **House Bills**

HB 2559 by Representatives S. Hunt, Stanford, Jinkins, Ormsby, and Pollet; by request of Public Disclosure Commission

Providing enhanced disclosure requirements for large campaign contributions.

Requires treasurers to electronically file with the public disclosure commission a special report when a contribution of twenty-five thousand dollars or more is received from a single entity outside of a special reporting period.

Requires a political committee to electronically file with the public disclosure commission a special report when it makes a contribution of twenty-five thousand dollars or more outside of a special reporting period.

Requires treasurers and political committees to file certain other information electronically with the public disclosure commission.

**HB 2560** by Representatives S. Hunt, Jinkins, and Pollet; by request of Public Disclosure Commission

Providing surplus campaign funds account reporting requirements.

Requires each treasurer of a surplus funds account to file with the public disclosure commission a report containing certain required information only if the expenditures in the preceding calendar month or the total expenditures made since the last report exceed two hundred dollars.

Standardizing disclosure requirements for political committees.

Standardizes disclosure requirements for political committees.

HB 2562 by Representatives S. Hunt, Jinkins, and Pollet; by request of Public Disclosure Commission

Concerning the definition of "contribution" for the purposes of campaign disclosure provisions.

Excludes the following from the definition of "contribution" for purposes of the fair campaign practices act: The financing by a person of the dissemination,

distribution, or republication of a portion of electronic political advertising prepared by a candidate, a political committee, or its authorized agent, if the republished portion, by itself, does not promote or oppose the subject of the original political advertising.

HB 2563 by Representatives S. Hunt, Moeller, Jinkins, and Pollet; by request of Public Disclosure Commission

Concerning electronic filing requirements for campaignrelated expenditures and contributions.

Revises the fair campaign practices act.

Requires the following to electronically file certain information with the public disclosure commission: Candidates, political committees, treasurers, sponsors of political advertising, lobbyists, employers of lobbyists, elected officials, and executive state officers, appointees, and candidates.

Authorizes the public disclosure commission to make exceptions, on a case-by-case basis, for a person who demonstrates the technological inability to file reports using the electronic means provided or approved by the commission.

HB 2564 by Representatives Manweller, Vick, and Gregerson

Concerning the property tax exemption for public burying grounds and cemeteries.

Addresses exemptions from property taxes for real and personal property used for public burying grounds and cemeteries.

HB 2565 by Representatives Vick, Reykdal, Orcutt, Wilson, Springer, Robinson, Nealey, Wilcox, Manweller, Stokesbary, Condotta, Pike, Haler, Frame, Hargrove, and Muri

Reducing the frequency of local sales and use tax changes. Removes the option for a local sales and use tax change to take effect on the first day of October.

#### -- 2016 REGULAR SESSION --

HB 2566 by Representatives Fitzgibbon and McBride

Facilitating the disposal of contaminated dredged sediments.

Revises the model toxics control act to facilitate the disposal of contaminated dredged sediments.

Declares it is the policy of the state to encourage commerce and navigation by facilitating the use of aquatic land dredged material disposal sites on state-owned aquatic lands consistent with other environmental permitting and authorization processes.

### **HB 2567** by Representative Clibborn

Correcting certain manifest drafting errors in chapter 44, Laws of 2015 3rd sp. sess. (transportation revenue).

Provides that during the third special legislative session of 2015, the legislature passed a significant transportation revenue bill (2ESSB 5987). However, since then certain drafting errors were discovered that resulted in some provisions being enacted contrary to legislative intent. Therefore, it is the intent of the legislature to simply correct those manifest drafting errors in order to conform certain provisions with the original legislative intent.

HB 2568 by Representatives Blake, Buys, Moscoso, Fitzgibbon, McBride, and Ormsby

Managing Capitol lake as an estuarine environment.

Requires the state capitol committee to provide for the management, protection, preservation, and coordination of Capitol lake as an estuarine environment.

Requires Capitol lake to be: (1) Managed and maintained in coordination with interests within the Deschutes watershed and Budd Inlet; and

(2) Comanaged by certain Indian tribes.

Requires the department of enterprise services to: (1) Coordinate with the jurisdictions with interest within the Deschutes watershed and Budd Inlet; and

(2) Immediately begin planning for and implementing a transition for Capitol lake from a lake environment to an estuarine environment.

HB 2569 by Representatives Sells, Hayes, Van De Wege, Ormsby, Hickel, and Senn

Authorizing the use of high occupancy vehicle lanes by law enforcement and fire department vehicles.

Prohibits the following vehicles from being restricted from a highway in the state designated as a high occupancy vehicle lane: (1) An officially marked law enforcement or fire department vehicle equipped with emergency lights and siren operated by on-duty state patrol or local law enforcement personnel or on-duty local or special district fire department personnel; and

(2) An unmarked law enforcement vehicle operated by on-duty state patrol or local law enforcement personnel in the process of being used to conduct an active investigation.

HB 2570 by Representatives Taylor, Shea, MacEwen, Holy, Condotta, Rodne, G. Hunt, Young, and Haler

Limiting the subpoena power of special inquiry judges.

Prohibits a public attorney, corporation counsel, city attorney, special inquiry judge, or certain other persons from searching or seizing personal banking records without: (1) The informed consent of the account holder;

- (2) A warrant, based upon probable cause, describing the person, place, or thing to be searched or seized; or
- (3) A legally recognized exception to the warrant requirement.

HB 2571 by Representatives Dent, Blake, Buys, Chandler, Peterson, Johnson, Manweller, Walsh, Holy, Caldier, Klippert, Schmick, and Griffey

Concerning sales of personal property used in conducting a farm activity where the sale is made by or through an auctioneer.

Addresses sales and use tax exemptions on the sale of personal property used in conducting a farm activity where the sale is made by or through an auctioneer and is held or conducted upon a farm.

HB 2572 by Representatives Dent, Blake, Buys, Schmick, Chandler, Peterson, Manweller, Johnson, Walsh, Holy, Caldier, Klippert, Griffey, Haler, and Hargrove

Concerning a sales and use tax exemption for replacement parts for agricultural aircraft.

Addresses sales and use tax exemptions for replacement parts for agricultural aircraft.

### -- 2016 REGULAR SESSION --

Jan 15 First reading, referred to Finance (Not Officially read and referred until adoption of Introduction report).

HB 2573 by Representatives Santos, Magendanz, Kilduff, Reykdal, Rossetti, Muri, Pollet, and Hickel; by request of Superintendent of Public Instruction

Concerning the shortage of public school teachers and substitute teachers.

Requires the superintendent of public instruction, in consultation with school district and educational service district personnel, to develop and implement a comprehensive, statewide initiative to increase the number of qualified individuals who apply for teaching positions in the state.

Authorizes, under certain circumstances and in addition to postretirement employment options, a teacher in plan 2 or plan 3 who has retired under alternate early retirement provisions to be employed with an employer that has documented a shortage of certificated substitute teachers without a suspension of the retiree's benefit.

Requires a professional certificate to be issued to certain experienced out-of-state teachers if the teacher: (1) Holds a valid teaching certificate issued by the national board for professional teaching standards; or

(2) Has a second-level teacher certificate from another state.

Makes an appropriation.

HB 2574 by Representatives Farrell, Fey, Peterson, Moscoso, Clibborn, Fitzgibbon, Kilduff, Robinson, McBride, and Gregerson

Enhancing public safety by reducing distracted driving incidents caused by the use of personal wireless communications devices.

Revises existing cell phone laws in order to qualify for federal funds that have been set aside to combat the emerging national problem of distracted driving.

Requires the director of the department of licensing to incorporate questions on distracted driving into the driver licensing examination.

HB 2575 by Representatives Farrell, Fitzgibbon, Peterson, Walkinshaw, Frame, McBride, Stanford, Jinkins, Ormsby, Gregerson, Senn, Pollet, and Tharinger

Continuing state efforts to increase oil transportation safety.

Requires the department of ecology to: (1) Update the study of oil shipment through the state that was conducted pursuant to the operating budget proviso in 2014;

- (2) Update the study and associated recommendations and submit the update to the appropriate legislative policy and fiscal committees;
- (3) Consult with the emergency management division of the state military department, the utilities and transportation commission, the department of transportation, and, as appropriate, other federal and state

agencies, tribal governments and commissions, and public and private organizations;

- (4) Compile a master document that summarizes the anticipated cumulative environmental impacts associated with oil facility infrastructure development proposals that were active as of January 1, 2016; and
- (5) Contract with an eligible independent third party to update the October 2006 report to the state emergency response commission regarding statewide response to chemical, biological, radiological, nuclear, and explosive materials.

Expires June 30, 2019.

Concerning public records act requests to local agencies.

Revises the public records act with regard to requests to local agencies.

Creates the public records commission to administer the provisions of the public records act.

Authorizes public agencies to recover their costs for public records requests by charging a reasonable fee when records are requested for the purpose of sale or resale.

Creates the dedicated open records account.

HB 2577 by Representatives Wylie, Blake, S. Hunt, Vick, and Kretz

Authorizing preferential pricing for spirits and wine sold to on-premises licensees.

Restores the policy of authorizing preferential pricing of spirits and wine sold to on-premises licensees.

HB 2578 by Representatives Jinkins, Manweller, Gregerson, McCabe, G. Hunt, Tharinger, Rossetti, and Zeiger

Addressing job search requirements for unemployment compensation claimants.

Modifies unemployment compensation provisions regarding job search requirements for claimants.

HB 2579 by Representatives Griffey, Goodman, Orwall, Dent, Wilson, Van De Wege, and

**McBride** 

Concerning prefire mitigation.

Requires the director of fire protection to develop a statewide plan for prefire mitigation that will require coordination with local fire departments to develop individualized community-wide protection plans that include public education such as firewise, partnership building, and personal wildfire action plans in the event of a wildfire.

Requires the office of the state fire marshal to identify priority interface zones and work to develop a grant program to assist local jurisdictions in the voluntary adoption of the international wildland urban interface code.

Creates the wildfire prevention account.

Jan 15 First reading, referred to Agriculture & Natural Resources (Not Officially read and referred until adoption of Introduction report).

HB 2580 by Representatives Cody, Rodne, Robinson, Johnson, and Jinkins

Establishing a public registry for the transparency of blood establishments.

Prohibits a blood-collecting or distributing establishment from collecting or distributing blood for transfusion in the state, unless it is registered by the department of health.

Requires the department of health to: (1) Deny or revoke the registration of an establishment upon a determination that it no longer holds a license issued by the federal food and drug administration; and

(2) Create and maintain an online public registry of all registered blood-collecting or distributing establishments that supply blood products for transfusion in the state, including all clients that each establishment serves.

Concerning the alcohol content of cider.

Addresses the amount of alcohol, by volume, in cider.

HB 2582 by Representatives Bergquist, Stokesbary, Orwall, Gregerson, Zeiger, and Hickel

Modifying provisions of the Washington advanced college tuition payment program.

Recharges the Washington advanced college tuition payment program by: (1) Allowing purchasers to buy more tuition units per beneficiary;

- (2) Allowing beneficiaries to use more units per year; and
- (3) Requiring that the payout value of a tuition unit increases with the rate of inflation in any year in which the unit value is greater than one percent of a full year of full-time undergraduate tuition and fee charges at the most expensive state institution of higher education in the state.

Authorizing specified local governments to designate a portion of their territory as a creative district subject to certification by the Washington arts commission.

Authorizes a local government to designate a creative district within its territorial boundaries subject to certification as a state-certified creative district by the state arts commission.

Requires the state arts commission to create a process for review of applications submitted by local governments for certification of state-certified creative districts.

HB 2584 by Representatives Vick, Van De Wege, Blake, Harris, and Tarleton

Concerning public disclosure of information submitted to the liquor and cannabis board regarding marijuana product traceability and operations.

Exempts the following from disclosure under the public records act: (1) Financial, commercial operations, and security-related information supplied to the state liquor and cannabis board when filed by or on behalf of a licensee or prospective licensee for the purpose of obtaining, maintaining, or renewing a license to produce, process, transport, or sell marijuana; and

(2) Information submitted by an individual or business to the state liquor and cannabis board for the purpose of marijuana product traceability.

HB 2585 by Representatives Robinson, Walsh, and McBride; by request of Washington State Housing Finance Commission

Concerning private activity bond allocation.

Changes certain timelines with regard to private activity bond allocations.

HB 2586 by Representatives Reykdal, Magendanz, Haler, Hargrove, Rossetti, Van De Wege, Muri, S. Hunt, and Springer

Allowing school siting outside of urban growth areas.

Requires a county that is required or chooses to plan under the growth management act, to allow school districts to site common schools on lands located outside of urban growth areas when certain criteria are met.

Requires the joint legislative audit and review committee to review the impacts of schools that are sited outside of urban growth areas under the authority provided by this act.

Expires July 1, 2026.

HB 2587 by Representatives Rodne, Goodman, and Orwall

Concerning the superior court judges' association.

Revises two statutes to remove inconsistent uses of the superior court judges' association's name.

HB 2588 by Representatives Reykdal, Muri, Kirby, Blake, Condotta, Goodman, Orcutt, Ryu, Rossetti, Stanford, Ormsby, and Gregerson

Concerning vapor products in respect to provisions concerning certain child-resistant packaging, definitions related to "vapor product," signage requirements prohibiting vapor product sales to minors, prohibition of the purchase and possession of vapor products by minors, the liquor and cannabis board's enforcement authority over vapor products, preemption of certain local regulation of vapor products, and a requirement for vendor-assisted sales of vapor products in retail establishments.

Regulates vapor products.

HB 2589 by Representatives G. Hunt, Short, Van Werven, Rodne, McCabe, Taylor, Holy, Manweller, Shea, Walsh, Scott, Muri, Smith, Schmick, Harmsworth, McCaslin, Kochmar, Condotta, MacEwen, Buys, Griffey, Wilson, Pike, Young, Klippert, Hawkins, Haler, Kretz, Wilcox, Zeiger, Dent, Hargrove, Hickel, Stambaugh, Caldier, Hayes, and Parker

Allowing the use of gender-segregated facilities.

Provides that nothing in the state civil rights act: (1) Prohibits a public or private entity from limiting access to a private facility segregated by gender to a person if the person is preoperative, nonoperative, or otherwise has genitalia of a different gender from that for which the facility is segregated; and

(2) Prevents a minor child or a person with a disability from entering a facility segregated by gender when the child or person is a different gender from the gender for which the facility is segregated if certain conditions are met.

Concerning county road administration and maintenance.
Provides taxpayers with lower road maintenance costs
and greater road efficiencies by updating outdated local
road statutes.

HB 2591 by Representatives Hargrove, Kagi, Walsh, Dent, Caldier, Senn, Frame, Muri, Zeiger, McBride, Ormsby, and Gregerson

Notifying foster parents of dependency hearings and their opportunity to be heard in those hearings.

Addresses timely and adequate notice by the department of social and health services or supervising agency to a child's foster parents, preadoptive parents, or other caregivers of their right to be heard before each proceeding held with respect to a child in juvenile court.

Requires the administrative office of the courts to also submit, to a representative of the foster parent association of the state, an annual report providing information about cases that fail to meet statutory guidelines to achieve permanency for dependent children.

HB 2592 by Representatives Holy, Van De Wege, Hayes, Fitzgibbon, Bergquist, Wilcox, Moeller, Kilduff, Stokesbary, Ryu, Muri, McBride, and Tharinger; by request of Law Enforcement Officers and Fire Fighters' Plan 2 Retirement Board

Providing benefits for certain retirement system members who die or become disabled in the course of providing emergency management services.

Provides benefits for certain retirement system members who die or become disabled in the course of providing emergency management services.

#### -- 2016 REGULAR SESSION --

Jan 15 First reading, referred to Appropriations (Not Officially read and referred until adoption of Introduction report).

HB 2593 by Representatives Kilduff, Zeiger, Moscoso, Bergquist, Rossetti, McBride, Stanford, S. Hunt, Gregerson, Santos, Goodman, Pollet, and Hickel

Making community and technical colleges more affordable by eliminating the application fee for low-income students and reviewing placement testing fees.

Requires the state board for community and technical colleges to coordinate with the community and technical colleges to implement a uniform statewide program to waive the application fee for certain individuals applying for admission to a community or technical college.

Jan 15 First reading, referred to Higher Education (Not Officially read and referred until adoption of Introduction report).

#### HB 2594 by Representatives MacEwen and Muri

Simplifying the taxation of amenities owned by homeowners' associations.

Provides a sales and use tax exemption to any portion of the charges paid by a member of a homeowners' association for access or admission to any amenity, common area, facility, or other entity operated by the association.

HB 2595 by Representatives Ortiz-Self, Ryu, Peterson, Robinson, McBride, Reykdal, Walkinshaw, Farrell, Kagi, Rossetti, and S. Hunt

Concerning safe technology use and digital citizenship in public schools.

Requires the state school directors' association to: (1) Revise and distribute its model policy and procedure on electronic resources and internet safety to all school districts in the state; and

(2) In revising its model policy and procedure and with the assistance of the office of the superintendent of public instruction, convene and consult with an advisory committee.

Requires each school district to provide education that includes awareness of safe technology use, digital citizenship, and digital and media literacy.

HB 2596 by Representatives Dye, Blake, Kretz, Tharinger, Short, Schmick, McCabe, Haler, Rossetti, Muri, Condotta, and Springer

Reducing the occurrences of small wildland fires escalating into catastrophic fires through the creation of a mechanism to better equip local wildland fire suppression entities in their immediate, local suppression activities.

Creates the local wildland fire response account.

Authorizes a local suppression entity to, upon confirmation of the start of a wildland fire within its jurisdiction or area of response, submit a request to the department of natural resources for an expenditure from the local wildland fire response account to fund an immediate local suppression effort.
