2 investigations conducted under this section shall be borne by the city
3 or town, unless the city's or town's budget limits its ability to
4 reasonably absorb such costs. If the city or town cannot reasonably
5 absorb the costs of such investigations, the city or town may in its
6 discretion require that the employee, prospective employee, volunteer,
7 vendor, or independent contractor pay the costs associated with the
8 record check. Any fingerprinting costs may be borne by the applicant,
9 although an agency may agree to absorb those costs or reimburse the
10 applicant for those costs upon hire."

12 On page 3, line 36, after "arranged." insert "The cost of
13 investigations conducted under this section shall be borne by the code
14 city, unless the code city's budget limits its ability to reasonably
15 absorb such costs. If the code city cannot reasonably absorb the costs
16 of such investigations, the code city may in its discretion require
17 that the employee, prospective employee, volunteer, vendor, or
18 independent contractor pay the costs associated with the record check.
19 Any fingerprinting costs may be borne by the applicant, although an
20 agency may agree to absorb those costs or reimburse the applicant for
21 those costs upon hire."

23 On page 5, line 4, after "arranged." insert "The cost of
24 investigations conducted under this section shall be borne by the
25 county, unless the county's budget limits its ability to reasonably
26 absorb such costs. If the county cannot reasonably absorb the costs of
27 such investigations, the county may in its discretion require that the

1 employee, prospective employee, volunteer, vendor, or independent
2 contractor pay the costs associated with the record check. Any
3 fingerprinting costs may be borne by the applicant, although an agency
4 may agree to absorb those costs or reimburse the applicant for those
5 costs upon hire."

7 On page 7, line 32, after "arranged. The" insert "costs of
8 investigations conducted under this subsection shall be borne by the
9 park district, unless the park district's budget limits its ability to
10 reasonably absorb such costs. If the park district cannot reasonably
11 absorb the costs of such investigations, the"

13 On page 7, line 34, after "check." insert "Any fingerprinting
14 costs may be borne by the applicant, although an agency may agree to
15 absorb those costs or reimburse the applicant for those costs upon
16 hire."

EFFECT: Requires cities and towns, code cities, counties, and metropolitan park districts to pay the costs of investigations, unless its budget limits its ability to absorb the costs, in which case it may require the subject of the investigations to pay the costs. Fingerprinting costs may be borne by the applicant, but the city or town, code city, county, or park district may agree to absorb those costs or reimburse the applicant upon hire.
