1 On page 2, after line 23, insert the following:

2 "(d) If the employer is required under a collective bargaining  
3 agreement to deduct fees from an employee's pay other than dues  
4 required for membership or a fee equivalent to dues, the employer may  
5 offset the administrative cost of processing and transmitting payments  
6 to the exclusive bargaining representative. The deducted fee, offset  
7 by the administrative cost, shall be transmitted to the treasurer of  
8 exclusive bargaining unit."

10 On page 3, after line 19, insert the following:

11 "(c) If the employer is required under a collective bargaining  
12 agreement to deduct fees from an employee's pay other than dues  
13 required for membership or a fee equivalent to dues, the employer may  
14 offset the administrative cost of processing and transmitting payments  
15 to the exclusive bargaining representative. The deducted fee, offset  
16 by the administrative cost, shall be transmitted to the treasurer of  
17 exclusive bargaining unit."

18

19 On page 4, after line 21, insert the following:

20 "(d) If the employer is required under a collective bargaining  
21 agreement to deduct fees from an employee's pay other than dues  
22 required for membership or a fee equivalent to dues, the employer may  
23 offset the administrative cost of processing and transmitting payments  
24 to the exclusive bargaining representative. The deducted fee, offset  
25 by the administrative cost, shall be transmitted to the treasurer of  
26 exclusive bargaining unit."

1 On page 5, after line 22, insert the following:

2 "(d) If the employer is required under a collective bargaining  
3 agreement to deduct fees from an employee's pay other than dues  
4 required for membership or a fee equivalent to dues, the employer may  
5 offset the administrative cost of processing and transmitting payments  
6 to the exclusive bargaining representative. The deducted fee, offset  
7 by the administrative cost, shall be transmitted to the treasurer of  
8 exclusive bargaining unit."

9

10 On page 7, after line 17, insert the following:

11 "(c) If the employer is required under a collective bargaining  
12 agreement to deduct fees from an employee's pay other than dues  
13 required for membership or a fee equivalent to dues, the employer may  
14 offset the administrative cost of processing and transmitting payments  
15 to the exclusive bargaining representative. The deducted fee, offset  
16 by the administrative cost, shall be transmitted to the treasurer of  
17 exclusive bargaining unit."

18

19 On page 8, after line 3, insert the following:

20 "(c) If the employer is required under a collective bargaining  
21 agreement to deduct fees from an employee's pay other than dues  
22 required for membership or a fee equivalent to dues, the employer may  
23 offset the administrative cost of processing and transmitting payments  
24 to the exclusive bargaining representative. The deducted fee, offset  
25 by the administrative cost, shall be transmitted to the treasurer of  
26 exclusive bargaining unit."

**EFFECT:** Allows the employer to offset the administrative cost of processing and transmitting payments to the exclusive bargaining representative when the employer is required to deducted fees (other than union dues or equivalent fees) under a collective bargaining agreement.
