On page 5, line 11, after "must include the" strike "information on the "Top Five Contributors"" and insert "~~(information on the "Top Five Contributors")~~ web address link to the committee's filing reports on the commission's website,"

On page 5, line 15, after "the" strike all material through "more" on line 16, and insert "~~("Top Five Contributors" information required by this section once their cumulative value reaches one thousand dollars or more)~~ web address link to the committee's filing reports on the commission's website, as required by this section"

On page 5, beginning on line 18, after "address, and" strike "'Top Five Contributor'" and insert "~~("Top Five Contributor")~~ web address link"

EFFECT: Removes new requirements on listing the top contributors.

Changes the requirement from listing the top five contributors to listing the web address link to the committee's reports on the PDC's web site.
