- 1 Strike everything after the enacting clause and insert the 2 following:
- 3 "NEW SECTION. Sec. 1. (1) Subject to the availability of 4 amounts appropriated for this specific purpose, the Washington state 5 economic growth commission is established to:
- 6 (a) Develop a state economic growth strategy related to 7 accelerating technology innovation to increase the number of high-8 paying jobs in the state's economy; and
- 9 (b) Establish the feasibility and devise a plan for establishing 10 a manufacturing innovation institute.
 - The Washington state economic growth commission shall consist of sixteen voting members appointed by the governor follows: One representative from the department of commerce, four representatives from academia, three representatives from private industry or trade associations, three representatives from a labor organization, one senior economist with expertise in manufacturing and technology, one representative from Impact Washington, representatives from the workforce training and education coordinating board, and one representative from the state board for community and technical colleges.
 - (b) The chair of the commission is a voting member selected by the governor, and serves at the pleasure of the governor.
- 23 (3) The commission may adopt rules for its own governance and 24 hire staff as needed to perform functions under this chapter.
- 25 (4) The commission may establish committees as it desires, and 26 may invite people who are not members of the commission to serve as 27 committee members.
- 28 (5) The commission may meet as often as it deems appropriate, but 29 not more than six times per year.
- 30 (6) Administrative support for the commission must be provided by 31 the department of commerce.

- (2) Allows the Department to contract with a statewide nonprofit organization for the purposes of the act, instead of solely the state's manufacturing extension partnership.

 (3) Repeals the Joint Legislative Oversight Committee on Trade
- Policy.
 - (4) Includes a new effective date for the act of July 1, 2018.
