1 On page 3, beginning on line 14, after "36.28A.060" strike all  
2 material through "act" on line 15

3 Beginning on page 6, line 34, strike all of sections 5, 6, 7, and  
4 8 and insert the following:

5 "NEW SECTION. **Sec. 5.** A new section is added to chapter 28A.320  
6 RCW to read as follows:

7 (1) School districts are encouraged to implement an incident  
8 alert and reporting system to allow students to report anonymously to  
9 school officials unsafe, potentially harmful, dangerous, violent, or  
10 criminal activities, or the threat of these activities. This system  
11 may be available as a mobile application and allow for reports via  
12 phone, text, email, and web site.

13 (2) Any incident alert and reporting system must protect the  
14 privacy of student data, consistent with federal and state law.

15 (3) School districts are encouraged to use the age-appropriate  
16 educational materials developed under section 6 of this act to teach  
17 students how to access an incident alert and reporting system.

18 (4) School districts shall make reasonable efforts to disseminate  
19 information about any incident alert and reporting system to students  
20 and families.

21 (5) School districts and its officers, agents, and employees are  
22 immune from civil liability for damages resulting from the creation  
23 and use of the incident alert and reporting system, unless it is  
24 shown that the school district and its officers, agents, and  
25 employees acted with gross negligence or in bad faith.

26 NEW SECTION. **Sec. 6.** A new section is added to chapter 28A.300  
27 RCW to read as follows:

28 The office of the superintendent of public instruction must  
29 develop age-appropriate educational materials designed to teach  
30 students how to access an incident alert and reporting system and  
31 report anonymously to school officials unsafe, potentially harmful,

1 dangerous, violent, or criminal activities, or the threat of these  
2 activities."

3 Renumber the remaining sections consecutively and correct any  
4 internal references accordingly.

5 On page 28, beginning on line 11, strike all of section 24

6 On page 1, beginning on line 3 of the title, after  
7 "notifications;" strike "creating a program to provide students and  
8 the community with the means to report unsafe or violent activities;"

9 On page 1, line 7 of the title, after "summit;" strike all  
10 material through "pistols;" on line 9

11 On page 1, line 10 of the title, after "rifles;" strike "and" and  
12 after "funds;" insert "encouraging school districts to implement an  
13 incident alert and reporting system to allow students to report  
14 anonymously to school officials unsafe activities; and enhancing the  
15 background check process for the purchase of semiautomatic rifles;"

16 On page 1, at the beginning of line 14 of the title, strike  
17 "adding a new section to chapter 28A.630 RCW;"

18 On page 1, at the beginning of line 16 of the title, strike  
19 "adding a new section to chapter 28A.150 RCW;"

20 On page 1, line 18 of the title, after "28A.310.505;" insert  
21 "and" and after "penalties" strike "; providing an expiration date;  
22 and declaring an emergency"

EFFECT: (1) Removes Part II of the bill establishing a statewide students protecting students program.

(2) Encourages school districts to implement an incident alert and reporting system to allow students to report anonymously and to teach students how to report unsafe activities to school officials using age-appropriate educational materials developed by the Office of the Superintendent of Public Instruction.

(3) Requires school districts to make reasonable efforts to disseminate information about any incident alert and reporting system to students and families.
