**Title:** An act relating to the transitional bilingual instruction program reporting date.

**Brief Summary of Bill**

- Changes the date by which the Superintendent of Public Instruction must submit an annual report to the Legislature on the Transitional Bilingual Instruction Program from January 1 to February 1.

**Background:**

The Transitional Bilingual Instruction Program (TBIP) is part of the state's program of basic education. The TBIP requires all school districts to provide a system of instruction in two languages, one of which is English, as a means of building upon and expanding language skills to enable qualifying students to achieve competency in English. All school districts also must make available a program of instructional support for students who have exited the

TBIP and achieved English proficiency for purposes of the TBIP, but who need assistance in reaching grade-level performance in academic subjects.

According to the Office of the Superintendent of Public Instruction, in the 2014-15 school year, 119,844 students in Washington were English language learners, with nearly all of these students (118,526) enrolled in the TBIP.

The Superintendent of Public Instruction (SPI) is required to annually review the TBIP and to submit a report of that review to the Legislature on or before each January 1.

**Summary of Bill:**

The date by which the SPI must submit an annual report to the Legislature on the TBIP is changed from on or before each January 1 to on or before each February 1.

---

**Effective Date:** The bill takes effect 90 days after adjournment of the session in which the bill is passed.
