## HOUSE BILL 2126

State of Washington 65th Legislature 2017 Regular Session

By Representatives Blake and Wilcox

Read first time 02/17/17. Referred to Committee on Appropriations.

- AN ACT Relating to creating a community-based approach to provide assistance with nonlethal management methods to reduce livestock depredations by wolves; reenacting and amending RCW 43.79A.040; and adding a new chapter to Title 16 RCW.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 NEW SECTION. Sec. 1. The legislature finds that there is a need 7 to provide resources to help livestock producers adapt their operations in light of the recovery of wolves on the landscape and a 8 desire by many to increase use of nonlethal deterrence measures to 9 10 reduce the probability of livestock depredations by wolves. 11 application of resources in support of these goals must respect livestock producers' values of independence, privacy, and local 12 decision making. The legislature further recognizes that livestock 13 14 producers have unique and valuable knowledge, occupy an important 15 place in their local communities and the state's social fabric, and 16 are critical partners in creating sound natural resource policies.
- NEW SECTION. Sec. 2. The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
- 20 (1) "Department" means the department of agriculture.

- 1 (2) "Director" means the director of the department of 2 agriculture.
  - NEW SECTION. Sec. 3. (1) The northeast Washington wolf-cattle management grant is created within the department. Funds from the grant program must be used only for the deployment of nonlethal deterrence resources, including equipment and tools, owned and strategically located locally.
- (2)(a) An advisory board is established to advise the department 8 9 on the expenditure of the northeast Washington wolf-cattle management 10 grant funds. Advisory board members must be knowledgeable about wolf 11 depredation issues, and have a special interest in the use of nonlethal wolf management techniques. Board members are unpaid, are 12 13 not state employees, and are not eligible for reimbursement for subsistence, lodging, or travel expenses incurred in the performance 14 15 of their duties as board members. The director must appoint each member to the board for a term of two years. Board members may be 16 17 reappointed for subsequent two-year terms. The following board members must be appointed by the director in consultation with each 18 applicable conservation district and the legislators in the 19 20 legislative district encompassing each county:
  - (i) One Ferry county conservation district board member;
- 22 (ii) One Stevens county conservation district board member; and
  - (iii) One Pend Oreille conservation district board member.
- (b) If no board member qualifies under this section, the director must appoint a resident of the applicable county to serve on the board.
  - (c) Board members may not:

- (i) Directly benefit, in whole or in part, from any contract made by, through, or under the supervision of the northwest Washington wolf-cattle management, or which may be made for the benefit of his or her office; or
- 32 (ii) Directly accept any compensation, gratuity, or reward in 33 connection with such a contract from any other person with a 34 beneficial interest in the contract.
- 35 (3) The board must help direct the deployment of nonlethal 36 deterrence resources, including equipment and tools, owned and 37 strategically located by the collaborative.

NEW SECTION. Sec. 4. (1) The northeast Washington wolf-cattle management account is created as a nonappropriated account in the custody of the state treasurer. All receipts from the northeast Washington wolf-cattle management grant must be deposited into the account. Expenditures from the account may be used only for the deployment of nonlethal wolf deterrence resources as described in section 3 of this act. Only the director may authorize expenditures from the account in consultation with the advisory board created in section 3 of this act. The account is subject to allotment procedures under chapter 43.88 RCW, but an appropriation is not required for expenditures. Interest earned by deposits in the account must be retained in the account.

- (2) The board of directors created in section 3 of this act may solicit and receive gifts and grants from public and private sources for the purposes of section 3 of this act.
- Sec. 5. RCW 43.79A.040 and 2016 c 203 s 2, 2016 c 173 s 10, 2016 c 69 s 21, and 2016 c 39 s 7 are each reenacted and amended to read as follows:
  - (1) Money in the treasurer's trust fund may be deposited, invested, and reinvested by the state treasurer in accordance with RCW 43.84.080 in the same manner and to the same extent as if the money were in the state treasury, and may be commingled with moneys in the state treasury for cash management and cash balance purposes.
  - (2) All income received from investment of the treasurer's trust fund must be set aside in an account in the treasury trust fund to be known as the investment income account.
  - (3) The investment income account may be utilized for the payment of purchased banking services on behalf of treasurer's trust funds including, but not limited to, depository, safekeeping, and disbursement functions for the state treasurer or affected state agencies. The investment income account is subject in all respects to chapter 43.88 RCW, but no appropriation is required for payments to financial institutions. Payments must occur prior to distribution of earnings set forth in subsection (4) of this section.
  - (4)(a) Monthly, the state treasurer must distribute the earnings credited to the investment income account to the state general fund except under (b), (c), and (d) of this subsection.
  - (b) The following accounts and funds must receive their proportionate share of earnings based upon each account's or fund's

(c) The following accounts and funds must receive eighty percent of their proportionate share of earnings based upon each account's or fund's average daily balance for the period: The advanced right-of-way revolving fund, the advanced environmental mitigation revolving account, the federal narcotics asset forfeitures account, the high occupancy vehicle account, the local rail service assistance account, and the miscellaneous transportation programs account.

- (d) Any state agency that has independent authority over accounts or funds not statutorily required to be held in the custody of the state treasurer that deposits funds into a fund or account in the custody of the state treasurer pursuant to an agreement with the office of the state treasurer shall receive its proportionate share of earnings based upon each account's or fund's average daily balance for the period.
- 15 (5) In conformance with Article II, section 37 of the state 16 Constitution, no trust accounts or funds shall be allocated earnings 17 without the specific affirmative directive of this section.
- NEW SECTION. Sec. 6. Sections 1 through 4 of this act constitute a new chapter in Title 16 RCW.
