1 AN ACT Relating to modernizing fuel content standards and
2 references; amending RCW 19.112.010, 19.112.020, 19.112.030,
3 19.112.050, 19.112.060, 19.112.110, 19.112.130, 19.112.900,
4 42.56.270, 43.19.642, 43.19.646, 43.19.647, 82.08.865, 82.08.956, and
5 82.12.956; reenacting and amending RCW 80.50.020; adding a new
6 section to chapter 43.325 RCW; repealing RCW 19.112.040, 19.112.090,
7 19.112.120, 19.112.140, 19.112.150, 19.112.160, 19.112.170,
8 19.112.180, and 43.19.643; and prescribing penalties.

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

10 **Sec. 1.** RCW 19.112.010 and 2009 c 132 s 1 are each amended to
11 read as follows:

6 ~~(3) "Biodiesel fuel" means the monoalkyl esters of long chain~~
7 ~~fatty acids derived from plant or animal matter that meet the~~
8 ~~registration requirements for fuels and fuel additives established by~~
9 ~~the federal environmental protection agency and standards established~~
10 ~~by the American society of testing and materials.~~

11 ~~(4) "Diesel" means special fuel as defined in RCW 82.38.020, and~~
12 ~~diesel fuel dyed in accordance with the regulations in 26 C.F.R. Sec.~~
13 ~~48.4082-1T as of October 24, 2005.~~

14 ~~(5)) "Director" means the director of agriculture.~~

15 ~~((6) "E85 motor fuel" means an alternative fuel that is a blend~~
16 ~~of ethanol and hydrocarbon of which the ethanol portion is nominally~~
17 ~~seventy five to eighty five percent denatured fuel ethanol by volume~~
18 ~~that complies with the most recent version of American society of~~
19 ~~testing and materials specification D 5798.~~

20 ~~(7)) (2) "Motor fuel" ((means)) includes: (a) Any liquid product~~
21 ~~used for the generation of power in an internal combustion engine~~
22 ~~used for the propulsion of a motor vehicle upon the highways of this~~

24 ~~regulations that is used to power a motor vehicle; and (c) any~~

32 ~~(9) "Renewable diesel" means a diesel fuel substitute produced~~
33 ~~from nonpetroleum renewable sources, including vegetable oils and~~
34 ~~animal fats, that meets the registration requirements for fuels and~~
35 ~~fuel additives established by the federal environmental protection~~
36 ~~agency in 40 C.F.R. Part 79 (2008) and meets the requirements of~~
37 ~~American society of testing and materials specification D 975.)~~

38 **Sec. 2.** RCW 19.112.020 and 2010 c 96 s 1 are each amended to
39 read as follows:

1 (1) This chapter shall be administered by the director or ((his
2 or her)) the director's authorized agent. ((For the purpose of
3 administering this chapter, for motor fuel except biodiesel fuel,))

4 (2)(a) The director shall adopt rules for maintaining standards
5 for motor fuel. The rules may include:

6 (i) All or part of the standards set forth in the Annual Book of
7 ASTM Standards and ((supplements thereto,)) amendments and revisions
8 thereof((, are adopted, together with));

9 (ii) All or part of the standards set forth in the national
10 institute of standards and technology (NIST) handbook 130, uniform

32 (3) "Director" means the director of the department of commerce.

35 The definitions in this section apply throughout this chapter
36 unless the context clearly requires otherwise.

1 (1) "Alternative energy resource" includes energy facilities of
2 the following types: (a) Wind; (b) solar energy; (c) geothermal
3 energy; (d) landfill gas; (e) wave or tidal action; or (f) biomass
4 energy based on solid organic fuels from wood, forest, or field
5 residues, or dedicated energy crops that do not include wood pieces
6 that have been treated with chemical preservatives such as creosote,
7 pentachlorophenol, or copper-chrome-arsenic.

8 (2) "Applicant" means any person who makes application for a site
9 certification pursuant to the provisions of this chapter.

10 (3) "Application" means any request for approval of a particular
11 site or sites filed in accordance with the procedures established
12 pursuant to this chapter, unless the context otherwise requires.

13 (4) "Associated facilities" means storage, transmission,
14 handling, or other related and supporting facilities connecting an
15 energy plant with the existing energy supply, processing, or
16 distribution system, including, but not limited to, communications,
17 controls, mobilizing or maintenance equipment, instrumentation, and
18 other types of ancillary transmission equipment, off-line storage or
19 venting required for efficient operation or safety of the
20 transmission system and overhead, and surface or subsurface lines of
21 physical access for the inspection, maintenance, and safe operations
22 of the transmission facility and new transmission lines constructed
23 to operate at nominal voltages of at least 115,000 volts to connect a
24 thermal power plant or alternative energy facilities to the northwest
25 power grid. However, common carrier railroads or motor vehicles shall
26 not be included.

27 (5) "Biofuel" has the same meaning as defined in ((RCW
28 ~~43.325.010~~)) section 13 of this act.

29 (6) "Certification" means a binding agreement between an
30 applicant and the state which shall embody compliance to the siting
31 guidelines, in effect as of the date of certification, which have
32 been adopted pursuant to RCW 80.50.040 as now or hereafter amended as
33 conditions to be met prior to or concurrent with the construction or
34 operation of any energy facility.

35 (7) "Construction" means on-site improvements, excluding
36 exploratory work, which cost in excess of two hundred fifty thousand
37 dollars.

38 (8) "Council" means the energy facility site evaluation council
39 created by RCW 80.50.030.

1 (9) "Counsel for the environment" means an assistant attorney
2 general or a special assistant attorney general who shall represent
3 the public in accordance with RCW 80.50.080.

4 (10) "Electrical transmission facilities" means electrical power
5 lines and related equipment.

6 (11) "Energy facility" means an energy plant or transmission
7 facilities: PROVIDED, That the following are excluded from the
8 provisions of this chapter:

9 (a) Facilities for the extraction, conversion, transmission or
10 storage of water, other than water specifically consumed or
11 discharged by energy production or conversion for energy purposes;
12 and

13 (b) Facilities operated by and for the armed services for
14 military purposes or by other federal authority for the national
15 defense.

16 (12) "Energy plant" means the following facilities together with
17 their associated facilities:

18 (a) Any nuclear power facility where the primary purpose is to
19 produce and sell electricity;

20 (b) Any nonnuclear stationary thermal power plant with generating
21 capacity of three hundred fifty thousand kilowatts or more, measured
22 using maximum continuous electric generating capacity, less minimum
23 auxiliary load, at average ambient temperature and pressure, and
24 floating thermal power plants of one hundred thousand kilowatts or
25 more suspended on the surface of water by means of a barge, vessel,
26 or other floating platform;

27 (c) Facilities which will have the capacity to receive liquefied
28 natural gas in the equivalent of more than one hundred million
29 standard cubic feet of natural gas per day, which has been
30 transported over marine waters;

31 (d) Facilities which will have the capacity to receive more than
32 an average of fifty thousand barrels per day of crude or refined
33 petroleum or liquefied petroleum gas which has been or will be
34 transported over marine waters, except that the provisions of this
35 chapter shall not apply to storage facilities unless occasioned by
36 such new facility construction;

37 (e) Any underground reservoir for receipt and storage of natural
38 gas as defined in RCW 80.40.010 capable of delivering an average of
39 more than one hundred million standard cubic feet of natural gas per
40 day; and

1 (f) Facilities capable of processing more than twenty-five
2 thousand barrels per day of petroleum or biofuel into refined
3 products except where such biofuel production is undertaken at
4 existing industrial facilities.

5 (13) "Independent consultants" means those persons who have no
6 financial interest in the applicant's proposals and who are retained
7 by the council to evaluate the applicant's proposals, supporting
8 studies, or to conduct additional studies.

9 (14) "Land use plan" means a comprehensive plan or land use
10 element thereof adopted by a unit of local government pursuant to
11 chapter 35.63, 35A.63, 36.70, or 36.70A RCW, or as otherwise
12 designated by chapter 325, Laws of 2007.

13 (15) "Person" means an individual, partnership, joint venture,
14 private or public corporation, association, firm, public service
15 company, political subdivision, municipal corporation, government
16 agency, public utility district, or any other entity, public or
17 private, however organized.

18 (16) "Preapplicant" means a person considering applying for a
19 site certificate agreement for any transmission facility.

20 (17) "Preapplication process" means the process which is
21 initiated by written correspondence from the preapplicant to the
22 council, and includes the process adopted by the council for
23 consulting with the preapplicant and with cities, towns, and counties
24 prior to accepting applications for all transmission facilities.

25 (18) "Secretary" means the secretary of the United States
26 department of energy.

27 (19) "Site" means any proposed or approved location of an energy
28 facility, alternative energy resource, or electrical transmission
29 facility.

30 (20) "Thermal power plant" means, for the purpose of
31 certification, any electrical generating facility using any fuel for
32 distribution of electricity by electric utilities.

33 (21) "Transmission facility" means any of the following together
34 with their associated facilities:

35 (a) Crude or refined petroleum or liquid petroleum product
36 transmission pipeline of the following dimensions: A pipeline larger
37 than six inches minimum inside diameter between valves for the
38 transmission of these products with a total length of at least
39 fifteen miles;

1 (b) Natural gas, synthetic fuel gas, or liquefied petroleum gas
2 transmission pipeline of the following dimensions: A pipeline larger
3 than fourteen inches minimum inside diameter between valves, for the
4 transmission of these products, with a total length of at least
5 fifteen miles for the purpose of delivering gas to a distribution
6 facility, except an interstate natural gas pipeline regulated by the
7 United States federal power commission.

8 (22) "Zoning ordinance" means an ordinance of a unit of local
9 government regulating the use of land and adopted pursuant to chapter
10 35.63, 35A.63, 36.70, or 36.70A RCW or Article XI of the state
11 Constitution, or as otherwise designated by chapter 325, Laws of
12 2007.

13 **Sec. 15.** RCW 82.08.865 and 2010 c 106 s 218 are each amended to
14 read as follows:

15 (1) The tax levied by RCW 82.08.020 does not apply to sales of
16 diesel fuel, biodiesel fuel, or aircraft fuel, to a farm fuel user
17 for agricultural purposes. This exemption applies to a fuel blend if
18 all of the component fuels of the blend would otherwise be exempt
19 under this subsection if the component fuels were sold as separate
20 products. This exemption is available only if the buyer provides the
21 seller with an exemption certificate in a form and manner prescribed
22 by the department.

23 (2) The definitions in RCW 82.04.213 and this subsection apply to
24 this section.

25 (a)(i) "Agricultural purposes" means the performance of
26 activities directly related to the growing, raising, or producing of
27 agricultural products.

28 (ii) "Agricultural purposes" does not include: (A) Heating space
29 for human habitation or water for human consumption; or (B)
30 transporting on public roads individuals, agricultural products, farm
31 machinery or equipment, or other tangible personal property, except
32 when the transportation is incidental to transportation on private
33 property and the fuel used for such transportation is not subject to
34 tax under chapter 82.38 RCW.

35 (b) "Aircraft fuel" is defined as provided in RCW 82.42.010.

36 (c) "Biodiesel fuel" (~~is defined as provided in RCW 19.112.010~~)
37 means biodiesel fuel as defined by the Washington state department of
38 agriculture as of January 1, 2018.

1 (d) "Diesel fuel" is defined as provided in 26 U.S.C. 4083, as
2 amended or renumbered as of January 1, 2006.

3 (e) "Farm fuel user" means: (i) A farmer; or (ii) a person who
4 provides horticultural services for farmers, such as soil preparation
5 services, crop cultivation services, and crop harvesting services.

6 **Sec. 16.** RCW 82.08.956 and 2013 2nd sp.s. c 13 s 1002 are each
7 amended to read as follows:

8 (1) The tax levied by RCW 82.08.020 does not apply to sales of
9 hog fuel used to produce electricity, steam, heat, or biofuel in

11 provides the seller with an exemption certificate in a form and
12 manner prescribed by the department. The seller must retain a copy of
13 the certificate for the seller's files.

25 exemption claimed under this section for the previous two calendar
26 years to be immediately due.

27 (4) This section expires June 30, 2024.

28 **Sec. 17.** RCW 82.12.956 and 2013 2nd sp.s. c 13 s 1003 are each

30 (1) The provisions of this chapter do not apply with respect to
31 the use of hog fuel for production of electricity, steam, heat, or
32 biofuel in Washington state.

36 (b) "Biofuel" has the same meaning as provided in RCW
