2 1 (uncodified); adding a new section to chapter 46.70 RCW; repealing

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** 2017 c 15 s 1 (uncodified) is amended to read as
7 follows:

8 (1)(a) Effective July 1, 2017, the department of licensing may
9 not issue any new wholesale vehicle dealer licenses.

10 ((+2)) (b) Effective July 1, 2018, the department of licensing
11 may not renew any wholesale vehicle dealer licenses((-
12 ~~(3) This section expires October 31, 2019~~)), except as provided
13 in subsection (2) of this section.

14 (2) The department of licensing shall renew a wholesale vehicle
15 dealer license of a wholesale vehicle dealer who has held the license
16 continuously for at least the previous six years from the effective
17 date of this section and who otherwise meets the requirements of this
18 chapter.

19 NEW SECTION. **Sec. 2.** The following acts or parts of acts are
20 each repealed:

- 1 (1) 2017 c 15 s 2;
- 2 (2) 2017 c 15 s 3;
- 3 (3) 2017 c 15 s 4;
- 4 (4) 2017 c 15 s 5;
- 5 (5) 2017 c 15 s 6; and
- 6 (6) 2017 c 15 s 8 (uncodified).

7 NEW SECTION. **Sec. 3.** Section 1 of this act is added to chapter
8 46.70 RCW.

9 NEW SECTION. **Sec. 4.** This act takes effect July 1, 2018.
