1 AN ACT Relating to the mental health field response teams
2 program; and adding a new section to chapter 36.28A RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 36.28A
5 RCW to read as follows:

6 (1) Subject to the availability of amounts appropriated for this
7 specific purpose, the Washington association of sheriffs and police
8 chiefs shall develop and implement a mental health field response
9 grant program. The purpose of the program is to assist local law
10 enforcement agencies to establish and expand mental health field
11 response capabilities, utilizing mental health professionals to
12 professionally, humanely, and safely respond to crises involving
13 persons with behavioral health issues with treatment, diversion, and
14 reduced incarceration time as primary goals. A portion of the grant
15 funds may also be used to develop data management capability to
16 support the program.

17 (2) Grants must be awarded to local law enforcement agencies
18 based on locally developed proposals to incorporate mental health
19 professionals into the agencies' mental health field response
20 planning and response. Two or more agencies may submit a joint grant
21 proposal to develop their mental health field response proposals.

1 Proposals must provide a plan for improving mental health field
2 response and diversion from incarceration through modifying or
3 expanding law enforcement practices in partnership with mental health
4 professionals. A peer review panel appointed by the Washington
5 association of sheriffs and police chiefs in consultation with
6 integrated managed care organizations and behavioral health
7 organizations must review the grant applications. Once the Washington
8 association of sheriffs and police chiefs certifies that the
9 application satisfies the proposal criteria, the grant funds will be
10 distributed. To the extent possible, at least one grant recipient
11 agency should be from the east side of the state and one from the
12 west side of the state with the crest of the Cascades being the
13 dividing line. The Washington association of sheriffs and police
14 chiefs shall make every effort to fund at least eight grants per
15 fiscal year with funding provided for this purpose from all allowable
16 sources under this section. The Washington association of sheriffs
17 and police chiefs may prioritize grant applications that include
18 local matching funds. Grant recipients must be selected and receiving
19 funds no later than October 1, 2018.

20 (3) Grant recipients must include at least one mental health
21 professional who will perform professional services under the plan. A
22 mental health professional may assist patrolling officers in the
23 field or in an on-call capacity, provide preventive, follow-up,
24 training on mental health field response best practices, or other
25 services at the direction of the local law enforcement agency.
26 Nothing in this subsection (3) limits the mental health
27 professional's participation to field patrol. Grant recipients are
28 encouraged to coordinate with local public safety answering points to
29 maximize the goals of the program.

30 (4) Within existing resources, the Washington association of
31 sheriffs and police chiefs shall:

32 (a) Consult with the department of social and health services
33 research and data analysis unit to establish data collection and
34 reporting guidelines for grant recipients. The data will be used to
35 study and evaluate whether the use of mental health field response
36 programs improves outcomes of interactions with persons experiencing
37 behavioral health crises, including reducing rates of violence and
38 harm, reduced arrests, and jail or emergency room usage;

39 (b) Consult with the department of social and health services
40 behavioral health administration and the managed care system to

1 develop requirements for participating mental health professionals;
2 and

3 (c) Coordinate with public safety answering points, behavioral
4 health, and the department of social and health services to develop
5 and incorporate telephone triage criteria or dispatch protocols to
6 assist with mental health, law enforcement, and emergency medical
7 responses involving mental health situations.

8 (5) The Washington association of sheriffs and police chiefs
9 shall submit an annual report to the governor and appropriate
10 committees of the legislature on the program. The report must include
11 information on grant recipients, use of funds, participation of
12 mental health professionals, and feedback from the grant recipients
13 by December 1st of each year the program is funded.

14 (6) Grant recipients shall develop and provide or arrange for
15 training necessary for mental health professionals to operate
16 successfully and competently in partnership with law enforcement
17 agencies. The training must provide the professionals with a working
18 knowledge of law enforcement procedures and tools sufficient to
19 provide for the safety of the professionals, partnered law
20 enforcement officers, and members of the public.

21 (7) Nothing in this section prohibits the Washington association
22 of sheriffs and police chiefs from soliciting or accepting private
23 funds to support the program created in this section.
