AN ACT Relating to prohibiting certain employers from including any question on an application about an applicant's criminal record, inquiring either orally or in writing about an applicant's criminal records, or obtaining information from a criminal background check, until after the employer initially determines that the applicant is otherwise qualified; adding a new chapter to Title 49 RCW; and prescribing penalties.

- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 9 <u>NEW SECTION.</u> **Sec. 1.** The definitions in this section apply 10 throughout this chapter unless the context clearly requires 11 otherwise.
- 12 (1) "Criminal record" includes any record about a citation or 13 arrest for criminal conduct, including records relating to probable 14 cause to arrest, and includes any record about a criminal or juvenile 15 case filed with any court, whether or not the case resulted in a 16 finding of guilt.
- (2) "Employer" includes public agencies, private individuals, businesses and corporations, contractors, temporary staffing agencies, training and apprenticeship programs, and job placement, referral, and employment agencies.

- 1 (3) "Otherwise qualified" means that the applicant meets the 2 basic criteria for the position as set out in the advertisement or 3 job description without consideration of a criminal record.
- Sec. 2. (1) An employer may not include any 4 NEW SECTION. 5 question on any application for employment, inquire either orally or in writing, receive information through a criminal history background 6 check, or otherwise obtain information about an applicant's criminal 7 record until after the employer initially determines that the 8 applicant is otherwise qualified for the position. Once the employer 9 10 has initially determined that the applicant is otherwise qualified, 11 the employer may inquire into or obtain information about a criminal record and consider an applicant's criminal record in a hiring 12 13 decision.
- 14 (2) An employer may not advertise employment openings in a way 15 that excludes people with criminal records from applying. Ads that 16 state "no felons," "no criminal background," or otherwise convey 17 similar messages are prohibited.
 - (3) An employer may not implement any policy or practice that automatically or categorically excludes individuals with a criminal record from consideration prior to an initial determination that the applicant is otherwise qualified for the position. Prohibited policies and practices include rejecting an applicant for failure to disclose a criminal record prior to initially determining the applicant is otherwise qualified for the position.

- (a) Any employer hiring a person who will or may have unsupervised access to children under the age of eighteen, a vulnerable adult as defined in chapter 74.34 RCW, or a vulnerable person as defined in RCW 9.96A.060;
 - (b) Any employer who is hiring for a position that includes:
 - (i) Services to be performed at or in a residential property;
- 32 (ii) Solicitation at or in a residential property of products or 33 services; or
 - (iii) Residential delivery services;
 - (c) Any employer, including a financial institution, who is expressly permitted or required under any federal or state law to inquire into, consider, or rely on information about an applicant's or employee's criminal record for employment purposes;

- 1 (d) Employment by a general or limited authority Washington law 2 enforcement agency as defined in RCW 10.93.020 or by a criminal 3 justice agency as defined in RCW 10.97.030(5)(b); or
 - (e) To an employer seeking a nonemployee volunteer.

- 5 NEW SECTION. Sec. 3. (1) This chapter may not be interpreted or applied to diminish or conflict with any requirements of state or б federal law, including Title VII of the civil rights act of 1964; the 7 15 U.S.C. federal fair credit reporting act, Sec. 1681; 8 Washington state fair credit reporting act, chapter 19.182 RCW; and 9 10 state laws regarding unsupervised access to children or vulnerable 11 persons, RCW 43.43.830 through 43.43.845.
 - (2) This chapter may not be interpreted or applied as imposing an obligation on the part of an employer to provide accommodations or job modifications in order to facilitate the employment or continued employment of an applicant or employee with a criminal record or who is facing pending criminal charges.
 - (3) This chapter may not be construed to prohibit an employer from declining to hire an applicant with a criminal record or from terminating the employment of an employee with a criminal record.
 - (4) This chapter may not be construed to discourage or prohibit an employer from adopting employment policies that are more protective of employees and job applicants than the requirements of this chapter.
 - (5) This chapter may not be construed to interfere with local government laws that provide additional protections to applicants or employees with criminal records, nor does it prohibit local governments from enacting greater protections for such applicants or employees in the future. Local government laws that provide lesser protections to job applicants with criminal records than this chapter conflict with this chapter and may not be enforced.
- 31 (6) This chapter may not be construed to create a private right 32 of action to seek damages or remedies of any kind. The exclusive 33 remedy available under this chapter is enforcement described in 34 section 4 of this act. This chapter does not create any additional 35 liability for employers beyond that enumerated in this chapter.
- NEW SECTION. Sec. 4. (1) The state attorney general's office 37 shall enforce this chapter. Its powers to enforce this chapter 38 include the authority to:

- 1 (a) Investigate violations of this chapter on its own initiative;
- 2 (b) Investigate violations of this chapter in response to complaints and seek remedial relief for the complainant;

- (c) Educate the public about how to comply with this chapter;
- 5 (d) Issue written civil investigative demands for pertinent 6 documents, answers to written interrogatories, or oral testimony as 7 required to enforce this chapter;
- 8 (e) Adopt rules implementing this chapter including rules 9 specifying applicable penalties; and
- 10 (f) Pursue administrative sanctions or a lawsuit in the courts 11 for penalties, costs, and attorneys' fees.
- 12 (2) In exercising its powers, the attorney general's office shall utilize a stepped enforcement approach, by first educating violators, 13 14 then warning them, then taking legal, including administrative, action. Maximum penalties are as follows: A notice of violation and 15 offer of agency assistance for the first violation; a monetary 16 17 penalty of up to seven hundred fifty dollars for the 18 violation; and a monetary penalty of up to one thousand dollars for each subsequent violation. 19
- NEW SECTION. Sec. 5. If any provision of this act or its application to any person or circumstance is held invalid, the remainder of the act or the application of the provision to other persons or circumstances is not affected.
- 24 NEW SECTION. Sec. 6. If any part of this act is found to be in 25 conflict with federal requirements that are a prescribed condition to 26 the allocation of federal funds to the state, the conflicting part of 27 this act is inoperative solely to the extent of the conflict and with respect to the agencies directly affected, and this finding does not 28 29 affect the operation of the remainder of this act in its application 30 to the agencies concerned. Rules adopted under this act must meet 31 federal requirements that are a necessary condition to the receipt of 32 federal funds by the state.
- NEW SECTION. Sec. 7. Sections 1 through 4, 6, and 8 of this act constitute a new chapter in Title 49 RCW.
