- AN ACT Relating to restricting the use of step therapy by public 1 2 and private insurers for drugs used in mental health treatment; adding a new section to chapter 48.43 RCW; adding a new section to 3 4 chapter 41.05 RCW; and adding a new section to chapter 74.09 RCW.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON: 5
- Sec. 1. A new section is added to chapter 48.43 6 NEW SECTION. 7 RCW to read as follows:
- (1) Beginning July 1, 2018, each carrier offering or renewing a 9 health benefit plan may require step therapy for medications necessary for the treatment of mental illness only as follows:
 - (a) The carrier may require a first attempt treatment using one particular drug covered by the carrier unless the prescribing practitioner demonstrates that the patient has already tried and failed on the carrier's first attempt treatment drug or a drug in the same pharmacologic class, in which case, the carrier must provide immediate coverage for the drug prescribed by the practitioner.
- (b) Following a patient's use of the first attempt drug, the 18 carrier must provide immediate coverage for the drug prescribed by 19 20 the patient's prescribing practitioner if the patient's prescribing 21 practitioner determines that the first attempt drug:
