- NEW SECTION. Sec. 101. SHORT TITLE. This act may be known and cited as the uniform parentage act.
- NEW SECTION. Sec. 102. DEFINITIONS. The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
- 7 (1) "Acknowledged parent" means an individual who has established 8 a parent-child relationship under sections 301 through 314 of this 9 act.
- 10 (2) "Adjudicated parent" means an individual who has been 11 adjudicated to be a parent of a child by a court with jurisdiction.
- 12 (3) "Alleged genetic parent" means an individual who is alleged 13 to be, or alleges that the individual is, a genetic parent or 14 possible genetic parent of a child whose parentage has not been 15 adjudicated. The term includes an alleged genetic father and alleged 16 genetic mother. The term does not include:
- 17 (a) A presumed parent;
- 18 (b) An individual whose parental rights have been terminated or 19 declared not to exist; or
- 20 (c) A donor.

- 21 (4) "Assisted reproduction" means a method of causing pregnancy 22 other than sexual intercourse. The term includes:
 - (a) Intrauterine or intracervical insemination;
- 24 (b) Donation of gametes;
- 25 (c) Donation of embryos;
- 26 (d) In-vitro fertilization and transfer of embryos; and
- 27 (e) Intracytoplasmic sperm injection.
- 28 (5) "Child" means an individual of any age whose parentage may be 29 determined under this chapter.
- 30 (6) "Child-support agency" means a government entity, public official, or private agency, authorized to provide parentage32 establishment services under Title IV-D of the social security act, 33 42 U.S.C. Secs. 651 through 669.
- 34 (7) "Determination of parentage" means establishment of a parent-35 child relationship by a judicial or administrative proceeding or 36 signing of a valid acknowledgment of parentage under sections 301 37 through 314 of this act.

- 1 (8) "Donor" means an individual who provides gametes intended for 2 use in assisted reproduction, whether or not for consideration. The 3 term does not include:
- 4 (a) A woman who gives birth to a child conceived by assisted 5 reproduction, except as otherwise provided in sections 701 through 6 718 of this act; or
- 7 (b) A parent under sections 601 through 608 of this act or an 8 intended parent under sections 701 through 718 of this act.
 - (9) "Gamete" means sperm, egg, or any part of a sperm or egg.
- 10 (10) "Genetic testing" means an analysis of genetic markers to 11 identify or exclude a genetic relationship.
 - (11) "Individual" means a natural person of any age.
- 13 (12) "Intended parent" means an individual, married or unmarried, 14 who manifests an intent to be legally bound as a parent of a child 15 conceived by assisted reproduction.
 - (13) "Man" means a male individual of any age.

- 17 (14) "Parent" means an individual who has established a parent-18 child relationship under section 201 of this act.
- 19 (15) "Parentage" or "parent-child relationship" means the legal 20 relationship between a child and a parent of the child.
 - (16) "Presumed parent" means an individual who under section 204 of this act is presumed to be a parent of a child, unless the presumption is overcome in a judicial proceeding, a valid denial of parentage is made under sections 301 through 314 of this act, or a court adjudicates the individual to be a parent.
- 26 (17) "Record" means information that is inscribed on a tangible 27 medium or that is stored in an electronic or other medium and is 28 retrievable in perceivable form.
- 29 (18) "Sign" means, with present intent to authenticate or adopt a 30 record:
 - (a) To execute or adopt a tangible symbol; or
- 32 (b) To attach to or logically associate with the record an 33 electronic symbol, sound, or process.
- 34 (19) "Signatory" means an individual who signs a record.
- 35 (20) "State" means a state of the United States, the District of 36 Columbia, Puerto Rico, the United States Virgin Islands, or any 37 territory or insular possession under the jurisdiction of the United 38 States. The term includes a federally recognized Indian tribe.

- 1 (21) "Transfer" means a procedure for assisted reproduction by 2 which an embryo or sperm is placed in the body of the woman who will 3 give birth to the child.
- 4 (22) "Witnessed" means that at least one individual who is 5 authorized to sign has signed a record to verify that the individual 6 personally observed a signatory sign the record.
 - (23) "Woman" means a female individual of any age.

- 8 <u>NEW SECTION.</u> **Sec. 103.** SCOPE. (1) This chapter applies to an adjudication or determination of parentage.
- 10 (2) This chapter does not create, affect, enlarge, or diminish 11 parental rights or duties under law of this state other than this 12 chapter.
- NEW SECTION. Sec. 104. AUTHORIZED COURT. The superior courts of this state may adjudicate parentage under this chapter.
- NEW SECTION. Sec. 105. APPLICABLE LAW. The court shall apply the law of this state to adjudicate parentage. The applicable law does not depend on:
- 18 (1) The place of birth of the child; or
- 19 (2) The past or present residence of the child.
- NEW SECTION. Sec. 106. DATA PRIVACY. A proceeding under this chapter is subject to law of this state other than this chapter which governs the health, safety, privacy, and liberty of a child or other individual who could be affected by disclosure of information that could identify the child or other individual, including address, telephone number, digital contact information, place of employment, social security number, and the child's day care facility or school.
- NEW SECTION. Sec. 107. ESTABLISHMENT OF MATERNITY AND PATERNITY. To the extent practicable, a provision of this chapter applicable to a father-child relationship applies to a mother-child relationship and a provision of this chapter applicable to a mother-child relationship applies to a father-child relationship.

- NEW SECTION. Sec. 201. ESTABLISHMENT OF PARENT-CHILD RELATIONSHIP. A parent-child relationship is established between an individual and a child if:
 - (1) The individual gives birth to the child, except as otherwise provided in sections 701 through 718 of this act;

- 19 (7) The individual's parentage of the child is established under 20 sections 702 through 707.
- NEW SECTION. Sec. 202. NO DISCRIMINATION BASED ON MARITAL STATUS OF PARENT. A parent-child relationship extends equally to every child and parent, regardless of the marital status of the parent.
- NEW SECTION. Sec. 203. CONSEQUENCES OF ESTABLISHING PARENTAGE.
 Unless parental rights are terminated, a parent-child relationship
 established under this chapter applies for all purposes, except as
 otherwise provided by law of this state other than this chapter.
- 29 <u>NEW SECTION.</u> **Sec. 204.** PRESUMPTION OF PARENTAGE. (1) An 30 individual is presumed to be a parent of a child if:
- 31 (a) Except as otherwise provided under sections 701 through 718 32 of this act, or law of this state other than this chapter:
- (i) The individual and the woman who gave birth to the child are married to or in a state registered domestic partnership with each other and the child is born during the marriage or partnership, whether the marriage or partnership is or could be declared invalid;

- (ii) The individual and the woman who gave birth to the child were married to or in a state registered domestic partnership with each other and the child is born not later than three hundred days after the marriage or partnership is terminated by death, dissolution, annulment, declaration of invalidity, or legal separation, whether the marriage or partnership is or could be declared invalid; or
- (iii) The individual and the woman who gave birth to the child married or entered into a state registered domestic partnership with each other after the birth of the child, whether the marriage or partnership is or could be declared invalid, the individual at any time asserted parentage of the child, and:
- 13 (A) The assertion is in a record filed with the state registrar 14 of vital statistics; or
- 15 (B) The individual agreed to be and is named as a parent of the 16 child on the birth certificate of the child; or
 - (b) The individual resided in the same household with the child for the first four years of the life of the child, including any period of temporary absence, and openly held out the child as the individual's child.
- (2) A presumption of parentage under this section may be overcome, and competing claims to parentage may be resolved, only by an adjudication under sections 501 through 523 of this act, or a valid denial of parentage under sections 301 through 314 of this act.

VOLUNTARY ACKNOWLEDGMENT OF PARENTAGE

- NEW SECTION. Sec. 301. ACKNOWLEDGMENT OF PARENTAGE. A woman who gave birth to a child and an alleged genetic father of the child, intended parent under sections 601 through 608 of this act, or presumed parent may sign an acknowledgment of parentage to establish the parentage of the child.
- NEW SECTION. Sec. 302. EXECUTION OF ACKNOWLEDGMENT OF PARENTAGE. (1) An acknowledgment of parentage under section 301 of this act must:
- 35 (a) Be in a record signed by the woman who gave birth to the 36 child and by the individual seeking to establish a parent-child

- (b) State that the child whose parentage is being acknowledged:
- (i) Does not have a presumed parent other than the individual seeking to establish the parent-child relationship or has a presumed parent whose full name is stated; and
- (ii) Does not have another acknowledged parent, adjudicated parent, or individual who is a parent of the child under sections 601 through 608 and 701 through 718 of this act, other than the woman who gave birth to the child; and
- (c) State that the signatories understand that the acknowledgment is the equivalent of an adjudication of parentage of the child and that a challenge to the acknowledgment is permitted only under limited circumstances and is barred four years after the effective date of the acknowledgment.
- 16 (2) An acknowledgment of parentage is void if, at the time of 17 signing:
 - (a) An individual other than the individual seeking to establish parentage is a presumed parent, unless a denial of parentage by the presumed parent in a signed record is filed with the state registrar of vital statistics; or
- (b) An individual, other than the woman who gave birth to the child or the individual seeking to establish parentage, is an acknowledged or adjudicated parent or a parent under sections 601 through 608 and 701 through 718 of this act.
- NEW SECTION. Sec. 303. DENIAL OF PARENTAGE. A presumed parent or alleged genetic parent may sign a denial of parentage in a record.

 The denial of parentage is valid only if:
- 29 (1) An acknowledgment of parentage by another individual is filed 30 under section 305 of this act;
- 31 (2) The signature of the presumed parent or alleged genetic 32 parent is attested by a notarial officer or witnessed; and
- 33 (3) The presumed parent or alleged genetic parent has not 34 previously:
- 35 (a) Completed a valid acknowledgment of parentage, unless the 36 previous acknowledgment was rescinded under section 308 of this act 37 or challenged successfully under section 309 of this act; or
 - (b) Been adjudicated to be a parent of the child.

NEW SECTION. Sec. 304. RULES FOR ACKNOWLEDGMENT OR DENIAL OF PARENTAGE. (1) An acknowledgment of parentage and a denial of parentage may be contained in a single document or may be in counterparts and may be filed with the state registrar of vital statistics separately or simultaneously. If filing of the acknowledgment and denial both are required under this chapter, neither is effective until both are filed.

- 8 (2) An acknowledgment of parentage or denial of parentage may be 9 signed before or after the birth of the child.
- 10 (3) Subject to subsection (1) of this section, an acknowledgment 11 of parentage or denial of parentage takes effect on the birth of the 12 child or filing of the document with the state registrar of vital 13 statistics, whichever occurs later.
- 14 (4) An acknowledgment of parentage or denial of parentage signed 15 by a minor is valid if the acknowledgment complies with this chapter.
- NEW SECTION. Sec. 305. EFFECT OF ACKNOWLEDGMENT OR DENIAL OF PARENTAGE. (1) Except as otherwise provided in sections 308 and 309 of this act, an acknowledgment of parentage that complies with sections 301 through 314 of this act and is filed with the state registrar of vital statistics is equivalent to an adjudication of parentage of the child and confers on the acknowledged parent all rights and duties of a parent.
 - (2) Except as otherwise provided in sections 308 and 309 of this act, a denial of parentage by a presumed parent or alleged genetic parent which complies with sections 301 through 314 of this act and is filed with the state registrar of vital statistics with an acknowledgment of parentage that complies with sections 301 through 314 of this act is equivalent to an adjudication of the nonparentage of the presumed parent or alleged genetic parent and discharges the presumed parent or alleged genetic parent from all rights and duties of a parent.
- NEW SECTION. Sec. 306. NO FILING FEE. The state registrar of vital statistics may not charge a fee for filing an acknowledgment of parentage or denial of parentage.
- NEW SECTION. Sec. 307. RATIFICATION BARRED. A court conducting a judicial proceeding or an administrative agency conducting an

- NEW SECTION. Sec. 308. PROCEDURE FOR RESCISSION. (1) A signatory may rescind an acknowledgment of parentage or denial of parentage by filing with the state registrar of vital statistics a rescission in a signed record which is attested by a notarial officer or witnessed, before the earlier of:
- 8 (a) Sixty days after the effective date under section 304 of this 9 act of the acknowledgment or denial; or
 - (b) The date of the first hearing before a court in a proceeding, to which the signatory is a party, to adjudicate an issue relating to the child, including a proceeding that establishes support.
 - (2) If an acknowledgment of parentage is rescinded under subsection (1) of this section, an associated denial of parentage is invalid, and the state registrar of vital statistics shall notify the woman who gave birth to the child and the individual who signed a denial of parentage of the child that the acknowledgment has been rescinded. Failure to give the notice required by this subsection does not affect the validity of the rescission.
- 20 NEW SECTION. Sec. 309. CHALLENGE AFTER EXPIRATION OF PERIOD FOR RESCISSION. (1) After the period for rescission under section 308 of 21 this act expires, but not later than four years after the effective 22 23 date under section 304 of this act of an acknowledgment of parentage 24 or denial of parentage, a signatory of the acknowledgment or denial 25 may commence a proceeding to challenge the acknowledgment or denial, including a challenge brought under section 514 of this act, only on 26 the basis of fraud, duress, or material mistake of fact. 27
- (2) A challenge to an acknowledgment of parentage or denial of parentage by an individual who was not a signatory to the acknowledgment or denial is governed by section 510 of this act.
- 31 <u>NEW SECTION.</u> **Sec. 310.** PROCEDURE FOR CHALLENGE BY SIGNATORY.
- 32 (1) Every signatory to an acknowledgment of parentage and any related
- denial of parentage must be made a party to a proceeding to challenge

- 35 (2) By signing an acknowledgment of parentage or denial of 36 parentage, a signatory submits to personal jurisdiction in this state 37 in a proceeding to challenge the acknowledgment or denial, effective

- (3) The court may not suspend the legal responsibilities arising from an acknowledgment of parentage, including the duty to pay child support, during the pendency of a proceeding to challenge the acknowledgment or a related denial of parentage, unless the party challenging the acknowledgment or denial shows good cause.
- 8 (4) A party challenging an acknowledgment of parentage or denial 9 of parentage has the burden of proof.
- 10 (5) If the court determines that a party has satisfied the burden 11 of proof under subsection (4) of this section, the court shall order 12 the state registrar of vital statistics to amend the birth record of 13 the child to reflect the legal parentage of the child.

- NEW SECTION. Sec. 312. FORMS FOR ACKNOWLEDGMENT AND DENIAL OF PARENTAGE. (1) The state registrar of vital statistics shall prescribe forms for an acknowledgment of parentage and denial of parentage.
- 26 (2) A valid acknowledgment of parentage or denial of parentage is 27 not affected by a later modification of the form under subsection (1) 28 of this section.
- NEW SECTION. Sec. 313. RELEASE OF INFORMATION. The state registrar of vital statistics may release information relating to an acknowledgment of parentage or denial of parentage to a signatory of the acknowledgment or denial, a court, federal agency, and child support agency of this or another state.

3 SUBCHAPTER 4

4 GENETIC TESTING

NEW SECTION. Sec. 401. DEFINITIONS. The definitions in this section apply throughout sections 401 through 412 of this act unless the context clearly requires otherwise.

- (1) "Combined relationship index" means the product of all tested relationship indices.
- (2) "Ethnic or racial group" means, for the purpose of genetic testing, a recognized group that an individual identifies as the individual's ancestry or part of the ancestry or that is identified by other information.
- 14 (3) "Hypothesized genetic relationship" means an asserted genetic 15 relationship between an individual and a child.
 - (4) "Probability of parentage" means, for the ethnic or racial group to which an individual alleged to be a parent belongs, the probability that a hypothesized genetic relationship is supported, compared to the probability that a genetic relationship is supported between the child and a random individual of the ethnic or racial group used in the hypothesized genetic relationship, expressed as a percentage incorporating the combined relationship index and a prior probability.
 - (5) "Relationship index" means a likelihood ratio that compares the probability of a genetic marker given a hypothesized genetic relationship and the probability of the genetic marker given a genetic relationship between the child and a random individual of the ethnic or racial group used in the hypothesized genetic relationship.
- NEW SECTION. Sec. 402. SCOPE—LIMITATION ON USE OF GENETIC TESTING. (1) This subchapter, sections 401 through 412 of this act, governs genetic testing of an individual in a proceeding to adjudicate parentage, whether the individual:
 - (a) Voluntarily submits to testing; or

- Sec. 403. AUTHORITY TO ORDER OR DENY GENETIC 4 NEW SECTION. 5 TESTING. (1) Except as otherwise provided in sections 401 through 412 or 501 through 523 of this act, in a proceeding under this chapter to б determine parentage, the court shall order the child and any other 7 individual to submit to genetic testing if a request for testing is 8 supported by the sworn statement of a party: 9
- 10 (a) Alleging a reasonable possibility that the individual is the child's genetic parent; or 11
 - (b) Denying genetic parentage of the child and stating facts establishing a reasonable possibility that the individual is not a genetic parent.
 - (2) A child support agency may order genetic testing only if there is no presumed, acknowledged, or adjudicated parent of a child other than the woman who gave birth to the child.
- (3) The court or child support agency may not order in utero 18 genetic testing. 19
- (4) If two or more individuals are subject to court-ordered genetic testing, the court may order that testing be completed 21 concurrently or sequentially. 22
 - (5) Genetic testing of a woman who gave birth to a child is not a condition precedent to testing of the child and an individual whose genetic parentage of the child is being determined. If the woman is unavailable or declines to submit to genetic testing, the court may order genetic testing of the child and each individual whose genetic parentage of the child is being adjudicated.
 - (6) In a proceeding to adjudicate the parentage of a child having a presumed parent or an individual who claims to be a parent under section 509 of this act, or to challenge an acknowledgment of parentage, the court may deny a motion for genetic testing of the child and any other individual after considering the factors in section 513 (1) and (2) of this act.
 - (7) If an individual requesting genetic testing is barred under sections 501 through 523 of this act from establishing the individual's parentage, the court shall deny the request for genetic testing.

- 1 (8) An order under this section for genetic testing is 2 enforceable by contempt.
- NEW SECTION. Sec. 404. REQUIREMENTS FOR GENETIC TESTING. (1)
 Genetic testing must be of a type reasonably relied on by experts in
 the field of genetic testing and performed in a testing laboratory
 accredited by:

- (a) The AABB, formerly known as the American association of blood banks, or a successor to its functions; or
- (b) An accrediting body designated by the secretary of the United States department of health and human services.
 - (2) A specimen used in genetic testing may consist of a sample or a combination of samples of blood, buccal cells, bone, hair, or other body tissue or fluid. The specimen used in the testing need not be of the same kind for each individual undergoing genetic testing.
 - (3) Based on the ethnic or racial group of an individual undergoing genetic testing, a testing laboratory shall determine the databases from which to select frequencies for use in calculating a relationship index. If an individual or a child support agency objects to the laboratory's choice, the following rules apply:
 - (a) Not later than thirty days after receipt of the report of the test, the objecting individual or child support agency may request the court to require the laboratory to recalculate the relationship index using an ethnic or racial group different from that used by the laboratory.
- 25 (b) The individual or the child support agency objecting to the laboratory's choice under this subsection shall:
 - (i) If the requested frequencies are not available to the laboratory for the ethnic or racial group requested, provide the requested frequencies compiled in a manner recognized by accrediting bodies; or
 - (ii) Engage another laboratory to perform the calculations.
 - (c) The laboratory may use its own statistical estimate if there is a question which ethnic or racial group is appropriate. The laboratory shall calculate the frequencies using statistics, if available, for any other ethnic or racial group requested.

 - (c) The spouse of the woman acting as a surrogate, if any, must acknowledge and agree to comply with the obligations imposed on the woman acting as a surrogate by the agreement.
- (d) Except as otherwise provided in sections 711, 714, and 715 of this act, the intended parent or, if there are two intended parents, each one jointly and severally, immediately on birth will be the exclusive parent or parents of the child, regardless of number of children born or gender or mental or physical condition of each child.

- (f) The agreement must include information disclosing how each intended parent will cover the surrogacy-related expenses of the surrogate and the medical expenses of the child. If health care coverage is used to cover the medical expenses, the disclosure must include a summary of the health care policy provisions related to coverage for surrogate pregnancy, including any possible liability of the woman acting as a surrogate, third-party liability liens, other insurance coverage, and any notice requirement that could affect coverage or liability of the woman acting as a surrogate. Unless the agreement expressly provides otherwise, the review and disclosure do not constitute legal advice. If the extent of coverage is uncertain, a statement of that fact is sufficient to comply with this subsection (1)(f).
- (g) The agreement must permit the woman acting as a surrogate to make all health and welfare decisions regarding herself and her pregnancy and, notwithstanding any other provisions in this chapter, provisions in the agreement to the contrary are void and unenforceable. This chapter does not diminish the right of the woman acting as a surrogate to terminate her pregnancy.
- (h) The agreement must include information about each party's right under sections 701 through 718 of this act to terminate the surrogacy agreement.
 - (2) A surrogacy agreement may provide for:
 - (a) Payment of consideration and reasonable expenses; and
- 31 (b) Reimbursement of specific expenses if the agreement is 32 terminated under sections 701 through 718 of this act.
