1            AN ACT Relating to registration enforcement for off-road vehicles  
2 and snowmobiles; adding a new section to chapter 46.09 RCW; adding a  
3 new section to chapter 46.10 RCW; adding a new section to chapter  
4 46.93 RCW; creating new sections; prescribing penalties; and  
5 providing an effective date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7            NEW SECTION.    **Sec. 1.**    The legislature finds that many residents  
8 of Washington enjoy recreational opportunities for off-road vehicle  
9 and snowmobile use afforded by the natural beauty of the state and do  
10 so in compliance with vehicle titling and registration laws and other  
11 laws that govern off-road vehicle and snowmobile use. At the same  
12 time, the legislature recognizes that the current law and  
13 corresponding enforcement regime may not be robust enough to ensure  
14 full compliance with legal registration requirements and a level  
15 playing field for all users. It is therefore the intent of the  
16 legislature to modify the statutory framework governing penalties for  
17 off-road vehicle and snowmobile registration violations and to add  
18 requirements to the department of licensing in order to improve  
19 registration compliance.

1        NEW SECTION.    **Sec. 2.**    A new section is added to chapter 46.09  
2 RCW under the subchapter heading "uses and violations" to read as  
3 follows:

4        (1) It is a gross misdemeanor, punishable as provided under  
5 chapter 9A.20 RCW, for a resident, as identified in RCW 46.16A.140,  
6 to knowingly fail to apply for a Washington state certificate of  
7 title for, or to knowingly fail to register, an off-road vehicle  
8 within fifteen days of receiving or refusing a notice issued by the  
9 department under section 4 of this act.

10        (2) Excise taxes owed and fines assessed must be deposited in the  
11 manner provided under RCW 46.16A.030(6).

12        NEW SECTION.    **Sec. 3.**    A new section is added to chapter 46.10  
13 RCW under the subchapter heading "uses and violations" to read as  
14 follows:

15        (1) It is a gross misdemeanor, punishable as provided under  
16 chapter 9A.20 RCW, for a resident, as identified in RCW 46.16A.140,  
17 to knowingly fail to register a snowmobile within fifteen days of  
18 receiving or refusing a notice issued by the department under section  
19 4 of this act.

20        (2) Excise taxes owed and fines assessed must be deposited in the  
21 manner provided under RCW 46.16A.030(6).

22        NEW SECTION.    **Sec. 4.**    A new section is added to chapter 46.93  
23 RCW to read as follows:

24        (1) By the first business day in February of each year, beginning  
25 in 2018, motorsports vehicle manufacturers must report to the  
26 department of licensing a listing of all motorsports vehicle  
27 warranties for off-road vehicles under chapter 46.09 RCW and  
28 snowmobiles under chapter 46.10 RCW sold to Washington residents by  
29 out-of-state motorsports vehicle dealers in the previous calendar  
30 year. The report must be transmitted such that the department  
31 receives the listing no later than the first business day in  
32 February. Failure to report a complete listing as required under this  
33 subsection results in an administrative fine of one hundred dollars  
34 for each day after the first business day in February that the  
35 department has not received the report.

36        (2) The department of licensing shall examine the listing  
37 reported in subsection (1) of this section to verify whether the  
38 vehicles are properly registered in the state. Beginning in 2018, and

1 to the extent that it has received the listing required under  
2 subsection (1) of this section, the department shall notify by  
3 certified mail from the United States postal service, with return  
4 receipt requested, by the end of February of each year, the  
5 purchasers of the warranties of the off-road vehicles and snowmobiles  
6 that are not properly registered in the state of the owner's  
7 obligations under state law regarding vehicle titling, registration,  
8 and use tax payment, as well as of the penalties for failure to  
9 comply with the law.

10 (3) Fines received under this section must be paid into the state  
11 treasury and credited to the nonhighway and off-road vehicle  
12 activities program account under RCW 46.09.510 and to the snowmobile  
13 account under RCW 46.68.350. The state treasurer must apportion the  
14 fines between the accounts according to the pro rata share of the  
15 number of off-road vehicle and snowmobile registrations in the  
16 previous calendar year. The department must provide the state  
17 treasurer with the information needed to determine the apportionment.

18 NEW SECTION. **Sec. 5.** Section 4 of this act applies to the sales  
19 of off-road vehicles and snowmobiles beginning in January 2017.

20 NEW SECTION. **Sec. 6.** This act takes effect August 1, 2017.
