1 On page 3, after line 32, insert the following:

3 "NEW SECTION. **Sec. 3.** (1) The state board of education shall
4 convene and lead a competency-based education work group by June 1,
5 2019. The purpose of the work group is to facilitate student access
6 to relevant and robust pathways aligned to their personal goals for
7 their career and further education as reflected in their high school
8 and beyond plans. The work group shall coordinate the:

9 (a) Development of a competency-based pathway for earning a high
10 school diploma; and

11 (b) Expansion of options for competency-based credit that meet
12 graduation requirements.

13 (2) The work group may not exceed twenty-one members and must
14 include the following members:

15 (a) Two students as selected by the association of Washington
16 student leaders;

17 (b) Two parents as selected by the Washington state parent
18 teacher association;

19 (c) One representative from the Washington state commission on
20 African-American affairs as selected by the governor;

21 (d) One representative from the Washington state commission on
22 Asian Pacific American affairs as selected by the governor;

23 (e) One representative from the Washington state commission on
24 Hispanic affairs as selected by the governor;

25 (f) One representative from the governor's office of Indian
26 affairs as selected by the governor;

1 (g) One representative from the educational opportunity gap
2 oversight and accountability committee as selected by the
3 educational opportunity gap oversight and accountability committee;
4 (h) One high school principal as selected by the association of
5 Washington school principals;
6 (i) One high school certificated teacher as selected by the
7 Washington education association;
8 (j) One high school counselor as selected by the Washington
9 education association;
10 (k) One school district board member as selected by the
11 Washington state school directors' association;
12 (l) One school district superintendent as selected by the
13 Washington association of school administrators;
14 (m) One community or technical college instructor or
15 administrator as selected by the Washington state board for
16 community and technical colleges;
17 (n) One university faculty or administrator as selected by the
18 Washington student achievement council;
19 (o) One representative from the office of the superintendent of
20 public instruction as selected by the superintendent of public
21 instruction;
22 (p) One representative from the state board of education as
23 selected by the chair of the state board of education; and
24 (q) Three representatives from business or industry as selected
25 by the workforce training and education coordinating board.
26 (3) The state board of education shall:
27 (a) Provide leadership of the work group;
28 (b) Coordinate work group membership to ensure member diversity,
29 including racial, ethnic, gender, geographic, community-size, and
30 expertise diversity;
31 (c) Provide staff support to the work group; and
32 (d) Submit an interim report outlining preliminary findings and
33 potential recommendations to the governor and the legislature by
34 December 1, 2019, and a final report detailing all findings and

1 recommendations related to the work group's purpose and tasks
2 described in subsection (1) of this section by December 1, 2020.

3 (4) This section expires March 1, 2021."

EFFECT: Directs the State Board of Education to convene, staff,
and lead a competency-based education work group of 21 or fewer
members. Prescribes duties and membership provisions for the work
group and directs it to produce related reports by December 1, 2019,
and December 1, 2020.
