- 2 implement a proactive policing grant program.
- 3 (a) The purpose of the program is to provide additional,
- 4 nonsupplanted funding to law enforcement agencies to address the
- 5 public safety needs of their individual communities. The grants
- 6 must be awarded to local law enforcement agencies based on their
- 7 locally developed proposals, and two or more agencies may submit a
- 8 joint grant proposal. A peer review panel appointed by the
- 9 Washington association of sheriffs and police chiefs must review the
- 10 grant applications, and association may prioritize grant
- 11 applications that include local matching funds.
- 12 (b) To the extent practicable, grants should be awarded on a
- 13 two-year cycle, and grant proposals must:
- (i) Demonstrate the public safety problem to be addressed;
- (ii) Identify the strategy for addressing the problem; and
- 16 (iii) Identify specific data elements to measure the current
- 17 state of the problem and whether the actions to address the problem
- 18 were successful.
- 19 (c) By December 1st of each year the program is funded,
- 20 association must submit an annual report to the governor and the
- 21 appropriate committees of the legislature. The report must include
- 22 information regarding the grant recipients, the use of funds, and
- 23 feedback from the grant recipients."

- 28 (1) The home security fund account is created in the state
- 29 treasury, subject to appropriation. The state's portion of the
- 30 surcharge established in RCW 36.22.179 and 36.22.1791 must be
- 31 deposited in the account. Expenditures from the account may be used
- 32 only for homeless housing programs as described in this chapter.
- 33 During the 2019-21 fiscal biennium, moneys from the home security
- 34 fund account may be appropriated for grants for local government

- 1 drug and gang task forces to prevent substance abuse disorders that
- 2 may lead to homelessness.
- 3 (2) The department must distinguish allotments from the account
- 4 made to carry out the activities in RCW 43.330.167, 43.330.700
- 5 through 43.330.715, 43.330.911, 43.185C.010, 43.185C.250 through
- 6 43.185C.320, and 36.22.179(1)(b).
- 7 (3) The office of financial management must secure an
- 8 independent expenditure review of state funds received under RCW
- 9 36.22.179(1)(b) on a biennial basis. The purpose of the review is to
- 10 assess the consistency in achieving policy priorities within the
- 11 private market rental housing segment for housing persons
- 12 experiencing homelessness. The independent reviewer must notify the
- 13 department and the office of financial management of its findings.
- 14 The first biennial expenditure review, for the 2017-2019 fiscal
- 15 biennium, is due February 1, 2020. Independent reviews conducted
- 16 thereafter are due February 1st of each even-numbered year."

  - <u>EFFECT:</u> (1) Provides \$8 million for the Department of Commerce to provide grants to local government drug and gang task forces.
  - (2) Provides \$10 million for the Criminal Justice Training Commission for the Washington Association of Sheriffs and Police Chiefs (WASPC) to develop and administer a proactive policing grant program that provides funding to law enforcement agencies to address the public safety needs of their individual communities. Requires WASPC to provide an annual report to the Governor and the Legislature by December 1st for each year the program is funded.
  - (3) Provides \$2 million from amounts appropriated in the underlying bill from the Home Security Fund-State for the Department of Commerce to provide grants to local drug and gang task forces.

FISCAL IMPACT: Increases General Fund - State by \$18,000,000.
