(33) \$3,000,000 of the general fund-state appropriation for 10 fiscal year 2020 and \$3,000,000 of the general fund-state 11 appropriation for fiscal year 2021 are provided solely to support 12 organizations that provide breast and cervical cancer screenings at 13 the county level. None of these amounts may be provided to 14 organizations that perform abortions." 15 16 Correct any internal references accordingly. 17 18 On page 308, after line 23, insert the following: "General Fund: For transfer to the sexual assault prevention and 19 20 response account, \$2,082,000 for fiscal year 2020 and 21 \$2,082,000 for fiscal year 22 2021.....\$4,164,000"

EFFECT: Prohibits the Medical Assistance program in the Health Care Authority and the Reproductive Health and Wellness program in the Department of Health (DOH) from paying for abortions that are not deemed medically necessary by the patient's primary care physician. Funding for those programs is reduced by \$10,164,000 General Fund-State in the 2019-21 biennium.

Funding for the DOH to support organizations that provide breast and cervical cancer screenings at the county level is increased by \$6,000,000 in the 2019-21 biennium. Prohibits any of these funds from going to organizations that perform abortions.

Funding for the Sexual Assault Prevention and Response Account is increased by \$4,164,000 for the 2019-21 biennium.
