- EFFECT: (1) Requires a religious organization to notify the county, city or town, or code city of the public meeting it is hosting regarding a homeless encampment by certified mail at least two weeks prior to the meeting.
- (2) Requires a county, city or town, or code city to publish notice of the meeting hosted by a religious organization regarding a homeless encampment that must be:
- (a) Delivered to each local newspaper and local radio and television station that has requested to be notified of special meetings of an agency;
 - (b) Posted on the agency's web site, with certain exceptions;
- (c) Displayed at the main entrance of the agency's location and the meeting site; and
 - (d) Delivered or posted at least seven days before the meeting.
