<u>EFFECT:</u> Makes the following changes to the expanded use of automated traffic safety cameras for specified traffic violations in cities with populations greater than 500,000 people:

- Limits their use to the portion of state and local roadways in downtown areas used for office, commercial, retail shopping, support services, and mixed residential uses; one-half mile surrounding the boundaries of these downtown areas; the portion of non-interstate freeways that travel into and out of these downtown areas for up to three miles; and the portion of roadway systems connected to these non-interstate freeway segments that are arterial roadways for up to one mile from their intersection with the non-interstate freeways.
- Clarifies the applicability of notice of infraction rules in the bill.
