EFFECT: Revises exclusions from onsite work to exclude: ship and rail car support activities; environmental inspection and testing; security guard services; warranty work performed by an original equipment manufacturer under certain circumstances; industrial cleaning and inspection services not related to construction; certain safety services; non-construction catalyst loading, regeneration, and removal; chemical purging and cleaning; refinery byproduct separation and recovery; and work performed that is not in an apprenticeable occupation.

Extends the implementation schedule for the graduation requirement to require 20 percent of the skilled journeypersons to be apprenticeship graduates beginning in 2021 rather than 2020 and to reach 60 percent in 2024 rather than 2023.

Provides for the safety training to have been completed within the past three rather than two years.

Requires the Department of Labor and Industries, in consultation with the Washington State Apprenticeship and Training Council, to prioritize consideration of new apprenticeship programs for workers in high-hazard facilities.
