EFFECT: Amends the definition of "covered entity" to specify that the definition includes a wholesaler, supplier, or retailer that has contractually undertaken responsibility to the manufacturer for the "do not flush" labeling of a covered product. Limits the entities that may request nonconfidential business information and documentation from a covered entity to the attorney general, a city, or a county. Specifies that the attorney general, cities, and counties, have concurrent and exclusive authority to enforce the labeling requirements. Changes the qualification of a specific violation of the labeling requirements from the sale of a noncompliant product by stock keeping unit number or unique item number to the sale of a noncompliant product package. Makes technical and clarifying changes.
