EFFECT: Exempts the applicant for an original off-road vehicle
(ORV) registration from the registration fee, if the vehicle is also

properly registered in another state. Requires the Department of Licensing, upon receipt of the application, to issue a metal tag along with the appropriate tab to a wheeled all-terrain vehicle owner and to issue a decal to an off-road vehicle owner otherwise.
