- 5 license fee required under RCW 46.17.350, in addition to any other

EFFECT: Exempts the applicant for an original off-road vehicle (ORV) registration or an ORV registration renewal from the registration fee, if the vehicle is also properly registered or permitted in another state to a resident of that state, and the resident presents at the time of application his or her unexpired driver's license from the other state, as well as the current registration or permit issued by the state for the ORV. Requires the DOL, upon receipt of the application, to issue a metal tag along with the appropriate tab to a wheeled all-terrain vehicle owner and to issue a decal to an ORV owner otherwise.
