<u>EFFECT:</u> Adds psychologists to the reciprocity program. Adds psychologists and chemical dependency professionals to the provisions directing the Department of Health to explore options related to interstate compacts.

Applies the reciprocity program to applicants from other states or territories with substantially equivalent or greater scope of practice to Washington's, rather than an equivalent scope of practice or greater. Limits persons with a probationary credential to only practicing in licensed or certified behavioral health service providers. Requires the Department of Health to prioritize identifying the five states or territories that have historically had

the most applicants for reciprocity with a scope of practice that is substantially equivalent to or greater than the scope in Washington.

Relocates the reciprocity program to the chapters for the respective professions.
