<u>EFFECT:</u> Instructs the Sex Offender Treatment Provider Advisory Committee (Advisory Committee) to consider options for reducing or eliminating certification-related fees, including the feasibility of requiring the underlying professions that the applicants are credentialed as to bear the regulatory costs.

Requires the Department of Social and Health Services to notify the Department of Health whenever a sex offender treatment provider in an underserved county contracts to provide treatment services to a sexually violent predator on conditional release. Directs the Department of Health to waive credentialing fees for sex offender treatment providers practicing in such circumstances. Defines an "underserved county" as a county identified by the Department of Social and Health services as having an inadequate supply of qualified sex offender treatment providers to achieve an equitable geographic distribution of conditional releases.
