1 Strike everything after the enacting clause and insert the
2 following:

3 "Sec. 1. RCW 46.20.285 and 2005 c 288 s 4 are each amended to
4 read as follows:

5 The department shall revoke the license of any driver for the
6 period of one calendar year unless otherwise provided in this
7 section, upon receiving a record of the driver's conviction of any of
8 the following offenses, when the conviction has become final:

9 (1) For vehicular homicide the period of revocation shall be two
10 years. The revocation period shall be tolled during any period of
11 total confinement for the offense;

12 (2) Vehicular assault. The revocation period shall be tolled
13 during any period of total confinement for the offense;

14 (3) Driving a motor vehicle while under the influence of
15 intoxicating liquor or a narcotic drug, or under the influence of any
16 other drug to a degree which renders the driver incapable of safely
17 driving a motor vehicle, for the period prescribed in RCW 46.61.5055;

18 (4) Any felony in the commission of which the sentencing court
19 determines that a motor vehicle (~~is~~) was used in a manner that
20 endangered persons or property;

21 (5) Failure to stop and give information or render aid as
22 required under the laws of this state in the event of a motor vehicle
23 accident resulting in the death or personal injury of another or
24 resulting in damage to a vehicle that is driven or attended by
25 another;

26 (6) Perjury or the making of a false affidavit or statement under
27 oath to the department under Title 46 RCW or under any other law
28 relating to the ownership or operation of motor vehicles;

29 (7) Reckless driving upon a showing by the department's records
30 that the conviction is the third such conviction for the driver
31 within a period of two years.

1 NEW SECTION. **Sec. 2.** This act takes effect July 1, 2020.

2 NEW SECTION. **Sec. 3.** If specific funding for the purposes of
3 this act, referencing this act by bill or chapter number, is not
4 provided by June 30, 2019, in the omnibus transportation
5 appropriations act, this act is null and void."

6 On page 1, line 2 of the title, after "offenses;" strike the
7 remainder of the title and insert "amending RCW 46.20.285; creating a
8 new section; and providing an effective date."

EFFECT: (1) Requires DOL to revoke the license of a person who is convicted of a felony in the commission of which the sentencing court determines that a motor vehicle was used in a manner that endangered persons or property instead of when the sentencing court determines that community safety requires revocation.

(2) Adds a delayed effective date of July 1, 2020.

(3) Adds a null and void clause.
