2 following:

3 **"Sec. 1.** 2017 3rd sp.s. c 37 s 501 (uncodified) is amended to
4 read as follows:

5 (1) This section is the tax preference performance statement for
6 the tax preferences contained in sections 502 and 503, chapter 37,
7 Laws of 2017 3rd sp. sess. This performance statement is only
8 intended to be used for subsequent evaluation of the tax preferences.
9 It is not intended to create a private right of action by any party
10 or be used to determine eligibility for preferential tax treatment.

11 (2) The legislature categorizes these tax preferences as ones
12 intended to induce certain designated behavior by taxpayers, improve
13 industry competitiveness, and create or retain jobs, as indicated in
14 RCW 82.32.808(2) (a) through (c).

15 (3) It is the legislature's specific public policy objective to
16 maintain and expand business in the semiconductor cluster. It is the
17 legislature's intent to extend by ten years the preferential tax
18 rates for manufacturers and processors for hire of semiconductor
19 materials in order to maintain and grow jobs in the semiconductor
20 cluster.

21 (4) If a review finds that: (a) Since October 19, 2017, at least
22 one project in the semiconductor cluster has located in Clark county,
23 and that this project generates at least two thousand five hundred
24 high-wage jobs, all of which pay twenty dollars per hour or more and
25 at least eighty percent of which pay thirty-five dollars per hour or
26 more; and (b) the number of jobs in the semiconductor cluster in
27 Washington has increased since October 19, 2017, then the legislature
28 intends to extend the expiration date of the tax preference.

29 (5) In order to obtain the data necessary to perform the review
30 in subsection (4) of this section, the joint legislative audit and
31 review committee may refer to data from the department of revenue's

1 annual survey ((data)) for tax years ending before January 1, 2020,
2 and annual tax performance report for subsequent tax years.

3 **Sec. 2.** 2017 3rd sp.s. c 37 s 504 (uncodified) is amended to
4 read as follows:

5 (1) This section is the tax preference performance statement for
6 the tax preferences contained in sections 505 through 508, chapter
7 37, Laws of 2017 3rd sp. sess. This performance statement is only
8 intended to be used for subsequent evaluation of the tax preferences.
9 It is not intended to create a private right of action by any party
10 or be used to determine eligibility for preferential tax treatment.

11 (2) The legislature categorizes these tax preferences as ones
12 intended to induce certain designated behavior by taxpayers, improve
13 industry competitiveness, and create or retain jobs, as indicated in
14 RCW 82.32.808(2) (a) through (c).

15 (3) It is the legislature's specific public policy objective to
16 encourage significant construction projects; retain, expand, and
17 attract semiconductor business; and encourage and expand family-wage
18 jobs. It is the legislature's intent to extend by ten years the
19 ((preferential tax rates)) exemptions for sales and use of gases and
20 chemicals used in the production of semiconductor materials, in order
21 to encourage the growth and retention of the semiconductor business
22 in Washington, thereby strengthening Washington's competitiveness
23 with other states for manufacturing investment.

24 (4) If a review finds that the number of construction projects in
25 the industry has increased, and that ((+the+)) the number of people
26 employed by the solar silicon, silicon manufacturing, and
27 semiconductor fabrication industry in Washington is the same or more
28 than in 2015, and that at least sixty percent of employees earn sixty
29 thousand dollars a year, then the legislature intends to extend the
30 expiration date of the tax preferences.

31 (5) In order to obtain the data necessary to perform the review
32 in subsection (4) of this section, the joint legislative audit and
33 review committee may refer to data from the department of revenue's
34 annual survey ((data)) for tax years ending before January 1, 2020,
35 and annual tax performance report for subsequent tax years.

36 **Sec. 3.** RCW 19.02.085 and 2013 c 144 s 22 are each amended to
37 read as follows:

1 (1) To encourage timely renewal by applicants, a business license
2 delinquency fee is imposed on licensees who fail to renew by the
3 business license expiration date. The business license delinquency
4 fee must be the lesser of one hundred fifty dollars or fifty percent
5 of a base comprised of the licensee's renewal fee minus corporate
6 licensing taxes, corporation annual report fee, and any interest fees
7 or penalties charged for late taxes or corporate renewals. The
8 business license delinquency fee must be added to the renewal fee and
9 paid by the licensee before a business license is renewed. The
10 delinquency fee must be deposited in the business license account.

11 (2) The department must waive or cancel the business license
12 delinquency fee imposed in subsection (1) of this section only if the
13 department determines that the licensee failed to renew a license by
14 the business license expiration date due to an undisputable error or
15 failure by the department. For purposes of this subsection, an error
16 or failure is undisputable if the department is satisfied, beyond any
17 doubt, that the error or failure occurred.

18 **Sec. 4.** RCW 82.04.192 and 2017 c 323 s 514 are each amended to
19 read as follows:

20 (1) "Digital audio works" means works that result from the
21 fixation of a series of musical, spoken, or other sounds, including
22 ringtones.

23 (2) "Digital audiovisual works" means a series of related images
24 which, when shown in succession, impart an impression of motion,
25 together with accompanying sounds, if any.

26 (3)(a) "Digital automated service," except as provided in (b) of
27 this subsection (3), means any service transferred electronically
28 that uses one or more software applications.

29 (b) "Digital automated service" does not include:

30 (i) Any service that primarily involves the application of human
31 effort by the seller, and the human effort originated after the
32 customer requested the service;

33 (ii) The loaning or transferring of money or the purchase, sale,
34 or transfer of financial instruments. For purposes of this subsection
35 (3)(b)(ii), "financial instruments" include cash, accounts receivable
36 and payable, loans and notes receivable and payable, debt securities,
37 equity securities, as well as derivative contracts such as forward
38 contracts, swap contracts, and options;

39 (iii) Dispensing cash or other physical items from a machine;

- 1 (iv) Payment processing services;
- 2 (v) Parimutuel wagering and handicapping contests as authorized
3 by chapter 67.16 RCW;
- 4 (vi) Telecommunications services and ancillary services as those
5 terms are defined in RCW 82.04.065;
- 6 (vii) The internet and internet access as those terms are defined
7 in RCW 82.04.297;
- 8 (viii) The service described in RCW 82.04.050(6)(c);
- 9 (ix) Online educational programs provided by a:
- 10 (A) Public or private elementary or secondary school; or
- 11 (B) An institution of higher education as defined in sections
12 1001 or 1002 of the federal higher education act of 1965 (Title 20
13 U.S.C. Secs. 1001 and 1002), as existing on July 1, 2009. For
14 purposes of this subsection (3)(b)(ix)(B), an online educational
15 program must be encompassed within the institution's accreditation;
- 16 (x) Live presentations, such as lectures, seminars, workshops, or
17 courses, where participants are connected to other participants via
18 the internet or telecommunications equipment, which allows audience
19 members and the presenter or instructor to give, receive, and discuss
20 information with each other in real time;
- 21 (xi) Travel agent services, including online travel services, and
22 automated systems used by travel agents to book reservations;
- 23 (xii)(A) A service that allows the person receiving the service
24 to make online sales of products or services, digital or otherwise,
25 using either: (I) The service provider's web site; or (II) the
26 service recipient's web site, but only when the service provider's
27 technology is used in creating or hosting the service recipient's web
28 site or is used in processing orders from customers using the service
29 recipient's web site.
- 30 (B) The service described in this subsection (3)(b)(xii) does not
31 include the underlying sale of the products or services, digital or
32 otherwise, by the person receiving the service;
- 33 (xiii) Advertising services. For purposes of this subsection
34 (3)(b)(xiii), "advertising services" means all services directly
35 related to the creation, preparation, production, or the
36 dissemination of advertisements. Advertising services include layout,
37 art direction, graphic design, mechanical preparation, production
38 supervision, placement, and rendering advice to a client concerning
39 the best methods of advertising that client's products or services.
40 Advertising services also include online referrals, search engine

1 marketing and lead generation optimization, web campaign planning,
2 the acquisition of advertising space in the internet media, and the
3 monitoring and evaluation of web site traffic for purposes of
4 determining the effectiveness of an advertising campaign. Advertising
5 services do not include web hosting services and domain name
6 registration;

7 (xiv) The mere storage of digital products, digital codes,
8 computer software, or master copies of software. This exclusion from
9 the definition of digital automated services includes providing space
10 on a server for web hosting or the backing up of data or other
11 information;

12 (xv) Data processing services. For purposes of this subsection
13 (3)(b)(xv), "data processing service" means a primarily automated
14 service provided to a business or other organization where the
15 primary object of the service is the systematic performance of
16 operations by the service provider on data supplied in whole or in
17 part by the customer to extract the required information in an
18 appropriate form or to convert the data to usable information. Data
19 processing services include check processing, image processing, form
20 processing, survey processing, payroll processing, claim processing,
21 and similar activities. Data processing does not include the service
22 described in RCW 82.04.050(6)(c); and

23 (xvi) Digital goods.

24 (4) "Digital books" means works that are generally recognized in
25 the ordinary and usual sense as books.

26 (5) "Digital code" means a code that provides a purchaser with
27 the right to obtain one or more digital products, if all of the
28 digital products to be obtained through the use of the code have the
29 same sales and use tax treatment. "Digital code" does not include a
30 code that represents a stored monetary value that is deducted from a
31 total as it is used by the purchaser. "Digital code" also does not
32 include a code that represents a redeemable card, gift card, or gift
33 certificate that entitles the holder to select digital products of an
34 indicated cash value. A digital code may be obtained by any means,
35 including email or by tangible means regardless of its designation as
36 song code, video code, book code, or some other term.

37 (6)(a) "Digital goods," except as provided in (b) of this
38 subsection (6), means sounds, images, data, facts, or information, or
39 any combination thereof, transferred electronically, including, but
40 not limited to, specified digital products and other products

1 transferred electronically not included within the definition of
2 specified digital products.

3 (b) The term "digital goods" does not include:

4 (i) Telecommunications services and ancillary services as those
5 terms are defined in RCW 82.04.065;

6 (ii) Computer software as defined in RCW 82.04.215;

7 (iii) The internet and internet access as those terms are defined
8 in RCW 82.04.297;

9 (iv) (A) Except as provided in (b) (iv) (B) of this subsection (6),
10 the representation of a personal or professional service in
11 electronic form, such as an electronic copy of an engineering report
12 prepared by an engineer, where the service primarily involves the
13 application of human effort by the service provider, and the human
14 effort originated after the customer requested the service.

15 (B) The exclusion in (b) (iv) (A) of this subsection (6) does not
16 apply to photographers in respect to amounts received for the taking
17 of photographs that are transferred electronically to the customer,
18 but only if the customer is an end user, as defined in RCW
19 82.04.190(11), of the photographs. Such amounts are considered to be
20 for the sale of digital goods; and

21 (v) Services and activities excluded from the definition of
22 digital automated services in subsection (3) (b) (i) through (xv) of
23 this section and not otherwise described in (b) (i) through (iv) of
24 this subsection (6).

25 (7) "Digital products" means digital goods and digital automated
26 services.

27 (8) "Electronically transferred" or "transferred electronically"
28 means obtained by the purchaser by means other than tangible storage
29 media. It is not necessary that a copy of the product be physically
30 transferred to the purchaser. So long as the purchaser may access the
31 product, it will be considered to have been electronically
32 transferred to the purchaser.

33 (9) "Specified digital products" means electronically transferred
34 digital audiovisual works, digital audio works, and digital books.

35 (10) "Subscription radio services" means the sale of audio
36 programming by a radio broadcaster as defined in RCW (~~82.08.02081~~)
37 82.08.0208, except as otherwise provided in this subsection.
38 "Subscription radio services" does not include audio programming that
39 is sold on a pay-per-program basis or that allows the buyer to access

1 a library of programs at any time for a specific charge for that
2 service.

3 (11) "Subscription television services" means the sale of video
4 programming by a television broadcaster as defined in RCW
5 (~~82.08.02081~~) 82.08.0208, except as otherwise provided in this
6 subsection. "Subscription television services" does not include video
7 programming that is sold on a pay-per-program basis or that allows
8 the buyer to access a library of programs at any time for a specific
9 charge for that service, but only if the seller is not subject to a
10 franchise fee in this state under the authority of Title 47 U.S.C.
11 Sec. 542(a) on the gross revenue derived from the sale.

12 **Sec. 5.** RCW 82.04.4266 and 2015 3rd sp.s. c 6 s 202 are each
13 amended to read as follows:

14 (1) This chapter does not apply to the value of products or the
15 gross proceeds of sales derived from:

16 (a) Manufacturing fruits or vegetables by canning, preserving,
17 freezing, processing, or dehydrating fresh fruits or vegetables; or

18 (b) Selling at wholesale fruits or vegetables manufactured by the
19 seller by canning, preserving, freezing, processing, or dehydrating
20 fresh fruits or vegetables and sold to purchasers who transport in
21 the ordinary course of business the goods out of this state. A person
22 taking an exemption under this subsection (1)(b) must keep and
23 preserve records for the period required by RCW 82.32.070
24 establishing that the goods were transported by the purchaser in the
25 ordinary course of business out of this state.

26 (2) For purposes of this section, "fruits" and "vegetables" do
27 not include marijuana, useable marijuana, or marijuana-infused
28 products.

29 (3) A person claiming the exemption provided in this section must
30 file a complete annual (~~survey~~) tax performance report with the
31 department under RCW (~~82.32.585~~) 82.32.534.

32 (4) This section expires July 1, 2025.

33 **Sec. 6.** RCW 82.04.4268 and 2015 3rd sp.s. c 6 s 203 are each
34 amended to read as follows:

35 (1) In computing tax there may be deducted from the measure of
36 tax, the value of products or the gross proceeds of sales derived
37 from:

38 (a) Manufacturing dairy products; or

1 (b) Selling dairy products manufactured by the seller to
2 purchasers who either transport in the ordinary course of business
3 the goods out of this state or purchasers who use such dairy products
4 as an ingredient or component in the manufacturing of a dairy
5 product. A person taking an exemption under this subsection (1)(b)
6 must keep and preserve records for the period required by RCW
7 82.32.070 establishing that the goods were transported by the
8 purchaser in the ordinary course of business out of this state or
9 sold to a manufacturer for use as an ingredient or component in the
10 manufacturing of a dairy product.

11 (2) "Dairy products" has the same meaning as provided in RCW
12 82.04.260.

13 (3) A person claiming the exemption provided in this section must
14 file a complete annual ((survey)) tax performance report with the
15 department under RCW ((82.32.585)) 82.32.534.

16 (4) This section expires July 1, 2025.

17 **Sec. 7.** RCW 82.04.4269 and 2015 3rd sp.s. c 6 s 204 are each
18 amended to read as follows:

19 (1) This chapter does not apply to the value of products or the
20 gross proceeds of sales derived from:

21 (a) Manufacturing seafood products that remain in a raw, raw
22 frozen, or raw salted state at the completion of the manufacturing by
23 that person; or

24 (b) Selling manufactured seafood products that remain in a raw,
25 raw frozen, or raw salted state to purchasers who transport in the
26 ordinary course of business the goods out of this state. A person
27 taking an exemption under this subsection (1)(b) must keep and
28 preserve records for the period required by RCW 82.32.070
29 establishing that the goods were transported by the purchaser in the
30 ordinary course of business out of this state.

31 (2) A person claiming the exemption provided in this section must
32 file a complete annual ((survey)) tax performance report with the
33 department under RCW ((82.32.585)) 82.32.534.

34 (3) This section expires July 1, 2025.

35 **Sec. 8.** RCW 82.04.4327 and 1985 c 471 s 6 are each amended to
36 read as follows:

1 In computing tax (~~(there may be deducted)~~) under this chapter, an
2 artistic or cultural organization may deduct from the measure of tax
3 (~~(those)~~);

4 (1) All amounts received by the artistic or cultural
5 (~~(organizations which represent income derived from business~~
6 ~~activities conducted by the organization)~~) organization; and

7 (2) The value of articles manufactured by the artistic or
8 cultural organization solely for use by the organization in
9 displaying art objects or presenting artistic or cultural
10 exhibitions, performances, or programs for attendance or viewing by
11 the general public.

12 **Sec. 9.** RCW 82.04.4328 and 1985 c 471 s 7 are each amended to
13 read as follows:

14 (1) For the purposes of RCW (~~(82.04.4322, 82.04.4324,~~
15 ~~82.04.4326,)~~) 82.04.4327, 82.08.031, and 82.12.031, the term
16 "artistic or cultural organization" means an organization (~~(which)~~)
17 that is organized and operated exclusively for the purpose of
18 providing artistic or cultural exhibitions, presentations, or
19 performances or cultural or art education programs, as defined in
20 subsection (2) of this section, for viewing or attendance by the
21 general public. The organization must be a not-for-profit corporation
22 under chapter 24.03 RCW and managed by a governing board of not less
23 than eight individuals none of whom is a paid employee of the
24 organization or by a corporation sole under chapter 24.12 RCW. In
25 addition, to qualify for deduction or exemption from taxation under
26 RCW (~~(82.04.4322, 82.04.4324, 82.04.4326,)~~) 82.04.4327, 82.08.031,
27 and 82.12.031, the corporation (~~(shall)~~) must satisfy the following
28 conditions:

29 (a) No part of its income may be paid directly or indirectly to
30 its members, stockholders, officers, directors, or trustees except in
31 the form of services rendered by the corporation in accordance with
32 its purposes and bylaws;

33 (b) Salary or compensation paid to its officers and executives
34 must be only for actual services rendered, and at levels comparable
35 to the salary or compensation of like positions within the state;

36 (c) Assets of the corporation must be irrevocably dedicated to
37 the activities for which the exemption is granted and, on the
38 liquidation, dissolution, or abandonment by the corporation, may not
39 inure directly or indirectly to the benefit of any member or

1 individual except a nonprofit organization, association, or
2 corporation which also would be entitled to the exemption;

3 (d) The corporation must be duly licensed or certified when
4 licensing or certification is required by law or regulation;

5 (e) The amounts received that qualify for exemption must be used
6 for the activities for which the exemption is granted;

7 (f) Services must be available regardless of race, color,
8 national origin, or ancestry; and

9 (g) The director of revenue (~~shall~~) must have access to its
10 books in order to determine whether the corporation is exempt from
11 taxes.

12 (2) The term "artistic or cultural exhibitions, presentations, or
13 performances or cultural or art education programs" includes and is
14 limited to:

15 (a) An exhibition or presentation of works of art or objects of
16 cultural or historical significance, such as those commonly displayed
17 in art or history museums;

18 (b) A musical or dramatic performance or series of performances;
19 or

20 (c) An educational seminar or program, or series of such
21 programs, offered by the organization to the general public on an
22 artistic, cultural, or historical subject.

23 **Sec. 10.** RCW 82.08.0201 and 1992 c 194 s 10 are each amended to
24 read as follows:

25 Before January 1, 1994, and January 1st of each odd-numbered year
26 thereafter:

27 The department of licensing, with the assistance of the
28 department of revenue, (~~shall~~) must provide the office of financial
29 management and the fiscal committees of the legislature with an
30 updated estimate of the amount of revenue attributable to the taxes
31 imposed in RCW 82.08.020(2) (~~(, and the amount of revenue not~~
32 ~~collected as a result of RCW 82.44.023)~~).

33 **Sec. 11.** RCW 82.08.0208 and 2009 c 535 s 501 are each amended to
34 read as follows:

35 (1) The tax imposed by RCW 82.08.020 does not apply to the sale
36 of a digital code for one or more digital products if the sale of the
37 digital products to which the digital code relates is exempt from the
38 tax levied by RCW 82.08.020.

1 (2)(a) The tax imposed by RCW 82.08.020 does not apply to a
2 business or other organization for the purpose of making the digital
3 good or digital automated service, including a digital good or
4 digital automated service acquired through the use of a digital code,
5 or service defined as a retail sale in RCW 82.04.050(6)(c), available
6 free of charge for the use or enjoyment of the general public. The
7 exemption provided in this subsection (2) does not apply unless the
8 purchaser has the legal right to broadcast, rebroadcast, transmit,
9 retransmit, license, relicense, distribute, redistribute, or exhibit
10 the product, in whole or in part, to the general public.

11 (b) For purposes of this subsection (2), "general public" means
12 all persons and not limited or restricted to a particular class of
13 persons, except that the general public includes:

14 (i) A class of persons that is defined as all persons residing or
15 owning property within the boundaries of a state, political
16 subdivision of a state, or a municipal corporation; and

17 (ii) With respect to libraries, authorized library patrons.

18 (3)(a) The tax imposed by RCW 82.08.020 does not apply to the
19 sale to a business of digital goods, and services rendered in respect
20 to digital goods, if the digital goods and services rendered in
21 respect to digital goods are purchased solely for business purposes.
22 The exemption provided by this subsection (3) also applies to the
23 sale to a business of a digital code if all of the digital goods to
24 be obtained through the use of the code will be used solely for
25 business purposes.

26 (b) For purposes of this subsection (3), the following
27 definitions apply:

28 (i) "Business purposes" means any purpose relevant to the
29 business needs of the taxpayer claiming an exemption under this
30 subsection (3). Business purposes do not include any personal,
31 family, or household purpose. The term also does not include any
32 activity conducted by a government entity as that term is defined in
33 RCW 7.25.005; and

34 (ii) "Services rendered in respect to digital goods" means those
35 services defined as a retail sale in RCW 82.04.050(2)(g).

36 (4)(a) The tax imposed by RCW 82.08.020 does not apply to the
37 sale of digital goods, digital codes, digital automated services,
38 prewritten computer software, or services defined as a retail sale in
39 RCW 82.04.050(6)(c) to a buyer that provides the seller with an
40 exemption certificate claiming multiple points of use. An exemption

1 certificate claiming multiple points of use must be in a form and
2 contain such information as required by the department.

3 (b) A buyer is entitled to use an exemption certificate claiming
4 multiple points of use only if the buyer is a business or other
5 organization and the digital goods or digital automated services
6 purchased, or the digital goods or digital automated services to be
7 obtained by the digital code purchased, or the prewritten computer
8 software or services defined as a retail sale in RCW 82.04.050(6)(c)
9 purchased will be concurrently available for use within and outside
10 this state. A buyer is not entitled to use an exemption certificate
11 claiming multiple points of use for digital goods, digital codes,
12 digital automated services, prewritten computer software, or services
13 defined as a retail sale in RCW 82.04.050(6)(c) purchased for
14 personal use.

15 (c) A buyer claiming an exemption under this subsection (4) must
16 report and pay the tax imposed in RCW 82.12.020 and any local use
17 taxes imposed under the authority of chapter 82.14 RCW and RCW
18 81.104.170 directly to the department in accordance with RCW
19 82.12.0208 and 82.14.457.

20 (d) For purposes of this subsection (4), "concurrently available
21 for use within and outside this state" means that employees or other
22 agents of the buyer may use the digital goods, digital automated
23 services, prewritten computer software, or services defined as a
24 retail sale in RCW 82.04.050(6)(c) simultaneously from one or more
25 locations within this state and one or more locations outside this
26 state. A digital code is concurrently available for use within and
27 outside this state if employees or other agents of the buyer may use
28 the digital goods or digital automated services to be obtained by the
29 code simultaneously at one or more locations within this state and
30 one or more locations outside this state.

31 (5)(a) Except as provided in (b) of this subsection (5), the tax
32 imposed by RCW 82.08.020 does not apply to sales of audio or video
33 programming by a radio or television broadcaster.

34 (b)(i) Except as provided in (b)(ii) of this subsection (5), the
35 exemption provided in this subsection (5) does not apply in respect
36 to programming that is sold on a pay-per-program basis or that allows
37 the buyer to access a library of programs at any time for a specific
38 charge for that service.

39 (ii) The exemption provided in this subsection (5) applies to the
40 sale of programming described in (b)(i) of this subsection (5) if the

1 seller is subject to a franchise fee in this state under the
2 authority of Title 47 U.S.C. Sec. 542(a) on the gross revenue derived
3 from the sale.

4 (c) For purposes of this subsection (5), "radio or television
5 broadcaster" includes satellite radio providers, satellite television
6 providers, cable television providers, and providers of subscription
7 internet television.

8 (6) Sellers making tax-exempt sales under subsection (2) or (3)
9 of this section must obtain an exemption certificate from the buyer
10 in a form and manner prescribed by the department. The seller must
11 retain a copy of the exemption certificate for the seller's files. In
12 lieu of an exemption certificate, a seller may capture the relevant
13 data elements as allowed under the streamlined sales and use tax
14 agreement.

15 **Sec. 12.** RCW 82.08.025651 and 2011 c 23 s 4 are each amended to
16 read as follows:

17 (1) (a) The tax levied by RCW 82.08.020 does not apply to sales to
18 a public research institution of machinery and equipment used
19 primarily in a research and development operation, or to sales of or
