- 1 AN ACT Relating to incorporating the costs of employee health
- 2 benefits into school district contracts for pupil transportation; and
- 3 amending RCW 28A.160.140.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 28A.160.140 and 1990 c 33 s 140 are each amended to 6 read as follows:
- 9 district shall engage in an open competitive process at least once 10 every five years. This requirement shall not be construed to prohibit
- 11 a district from entering into a pupil transportation services
- 12 contract of less than five years in duration with a district option
- 13 to renew, extend, or terminate the contract, if the district engages
- 14 in an open competitive process at least once every five years after
- 15 July 26, 1987.
- 16 (b) Beginning on the effective date of this act, and until
- 17 December 31, 2019, any pupil transportation services contract must
- 18 <u>include:</u>
- (i) Sufficient funds specifically for the contracting employer to
- 20 provide the employees of the contractor with an employee health
- 21 benefits contribution equal to the allocation rate for school

- 1 employees for the months between the effective date of this act and January 1, 2020, less the retiree remittance for the public 3 employees' benefits board; and
 - (ii) An amount equivalent to the total employer and employee contribution rate to the school employees' retirement system, multiplied by estimated salaries of the employees of the contractor.
 - (c) Beginning January 1, 2020, any pupil transportation services contract must include:
 - (i) Sufficient funds specifically for the contracting employer to provide the employees of the contractor with an employer health benefits contribution equal to the monthly school employer funding rate for the school employees' benefits board program, less the retiree remittance for the public employees' benefits board; and
 - (ii) An amount equivalent to the total employer and employee contribution rate to the school employees' retirement system, multiplied by the estimated salaries of the employees of the contractor.

- (((1))) (a) "Employees of the contractor" means employees working sufficient compensated hours for the contracting employer performing services on the contract with the school district to meet the eligibility requirements for the school employees' benefits board program if the employee was directly employed by a school district;
- (b) "Open competitive process" means either one of the following, at the choice of the school district:
- $((\frac{1}{2}))$ (i) The solicitation of bids or quotations and the award of contracts under RCW 28A.335.190; or
- $((\frac{b}{b}))$ (ii) The competitive solicitation of proposals and their evaluation consistent with the process and criteria recommended or required, as the case may be, by the office of financial management for state agency acquisition of personal service contractors;
- $((\frac{(2)}{(2)}))$ (c) "Pupil transportation services contract" means a contract for the operation of privately owned or school district owned school buses, and the services of drivers or operators, management and supervisory personnel, and their support personnel such as secretaries, dispatchers, and mechanics, or any combination thereof, to provide students with transportation to and from school on a regular basis; and
