- 1 AN ACT Relating to providing for allied forces veteran 2 remembrance emblems; and amending RCW 46.18.295.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 46.18.295 and 2012 c 69 s 1 are each amended to read 5 as follows:
  - (1) (a) United States veterans discharged under honorable conditions (United States veterans) and individuals serving on active duty in the United States armed forces (active duty military personnel) may purchase a veterans remembrance emblem, campaign medal emblem, or military service award emblem. ((The))
- 11 <u>(b) Veterans of allied forces discharged under honorable</u> 12 <u>conditions (allied forces veterans) may purchase an allied forces</u> 13 veterans remembrance emblem.
  - $\underline{\text{(c)}}$   $\underline{\text{E}}$ mblems  $\underline{\text{((is))}}$   $\underline{\text{are}}$  to be displayed on license plates in the manner described by the department, existing vehicular registration procedures, and current laws.
- 17 (2) <u>United States veterans</u> and active duty military personnel who 18 served during periods of war or armed conflict may purchase a 19 remembrance emblem depicting campaign ribbons which they were 20 awarded.

  - (b) Show proof of eligibility through:
  - (i) Providing a DD-214 or discharge papers if a veteran;

- 31 (iv) Attesting in a notarized affidavit of their eligibility as 32 required under this section.
