- AN ACT Relating to using existing revenue sources for transportation purposes; adding new sections to chapter 82.32 RCW; adding a new section to chapter 43.135 RCW; adding a new section to chapter 46.68 RCW; and providing an effective date.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

September 30, 2019, and April 30, 2020.

- NEW SECTION. Sec. 1. A new section is added to chapter 82.32
 RCW to read as follows:
- 8 (1) By the last workday of the first and third calendar quarters,
 9 the state treasurer must transfer the amount specified in subsection
 10 (2) of this section from the general fund to the motor vehicle fund.
 11 The first two transfers under this subsection (1) must occur by
 - (2) The department must estimate the state general fund revenues derived from expenditures by the state department of transportation. The department must perform the estimate for tax collections in the immediately preceding third and fourth calendar quarters for the April transfer under subsection (1) of this section and tax collections in the immediately preceding first and second calendar quarters for the September transfer under subsection (1) of this section. The department must notify the state treasurer of this

- amount at least twenty days prior to the April or September transfer under subsection (1) of this section.

- 7 (b) "Expenditures by the state department of transportation" 8 means amounts paid by the state department of transportation with 9 respect to the purchase of any tangible personal property, digital 10 product, or labor, which is subject to state sales or use tax.
- NEW SECTION. Sec. 2. A new section is added to chapter 43.135 12 RCW to read as follows:
- 13 RCW 43.135.034(4) does not apply to the transfers under section 1 14 of this act.
- NEW SECTION. Sec. 3. A new section is added to chapter 46.68 RCW to read as follows:
- The one Washington road account is created in the motor vehicle fund. Money in the account must be spent only after appropriation. Expenditures from the account must be used only for highway purposes identified in the omnibus transportation budget and to pay the
- 21 principal and interest on the bonds authorized for one Washington
- 22 road account projects or improvements. For the purposes of this
- 23 section "highway purposes" has the same meaning as provided in
- 24 Article II, section 40 of the Washington state Constitution.

- NEW SECTION. Sec. 4. A new section is added to chapter 82.32 RCW to read as follows:
- 27 (1) The department must deposit into the one Washington road 28 account all revenue received from taxes imposed under chapters 82.08 29 and 82.12 RCW, as provided in subsection (2) of this section, upon 30 the sale of, use of, or charge made for:
 - (a) Motor vehicles, trailers, and semitrailers used, or of the type designed primarily to be used, upon the public streets and highways, for the convenience or pleasure of the owner, or for the conveyance, for hire, or otherwise of persons or property, including fixed loads and facilities for human habitation; but not including:

 (i) Dock and warehouse tractors and their cars or trailers, lumber

- 6 (d) Materials, labor, equipment, contracts, and components used 7 for building, repairing, or improving of any publicly owned street, 8 place, road, highway, easement, right-of-way, mass public 9 transportation terminal or parking facility, bridge, tunnel, or 10 trestle as described in RCW 82.04.050; and
- 11 (e) Construction, improvement, or repair of a ferry, ferry 12 terminal, or other facility operated by the Washington state ferries 13 or for the repair, overhaul, or the dry docking of any ferry operated 14 by the Washington state ferries.
- 15 (2) The department must deposit revenue received under subsection 16 (1) of this section into the one Washington road account, created in 17 section 3 of this act, as follows:
- 18 (a) Twenty percent of all revenue received during fiscal year 19 2022;
- 20 (b) Forty percent of all revenue received during fiscal year 21 2023;
- 22 (c) Sixty percent of all revenue received during fiscal year 23 2024;
- 24 (d) Eighty percent of all revenue received during fiscal year 25 2025; and
- 26 (e) One hundred percent of all revenue received during fiscal year 2026 and thereafter.
- NEW SECTION. Sec. 5. This act takes effect July 1, 2021.
