- 1 AN ACT Relating to provisional professional licenses for service
- 2 members and military spouses; adding a new section to chapter 43.24
- 3 RCW; and creating a new section.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 NEW SECTION. Sec. 1. (1) The legislature finds that many 6 professions with occupational licensing requirements have differing 7 requirements between states which an individual must fulfill before being allowed to practice that profession. This reality prevents 8 certain individuals from continuing work in their profession upon 9 10 moving to Washington state, until they complete often costly, time-11 consuming, and redundant application requirements.
- 12 (2) Furthermore, the legislature acknowledges the undue burden 13 this can cause military families who are frequently required to 14 relocate across state lines.
- 15 (3) It is, therefore, the intent of the legislature to direct the 16 department of licensing to establish procedures to issue a 17 provisional occupational license to perform professional services 18 regulated by the department to a member of the armed forces or an 19 active duty military spouse who is licensed to perform that practice 20 in another state.

- NEW SECTION. Sec. 2. A new section is added to chapter 43.24 RCW to read as follows:

- (a) "Active duty military spouse" means any person currently married to someone who is an active or reserve member in any branch of the armed forces of the United States, including the national guard, coast guard, and armed forces reserves.
 - (b) "Department" means the department of licensing.
- 9 (c) "Provisional license, certificate, registration, or permit"
 10 means immediate authorization to perform the full range of activities
 11 allowed with a standard license, certificate, registration, or permit
 12 for a period of three years, or the duration of a standard license,
 13 certificate, registration, or permit if less than three years.
 - (2) By January 1, 2021, the department shall establish procedures to issue a provisional license, certificate, registration, or permit to perform professional services regulated by the department to a member of the armed forces of the United States or an active duty military spouse who is:
- 19 (a) Currently certified, registered, or licensed, or has a permit 20 in good standing to perform professional services in another state; 21 and
- 22 (b) Stationed, or is the spouse of a member of the armed forces 23 who is stationed, in Washington.
 - (3) (a) An applicant must state in the application that he or she:
 - (i) Has requested verification from the other state or states that the person is currently licensed, certified, or registered, or has a permit; and
- (ii) Is not subject to any pending investigation, charges, or disciplinary action by the regulatory body of the other state or states.
- 31 (b) If the department finds reasonable cause to believe that an 32 applicant falsely affirmed or stated either of the requirements under 33 (a) of this subsection, the department may summarily suspend the 34 provisional license, certificate, registration, or permit pending an 35 investigation or further action to discipline or revoke the license, 36 certificate, registration, or permit.
- 37 (4) This section does not apply when there is a reciprocity 38 licensing agreement with a national organization in place to
