1 AN ACT Relating to human remains; amending RCW 68.04.020,
2 68.04.080, 68.04.120, 68.04.170, 68.04.260, 68.04.270, 68.05.175,
3 68.05.195, 68.05.205, 68.05.245, 68.24.010, 68.24.150, 68.50.108,
4 68.50.110, 68.50.130, 68.50.140, 68.50.160, 68.50.170, 68.50.185,
5 68.50.240, 68.50.270, 68.64.120, 70.15.010, 70.58.230, 70.58.260,
6 70.95K.010, 70.95M.090, 73.08.070, 73.08.080, 18.39.170, 18.39.217,
7 and 18.39.410; reenacting and amending RCW 18.39.010; adding new
8 sections to chapter 68.04 RCW; repealing RCW 68.05.390; providing an
9 effective date; and prescribing penalties.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

11 NEW SECTION. **Sec. 1.** A new section is added to chapter 68.04
12 RCW to read as follows:

13 The definitions in this chapter apply throughout this title
14 unless the context clearly requires otherwise.

15 **Sec. 2.** RCW 68.04.020 and 2005 c 365 s 27 are each amended to
16 read as follows:

17 "Human remains" or "remains" means the body of a deceased person,
18 includes the body in any stage of decomposition, and includes
19 ((eremated)) postreduction human remains.

1 NEW SECTION. **Sec. 3.** A new section is added to chapter 68.04
2 RCW to read as follows:

3 "Alkaline hydrolysis" or "hydrolysis" means the reduction of
4 human remains to bone fragments and essential elements in a licensed
5 hydrolysis facility using heat, pressure, water, and base chemical
6 agents.

7 NEW SECTION. **Sec. 4.** A new section is added to chapter 68.04
8 RCW to read as follows:

9 "Hydrolysis facility" means a structure, room, or other space in
10 a building or structure containing one or more hydrolysis vessels, to
11 be used for alkaline hydrolysis.

12 **Sec. 5.** RCW 68.04.080 and 2005 c 365 s 31 are each amended to
13 read as follows:

14 "Columbarium" means a structure, room, or other space in a
15 building or structure containing niches for permanent placement of
16 (~~eremated~~) postreduction human remains in a place used, or intended
17 to be used, and dedicated, for cemetery purposes.

18 **Sec. 6.** RCW 68.04.120 and 2005 c 365 s 34 are each amended to
19 read as follows:

20 "Inurnment" means placing (~~eremated~~) postreduction human
21 remains in a cemetery.

22 NEW SECTION. **Sec. 7.** A new section is added to chapter 68.04
23 RCW to read as follows:

24 "Natural organic reduction" means the contained, accelerated
25 conversion of human remains to soil.

26 NEW SECTION. **Sec. 8.** A new section is added to chapter 68.04
27 RCW to read as follows:

28 "Natural organic reduction facility" means a structure, room, or
29 other space in a building or real property where natural organic
30 reduction of a human body occurs.

31 **Sec. 9.** RCW 68.04.170 and 2005 c 365 s 38 are each amended to
32 read as follows:

33 "Niche" means a space in a columbarium for placement of
34 (~~eremated~~) postreduction human remains.

1 **Sec. 10.** RCW 68.04.260 and 2005 c 365 s 43 are each amended to
2 read as follows:

3 "Scattering garden" means a designated area in a cemetery for the
4 scattering of (~~cremated~~) postreduction human remains.

5 **Sec. 11.** RCW 68.04.270 and 2005 c 365 s 44 are each amended to
6 read as follows:

7 "Scattering" means the removal of (~~cremated~~) postreduction
8 human remains from their container for the purpose of scattering the
9 (~~cremated human~~) remains in any lawful manner.

10 NEW SECTION. **Sec. 12.** A new section is added to chapter 68.04
11 RCW to read as follows:

12 "Reduce," "reduction," or "reducing" means cremate or conduct the
13 process of alkaline hydrolysis or natural organic reduction.

14 NEW SECTION. **Sec. 13.** A new section is added to chapter 68.04
15 RCW to read as follows:

16 "Reduction facility" means a crematory, an alkaline hydrolysis
17 facility, or a natural organic reduction facility.

18 NEW SECTION. **Sec. 14.** A new section is added to chapter 68.04
19 RCW to read as follows:

20 "Postreduction human remains" means human remains after
21 reduction.

22 **Sec. 15.** RCW 68.05.175 and 2009 c 102 s 11 are each amended to
23 read as follows:

24 A (~~permit~~) license or endorsement issued (~~by the board or~~)
25 under chapter 18.39 RCW is required in order to operate a (~~crematory~~
26 ~~or conduct a cremation~~) reduction facility or to reduce human
27 remains.

28 **Sec. 16.** RCW 68.05.195 and 2005 c 365 s 58 are each amended to
29 read as follows:

30 Any person other than persons defined in RCW 68.50.160 who buries
31 or scatters (~~cremated~~) postreduction human remains by land, air, or
32 sea or performs any other disposition of (~~cremated~~) postreduction
33 human remains outside of a cemetery (~~shall~~) must have a permit

1 issued in accordance with RCW 68.05.100 and (~~shall be~~) are subject
2 to that section.

3 **Sec. 17.** RCW 68.05.205 and 2009 c 102 s 12 are each amended to
4 read as follows:

5 The director with the consent of the board (~~shall~~) must set all
6 fees for chapters 18.39, 68.05, 68.20, 68.24, 68.28, 68.32, 68.36,
7 68.40, 68.44, and 68.46 RCW in accordance with RCW 43.24.086,
8 including fees for licenses, certificates, regulatory charges,
9 permits, or endorsements, and the department (~~shall~~) must collect
10 the fees.

11 **Sec. 18.** RCW 68.05.245 and 2005 c 365 s 64 are each amended to
12 read as follows:

13 (1) All (~~crematory~~) permits, licenses, or endorsements issued
14 under this chapter (~~shall~~) or chapter 18.39 RCW must be issued for
15 the year and (~~shall~~) expire at midnight, the thirty-first day of
16 January of each year, or at whatever time during any year that
17 ownership or control of any cemetery authority (~~which~~) that
18 operates such (~~crematory~~) facility is transferred or sold.

19 (2) The director (~~shall~~) must set and the department (~~shall~~)
20 must collect in advance the fees required for licensing.

21 NEW SECTION. **Sec. 19.** RCW 68.05.390 (Permit or endorsement
22 required for cremation—Penalty) and 1987 c 331 s 32 are each
23 repealed.

24 **Sec. 20.** RCW 68.24.010 and 2005 c 365 s 73 are each amended to
25 read as follows:

26 Cemetery authorities may take by purchase, donation, or devise,
27 property consisting of lands, mausoleums, (~~crematories~~) reduction
28 facilities, and columbariums, or other property within which the
29 placement of human remains may be authorized by law.

30 **Sec. 21.** RCW 68.24.150 and 2005 c 365 s 81 are each amended to
31 read as follows:

32 Every person who pays, causes to be paid, or offers to pay to any
33 other person, firm, or corporation, directly or indirectly, except as
34 provided in RCW 68.24.140, any commission, bonus, or rebate, or other
35 thing of value in consideration of recommending or causing the

1 disposition of human remains in any (~~crematory~~) reduction facility
2 or cemetery, is guilty of a misdemeanor. Each violation (~~shall~~)
3 constitutes a separate offense.

4 **Sec. 22.** RCW 68.50.108 and 1953 c 188 s 8 are each amended to
5 read as follows:

6 No (~~dead body~~) one may embalm or reduce human remains upon
7 which the coroner, or prosecuting attorney, if there (~~be no~~) is not
8 a coroner in the county, may perform an autopsy or postmortem,
9 (~~shall be embalmed or cremated~~) without the consent of the coroner
10 having jurisdiction(~~, and~~). Failure to obtain such consent (~~shall~~
11 be) is a misdemeanor(~~:- PROVIDED, That~~). However, such autopsy or
12 postmortem must be performed within five days, unless the coroner
13 (~~shall~~) obtains an order from the superior court extending such
14 time.

15 **Sec. 23.** RCW 68.50.110 and 2005 c 365 s 138 are each amended to
16 read as follows:

17 Except in cases of dissection provided for in RCW 68.50.100, and
18 where human remains (~~shall~~) are rightfully (~~be~~) carried through
19 or removed from the state for the purpose of burial elsewhere, human
20 remains lying within this state, and the remains of any dissected
21 body, after dissection, (~~shall~~) must be decently buried(~~, or~~)
22 (~~cremated~~) reduced within a reasonable time after death.

23 **Sec. 24.** RCW 68.50.130 and 2005 c 365 s 139 are each amended to
24 read as follows:

25 Every person who performs a disposition of any human remains,
26 except as otherwise provided by law, in any place, except in a
27 cemetery or a building dedicated exclusively for religious purposes,
28 is guilty of a misdemeanor. Disposition of (~~cremated~~) postreduction
29 human remains may also occur on private property, with the consent of
30 the property owner; and on public or government lands or waters with
31 the approval of the government agency that has either jurisdiction or
32 control, or both, of the lands or waters.

33 **Sec. 25.** RCW 68.50.140 and 2005 c 365 s 140 are each amended to
34 read as follows:

35 (1) Every person who (~~shall~~) removes human remains, or any part
36 thereof, from a grave, vault, or other place where the same has been

1 buried or deposited awaiting burial or (~~cremation~~) reduction,
2 without authority of law, with intent to sell the same, or for the
3 purpose of securing a reward for its return, or for dissection, or
4 from malice or wantonness, is guilty of a class C felony.

5 (2) Every person who (~~shall~~) purchases or receives, except for
6 burial or (~~cremation~~) reduction, human remains or any part thereof,
7 knowing that the same has been removed contrary to the foregoing
8 provisions, is guilty of a class C felony.

9 (3) Every person who (~~shall~~) opens a grave or other place of
10 interment, temporary or otherwise, or a building where human remains
11 are placed, with intent to sell or remove the casket, urn, or of any
12 part thereof, or anything attached thereto, or any vestment, or other
13 article interred, or intended to be interred with the human remains,
14 is guilty of a class C felony.

15 (4) Every person who removes, disinters, or mutilates human
16 remains from a place of interment, without authority of law, is
17 guilty of a class C felony.

18 **Sec. 26.** RCW 68.50.160 and 2012 c 5 s 1 are each amended to read
19 as follows:

20 (1) A person has the right to control the disposition of his or
21 her own remains without the predeath or postdeath consent of another
22 person. A valid written document expressing the decedent's wishes
23 regarding the place or method of disposition of his or her remains,
24 signed by the decedent in the presence of a witness, is sufficient
25 legal authorization for the procedures to be accomplished.

26 (2) Prearrangements that are prepaid, or filed with a licensed
27 funeral establishment or cemetery authority, under RCW 18.39.280
28 through 18.39.345 and chapter 68.46 RCW are not subject to
29 cancellation or substantial revision by survivors. Absent actual
30 knowledge of contrary legal authorization under this section, a
31 licensed funeral establishment or cemetery authority (~~shall~~) may
32 not be held criminally nor civilly liable for acting upon such
33 prearrangements.

34 (3) If the decedent has not made a prearrangement as set forth in
35 subsection (2) of this section or the costs of executing the
36 decedent's wishes regarding the disposition of the decedent's remains
37 exceeds a reasonable amount or directions have not been given by the
38 decedent, the right to control the disposition of the remains of a
39 deceased person vests in, and the duty of disposition and the

1 liability for the reasonable cost of preparation, care, and
2 disposition of such remains devolves upon the following in the order
3 named:

4 (a) The person designated by the decedent as authorized to direct
5 disposition as listed on the decedent's United States department of
6 defense record of emergency data, DD form 93, or its successor form,
7 if the decedent died while serving in military service as described
8 in 10 U.S.C. Sec. 1481(a) (1)-(8) in any branch of the United States
9 armed forces, United States reserve forces, or national guard;

10 (b) The designated agent of the decedent as directed through a
11 written document signed and dated by the decedent in the presence of
12 a witness. The direction of the designated agent is sufficient to
13 direct the type, place, and method of disposition;

14 (c) The surviving spouse or state registered domestic partner;

15 (d) The majority of the surviving adult children of the decedent;

16 (e) The surviving parents of the decedent;

17 (f) The majority of the surviving siblings of the decedent;

18 (g) A court-appointed guardian for the person at the time of the
19 person's death.

20 (4) If any person to whom the right of control has vested
21 pursuant to subsection (3) of this section has been arrested or
22 charged with first or second degree murder or first degree
23 manslaughter in connection with the decedent's death, the right of
24 control is relinquished and passed on in accordance with subsection
25 (3) of this section.

26 (5) If a cemetery authority as defined in RCW 68.04.190 or a
27 funeral establishment licensed under chapter 18.39 RCW has made a
28 good faith effort to locate the person cited in subsection (3)(a)
29 through (g) of this section or the legal representative of the
30 decedent's estate, the cemetery authority or funeral establishment
31 (~~shall have~~) has the right to rely on an authority to bury or
32 (~~cremate~~) reduce the human remains, executed by the most
33 responsible party available, and the cemetery authority or funeral
34 establishment may not be held criminally or civilly liable for
35 burying or (~~cremating~~) reducing the human remains. In the event any
36 government agency or charitable organization provides the funds for
37 the disposition of any human remains, the cemetery authority,
38 reduction facility, or funeral establishment may not be held
39 criminally or civilly liable for (~~cremating~~) reducing the human
40 remains.

1 (6) The liability for the reasonable cost of preparation, care,
2 and disposition devolves jointly and severally upon all kin of the
3 decedent in the same degree of kindred, in the order listed in
4 subsection (3) of this section, and upon the estate of the decedent.

5 **Sec. 27.** RCW 68.50.170 and 2005 c 365 s 142 are each amended to
6 read as follows:

7 Any person signing any authorization for the interment or
8 (~~cremation~~) reduction of any human remains warrants the
9 truthfulness of any fact set forth in the authorization, the identity
10 of the person whose human remains are sought to be interred or
11 (~~cremated~~) reduced, and his or her authority to order interments or
12 (~~cremation~~) reduction. That person is personally liable for all
13 damage occasioned by or resulting from breach of such warranty.

14 **Sec. 28.** RCW 68.50.185 and 2005 c 365 s 143 are each amended to
15 read as follows:

16 (1) A person authorized to dispose of human remains (~~shall~~) may
17 not (~~cremate~~) reduce or cause to be (~~cremated~~) reduced more than
18 one human remains at a time unless written permission, after full and
19 adequate disclosure regarding the manner of (~~cremation~~) reduction,
20 has been received from the person or persons under RCW 68.50.160
21 having the authority to order (~~cremation~~) reduction. This
22 restriction (~~shall~~) does not apply when equipment, techniques, or
23 devices are employed that keep human remains separate and distinct
24 before, during, and after the (~~cremation~~) reduction process.

25 (2) Violation of this section is a gross misdemeanor.

26 **Sec. 29.** RCW 68.50.240 and 2005 c 365 s 147 are each amended to
27 read as follows:

28 The person in charge of any premises on which interments or
29 (~~cremations~~) reductions are made (~~shall~~) must keep a record of
30 all human remains interred or (~~cremated~~) reduced on the premises
31 under his or her charge, in each case stating the name of each
32 deceased person, date of (~~cremation or~~) interment or reduction, and
33 name and address of the funeral establishment.

34 **Sec. 30.** RCW 68.50.270 and 2005 c 365 s 148 are each amended to
35 read as follows:

1 The person or persons determined under RCW 68.50.160 as having
2 authority to order (~~cremation shall be~~) reduction is entitled to
3 possession of the (~~cremated~~) postreduction human remains without
4 further intervention by the state or its political subdivisions.

5 **Sec. 31.** RCW 68.64.120 and 2008 c 139 s 13 are each amended to
6 read as follows:

7 (1) When a hospital refers an individual at or near death to a
8 procurement organization, the organization shall make a reasonable
9 search of the records of the department of licensing and any donor
10 registry that it knows exists for the geographical area in which the
11 individual resides to ascertain whether the individual has made an
12 anatomical gift.

13 (2) A procurement organization must be allowed reasonable access
14 to information in the records of the department of licensing to
15 ascertain whether an individual at or near death is a donor.

16 (3) When a hospital refers an individual at or near death to a
17 procurement organization, the organization may conduct any reasonable
18 examination necessary to ensure the medical suitability of a part
19 that is or could be the subject of an anatomical gift for
20 transplantation, therapy, research, or education from a donor or a
21 prospective donor. During the examination period, measures necessary
22 to ensure the medical suitability of the part may not be withdrawn
23 unless the hospital or procurement organization knows that the
24 individual expressed a contrary intent.

25 (4) Unless prohibited by law other than this chapter, at any time
26 after a donor's death, the person to which a part passes under RCW
27 68.64.100 may conduct any reasonable examination necessary to ensure
28 the medical suitability of the body or part for its intended purpose.

29 (5) Unless prohibited by law other than this chapter, an
30 examination under subsection (3) or (4) of this section may include
31 an examination of all medical records of the donor or prospective
32 donor.

33 (6) Upon the death of a minor who was a donor or had signed a
34 refusal, unless a procurement organization knows the minor is
35 emancipated, the procurement organization shall conduct a reasonable
36 search for the parents of the minor and provide the parents with an
37 opportunity to revoke or amend the anatomical gift or revoke the
38 refusal.

1 (7) Upon referral by a hospital under subsection (1) of this
2 section, a procurement organization shall make a reasonable search
3 for any person listed in RCW 68.64.080 having priority to make an
4 anatomical gift on behalf of a prospective donor. If a procurement
5 organization receives information that an anatomical gift to any
6 other person was made, amended, or revoked, it shall promptly advise
7 the other person of all relevant information.

8 (8) Subject to RCW 68.64.100(9), 68.64.190, and 68.64.901, the
9 rights of the person to which a part passes under RCW 68.64.100 are
10 superior to the rights of all others with respect to the part. The
11 person may accept or reject an anatomical gift in whole or in part.
12 Subject to the terms of the document of gift and this chapter, a
13 person that accepts an anatomical gift of an entire body may allow
14 embalming, burial, or (~~(cremation)~~) reduction, and use of remains in
15 a funeral service. If the gift is of a part, the person to which the
16 part passes under RCW 68.64.100, upon the death of the donor and
17 before embalming, burial, or (~~(cremation, shall)~~) reduction must
18 cause the part to be removed without unnecessary mutilation.

19 (9) Neither the physician who attends the decedent at death nor
20 the physician who determines the time of the decedent's death may
21 participate in the procedures for removing or transplanting a part
22 from the decedent.

23 (10) A physician or technician may remove a donated part from the
24 body of a donor that the physician or technician is qualified to
25 remove.

26 **Sec. 32.** RCW 70.15.010 and 2018 c 184 s 2 are each amended to
27 read as follows:

28 The definitions in this section apply throughout this chapter
29 unless the context clearly requires otherwise.

30 (1) "Department" means the department of health.

31 (2) "Disaster relief organization" means an entity that provides
32 emergency or disaster relief services that include health or
33 veterinary services provided by volunteer health practitioners and
34 that:

35 (a) Is designated or recognized as a provider of those services
36 pursuant to a disaster response and recovery plan adopted by an
37 agency of the federal government or the department; or

38 (b) Regularly plans and conducts its activities in coordination
39 with an agency of the federal government or the department.

1 (3) "Emergency" means an event or condition that is an emergency,
2 disaster, or public health emergency under chapter 38.52 RCW.

3 (4) "Emergency declaration" means a proclamation of a state of
4 emergency issued by the governor under RCW 43.06.010.

5 (5) "Emergency management assistance compact" means the
6 interstate compact approved by congress by P.L. 104-321, 110 Stat.
7 3877, RCW 38.10.010.

8 (6) "Entity" means a person other than an individual.

9 (7) "Health facility" means an entity licensed under the laws of
10 this or another state to provide health or veterinary services.

11 (8) "Health practitioner" means an individual licensed under the
12 laws of this or another state to provide health or veterinary
13 services.

14 (9) "Health services" means the provision of treatment, care,
15 advice or guidance, or other services, or supplies, related to the
16 health or death of individuals or human populations, to the extent
17 necessary to respond to an emergency, including:

18 (a) The following, concerning the physical or mental condition or
19 functional status of an individual or affecting the structure or
20 function of the body:

21 (i) Preventive, diagnostic, therapeutic, rehabilitative,
22 maintenance, or palliative care; and

23 (ii) Counseling, assessment, procedures, or other services;

24 (b) Sale or dispensing of a drug, a device, equipment, or another
25 item to an individual in accordance with a prescription; and

26 (c) Funeral, (~~cremation~~) reduction as defined in section 12 of
27 this act, cemetery, or other mortuary services.

28 (10) "Host entity" means an entity operating in this state which
29 uses volunteer health practitioners to respond to an emergency.

30 (11) "License" means authorization by a state to engage in health
31 or veterinary services that are unlawful without the authorization.
32 The term includes authorization under the laws of this state to an
33 individual to provide health or veterinary services based upon a
34 national certification issued by a public or private entity.

35 (12) "Person" means an individual, corporation, business trust,
36 trust, partnership, limited liability company, association, joint
37 venture, public corporation, government or governmental subdivision,
38 agency, or instrumentality, or any other legal or commercial entity.

39 (13) "Scope of practice" means the extent of the authorization to
40 provide health or veterinary services granted to a health

1 practitioner by a license issued to the practitioner in the state in
2 which the principal part of the practitioner's services are rendered,
3 including any conditions imposed by the licensing authority.

4 (14) "State" means a state of the United States, the District of
5 Columbia, Puerto Rico, the United States Virgin Islands, or any
6 territory or insular possession subject to the jurisdiction of the
7 United States.

8 (15) "Veterinary services" means the provision of treatment,
9 care, advice or guidance, or other services, or supplies, related to
10 the health or death of an animal or to animal populations, to the
11 extent necessary to respond to an emergency, including:

12 (a) Diagnosis, treatment, or prevention of an animal disease,
13 injury, or other physical or mental condition by the prescription,
14 administration, or dispensing of vaccine, medicine, surgery, or
15 therapy;

16 (b) Use of a procedure for reproductive management; and

17 (c) Monitoring and treatment of animal populations for diseases
18 that have spread or demonstrate the potential to spread to humans.

19 (16) "Volunteer health practitioner" means a health practitioner
20 who provides health or veterinary services, whether or not the
21 practitioner receives compensation for those services. The term does
22 not include a practitioner who receives compensation pursuant to a
23 preexisting employment relationship with a host entity or affiliate
24 which requires the practitioner to provide health services in this
25 state, unless the practitioner is not a resident of this state and is
26 employed by a disaster relief organization providing services in this
27 state while an emergency declaration is in effect.

28 **Sec. 33.** RCW 70.58.230 and 2009 c 231 s 4 are each amended to
29 read as follows:

30 It (~~shall be~~) is unlawful for any person to inter, deposit in a
31 vault, grave, or tomb, (~~eremate~~) reduce as defined in section 12 of
32 this act, or otherwise dispose of, or disinter or remove from one
33 registration district to another, or hold for more than three
34 business days after death, the human remains of any person whose
35 death occurred in this state or any human remains which shall be
36 found in this state, without obtaining, from the local registrar of
37 the district in which the death occurred or in which the human
38 remains were found, a permit for the burial, disinterment, or removal
39 of the human remains. However, a licensed funeral director or

1 embalmer of this state or a funeral establishment licensed in another
2 state contiguous to Washington, with a current certificate of removal
3 registration issued by the director of the department of licensing,
4 may remove human remains from the district where the death occurred
5 to another registration district or Oregon or Idaho without having
6 obtained a permit but in such cases the funeral director or embalmer
7 (~~shall~~) must at the time of removing human remains file with or
8 mail to the local registrar of the district where the death occurred
9 a notice of removal upon a blank to be furnished by the state
10 registrar. The notice of removal (~~shall~~) must be signed or
11 electronically approved by the funeral director or embalmer and
12 (~~shall~~) must contain the name and address of the local registrar
13 with whom the certificate of death will be filed and the burial-
14 transit permit secured. Every local registrar, accepting a death
15 certificate and issuing a burial-transit permit for a death that
16 occurred outside his or her district, (~~shall be~~) is entitled to a
17 fee of one dollar to be paid by the funeral director or embalmer at
18 the time the death certificate is accepted and the permit is secured.
19 It (~~shall be~~) is unlawful for any person to bring into or transport
20 within the state or inter, deposit in a vault, grave, or tomb, or
