- AN ACT Relating to increasing availability of peer services for 1 2 persons with behavioral health disorders; adding a new chapter to Title 70 RCW; creating a new section; providing expiration dates; and 3
- 4 declaring an emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 NEW SECTION. Sec. 1. The definitions in this section apply 7 chapter unless the context clearly requires throughout this otherwise. 8
- (1) "Authority" means the Washington state health care authority. 9
- 10 (2) "Peer support services" means services authorized under RCW 11 71.24.385 which are delivered by individuals who have common life
- 12 experiences with the people they are serving.
- 13 Sec. 2. (1) The authority shall administer a peer NEW SECTION. counselor certification program to support the delivery of peer 14 15 support services in Washington state.
- 16 (2) By July 1, 2019, the authority shall incorporate education 17 and training for substance use disorder peers in its peer counselor 18 certification program.
- (3) By July 1, 2019, the authority must include reimbursement for 19 20 peer support services by substance use disorder peers in its

- 1 behavioral health capitation rates and allow for federal matching
- 2 funds, consistent with the directive enacted in section 213(5)(ss),
- 3 chapter 299, Laws of 2018 (ESSB 6032).
- 4 <u>NEW SECTION.</u> **Sec. 3.** To ensure an adequate workforce of peer
- 5 counselors, the authority must approve entities to perform
- 6 specialized peer training for peer counselor certification using the
- 7 state curriculum upon request if the entity meets qualifications to
- 8 perform the training as determined by the authority.
- 9 <u>NEW SECTION.</u> **Sec. 4.** (1) The authority shall cooperate with the
- 10 department of health to complete the sunrise review required under
- 11 section 5 of this act.
- 12 (2) This section expires June 30, 2021.
- 13 <u>NEW SECTION.</u> **Sec. 5.** (1) The department of health shall conduct
- 14 a sunrise review under chapter 18.120 RCW to evaluate the need for
- 15 creation of an advanced peer support specialist credential to provide
- 16 a license to perform peer support services in the areas of mental
- 17 health, substance use disorders, and forensic behavioral health. The
- 18 requirements for this credential must be accessible to persons in
- 19 recovery and:
- 20 (a) Integrate with and complement the attributes of the peer
- 21 counselor certification program administered by the Washington state
- 22 health care authority under section 1 of this act;
- 23 (b) Provide education, experience, and training requirements that
- 24 are more stringent than the requirements for the peer counselor
- 25 certification program but less extensive than the requirements for
- 26 licensure or certification under other credentials related to
- 27 behavioral health which are administered by the department of health;
- 28 (c) Provide oversight, structure, discipline, and continuing
- 29 education requirements typical for other professional licenses and
- 30 certifications;
- 31 (d) Allow advanced peer support specialists to maximize the scope
- 32 of practice suitable to their skills, lived experience, education,
- 33 and training;
- 34 (e) Allow advanced peer support specialists to practice and
- 35 receive reimbursement in behavioral health capitation rates in the
- 36 full range of settings in which clients receive behavioral health
- 37 services which are appropriate for their participation;

- (g) Incorporate consideration of common barriers to certification and licensure related to criminal history and recovery from behavioral health disorders experienced by peers and accommodate applicants who have these lived experiences to the greatest extent consistent with prudence and client safety.
  - (2) This section expires June 30, 2021.

- 9 <u>NEW SECTION.</u> **Sec. 6.** Sections 1 through 4 of this act 10 constitute a new chapter in Title 70 RCW.
- NEW SECTION. Sec. 7. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect immediately.
