## SUBSTITUTE SENATE BILL 5128

State of Washington 66th Legislature 2019 Regular Session

By Senate Transportation (originally sponsored by Senators Rolfes, Braun, Mullet, Nguyen, and Fortunato)

READ FIRST TIME 02/07/19.

- AN ACT Relating to reducing the electric motorcycle registration renewal fee; amending RCW 46.17.323; creating a new section; providing an effective date; and providing a contingent expiration date.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 46.17.323 and 2015 3rd sp.s. c 44 s 203 are each amended to read as follows:
  - (1) Before accepting an application for an annual vehicle registration renewal for a vehicle that both (a) uses at least one method of propulsion that is capable of being reenergized by an external source of electricity and (b) is capable of traveling at least thirty miles using only battery power, except for electric motorcycles, the department, county auditor or other agent, or subagent appointed by the director must require the applicant to pay a one hundred dollar fee in addition to any other fees and taxes required by law. The one hundred dollar fee is due only at the time of annual registration renewal.
- 18 (2) This section only applies to a vehicle that is designed to 19 have the capability to drive at a speed of more than thirty-five 20 miles per hour.

1 (3) (a) The fee under this section is imposed to provide funds to mitigate the impact of vehicles on state roads and highways and for the purpose of evaluating the feasibility of transitioning from a 3 revenue collection system based on fuel taxes to a road user 4 assessment system, and is separate and distinct from other vehicle 5 6 license fees. Proceeds from the fee must be used for highway purposes, and must be deposited in the motor vehicle fund created in 7 RCW 46.68.070, subject to (b) of this subsection. 8

- (b) If in any year the amount of proceeds from the fee collected 9 under this section exceeds one million dollars, the excess amount 10 11 over one million dollars must be deposited as follows:
- 12 (i) Seventy percent to the motor vehicle fund created in RCW 46.68.070; 13
- 14 (ii) Fifteen percent to the transportation improvement account created in RCW 47.26.084; and 15
- 16 (iii) Fifteen percent to the rural arterial trust account created 17 in RCW 36.79.020.
  - (4)(a) In addition to the fee established in subsection (1) of this section, before accepting an application for an annual vehicle registration renewal for a vehicle that both (i) uses at least one method of propulsion that is capable of being reenergized by an external source of electricity and (ii) is capable of traveling at least thirty miles using only battery power, except for electric motorcycles, the department, county auditor or other agent, or subagent appointed by the director must require the applicant to pay a fifty dollar fee.
  - The fee required under (a) of this subsection must be distributed as follows:
- (i) The first one million dollars raised by the fee must be 29 deposited into the multimodal transportation account created in RCW 30 31 47.66.070; and
- 32 (ii) Any remaining amounts must be deposited into the motor vehicle fund created in RCW 46.68.070. 33
- (5) Beginning October 1, 2019, before accepting an application 34 for an annual vehicle registration renewal for an electric motorcycle 35 36 that uses propulsion units powered solely by electricity, the department, county auditor or other agent, or subagent appointed by 37 the director must require the applicant to pay a thirty dollar fee in 38 39 addition to any other fees and taxes required by law. The thirty 40 dollar fee is due only at the time of annual registration renewal.

- 1 (6) The fees collected pursuant to subsections (5) and (6) of this section shall be deposited into the motor vehicle fund created in RCW 46.68.070.
- 4 <u>(7)</u> This section applies to annual vehicle registration renewals 5 until the effective date of enacted legislation that imposes a 6 vehicle miles traveled fee or tax.
- NEW SECTION. Sec. 2. Section 1 of this act expires on the effective date of legislation enacted by the legislature that imposes a vehicle miles traveled fee or tax.
- NEW SECTION. Sec. 3. The department of licensing must provide written notice of the expiration date of section 1 of this act to affected parties, the chief clerk of the house of representatives, the secretary of the senate, the office of the code reviser, and others as deemed appropriate by the department.
- 15 <u>NEW SECTION.</u> **Sec. 4.** This act takes effect October 1, 2019.
