1 AN ACT Relating to hemp production; amending RCW 69.50.204;
2 reenacting and amending RCW 69.50.101; adding a new section to
3 chapter 15.120 RCW; adding a new chapter to Title 15 RCW; repealing
4 RCW 15.120.005, 15.120.010, 15.120.020, 15.120.030, 15.120.035,
5 15.120.040, 15.120.050, and 15.120.060; making an appropriation;
6 providing an effective date; providing an expiration date; and
7 declaring an emergency.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

9 NEW SECTION. **Sec. 1.** The legislature intends to:

10 (1) Authorize and establish a new licensing and regulatory
11 program for hemp production in this state in accordance with the
12 agricultural improvement act of 2018, P.L. 115-334;

13 (2) Replace the industrial hemp research program in chapter
14 15.120 RCW, with the new licensing and regulatory program established
15 in this chapter, and enable hemp growers licensed under the
16 industrial research program on the effective date of rules
17 implementing this chapter and regulating hemp production, to transfer
18 into the program created in this chapter; and

19 (3) Authorize the growing of hemp as a legal, agricultural
20 activity in this state. Hemp is an agricultural product that may be
21 legally grown, produced, processed, possessed, transferred,

1 commercially sold, and traded. Hemp and hemp products produced in
2 accordance with this chapter may be transferred and sold within the
3 state, outside of this state, and internationally. Nothing in this
4 chapter is intended to prevent or restrain commerce in this state
5 involving hemp or hemp products produced lawfully under the laws of
6 another state or country.

7 NEW SECTION. **Sec. 2.** The definitions in this section apply
8 throughout this chapter unless the context clearly requires
9 otherwise.

- 10 (1) "CBD" means cannabidiol.
- 11 (2) "CBD product" has the same meaning as in RCW 69.50.101.
- 12 (3) "Crop" means hemp grown as an agricultural commodity.
- 13 (4) "Cultivar" means a variation of the plant *Cannabis sativa L.*
14 that has been developed through cultivation by selective breeding.
- 15 (5) "Department" means the Washington state department of
16 agriculture.
- 17 (6) "Food" means articles used for food or drink for human
18 consumption or food for animals.
- 19 (7) "Hemp" means the plant *Cannabis sativa L.* and any part of
20 that plant, including the seeds thereof and all derivatives,
21 extracts, cannabinoids, isomers, acids, salts, and salts of isomers,
22 whether growing or not, with a delta-9 tetrahydrocannabinol
23 concentration of not more than 0.3 percent on a dry weight basis.
- 24 (8) "Postharvest test" means a test of delta-9
25 tetrahydrocannabinol concentration levels of hemp after harvested
26 based on ground whole plant samples without heat applied.
- 27 (9) "Process" means the processing, compounding, or conversion of
28 hemp into hemp commodities or products.
- 29 (10) "Produce" means the planting, cultivation, growing, or
30 harvesting of hemp including hemp seed.

31 NEW SECTION. **Sec. 3.** (1) The department must develop an
32 agricultural commodity program to replace the industrial hemp
33 research pilot program in chapter 15.120 RCW, in accordance with the
34 agricultural improvement act of 2018, P.L. 115-334.

35 (2) The department has sole regulatory authority over the
36 production of hemp and may adopt rules to implement this chapter. All
37 rules relating to hemp, including any testing of hemp, are outside of
38 the control and authority of the liquor and cannabis board.

1 (3) If the department adopts rules implementing this chapter that
2 are effective by June 1, 2019, people licensed to grow hemp under
3 chapter 15.120 RCW may transfer into the regulatory program
4 established in this chapter, and continue hemp production under this
5 chapter. If the department adopts rules implementing this chapter
6 that are effective after June 1, 2019, people licensed to grow hemp
7 under chapter 15.120 RCW may continue hemp production under this
8 chapter as of the effective date of the rules.

9 NEW SECTION. **Sec. 4.** (1) The department must develop a proposal
10 outlining the state's plan for regulating hemp production in
11 accordance with this chapter and the agricultural improvement act of
12 2018, P.L. 115-334.

13 (2) The proposal for the state's plan must include the following
14 requirements and components:

15 (a) A practice for hemp producers to maintain relevant
16 information regarding land on which hemp is produced including a
17 legal description of the land, for a period of not less than three
18 calendar years;

19 (b) A procedure for testing, using post-decarboxylation or other
20 similarly reliable methods, delta-9 tetrahydrocannabinol
21 concentration levels of hemp, without the application of heat;

22 (c) A procedure for the effective disposal of plants, whether
23 growing or not, that are produced in violation of this chapter, and
24 products derived from such plants;

25 (d) Procedures for enforcement required under the agricultural
26 improvement act of 2018, P.L. 115-334, including a process for
27 licensees to comply with this chapter through a corrective action
28 plan in appropriate circumstances;

29 (e) A procedure for conducting annual inspections of, at a
30 minimum, a random sample of hemp producers to verify hemp is not
31 produced in violation of this chapter;

32 (f) A procedure for obtaining and submitting the information
33 described in section 297C(d)(2) of the agricultural improvement act
34 of 2018, P.L. 115-334, as applicable, to the secretary of the United
35 States department of agriculture not more than thirty days after the
36 date on which the information is received; and

37 (g) A certification that the state has the resources and
38 personnel to carry out the practices and procedures described in this
39 section.

1 (3) The proposal for the state's plan may include any other
2 practice or procedure established to the extent the practice or
3 procedure is consistent with the agricultural improvement act of
4 2018, P.L. 115-334.

5 NEW SECTION. **Sec. 5.** The department must develop a post harvest
6 test protocol for testing hemp under this chapter that includes
7 testing of whole plant samples.

8 NEW SECTION. **Sec. 6.** CBD and CBD products derived from hemp are
9 considered a food product that must be tested and treated in
10 accordance with other agricultural crop derived food products for
11 human and animal consumption.

12 NEW SECTION. **Sec. 7.** (1) There is a hemp producer license
13 issued by the department to applicants qualified under this chapter
14 and the agricultural improvement act of 2018, P.L. 115-334.

15 (2) The department must establish license fees in an amount that
16 will fund the implementation of this chapter and sustain the hemp
17 program. License fees and any money received by the department under
18 this chapter must be deposited in the hemp regulatory account created
19 in section 9 of this act.

20 NEW SECTION. **Sec. 8.** (1) The hemp authorized for production
21 under this chapter must be propagated through certified,
22 conventionally bred pedigreed seeds as determined by the department
23 through its rule-making authority and as provided in this section.
24 Except when grown by an accredited agricultural research institution
25 or by a registered seed breeder developing a new Washington seed
26 cultivar, hemp must be grown only from seed types identified in
27 subsection (2) of this section or identified on a list of approved
28 seed cultivars to be established by the department by rule.

29 (2) The following varieties of seed cultivars are deemed approved
30 for hemp production: Alyssa; Anka; CFX-1; CFX-2; Delores; X-59 (Hemp
31 Nut); Crag; CRS-1; USO 14; USO 31; and Zolotonosha 11.

32 (3) Except as provided in subsection (5) of this section, the
33 following varieties of seed cultivars are deemed approved for hemp
34 production but must undergo THC testing unless and until such time as
35 the department determines they are exempt from THC testing: Canda;
36 CanMa; Carmagnola; Carmen; CS; Deni; Epsilon 68; ESTA-1; Fasamo;

1 Fedrina 74; Fedura 17; Felina 34; Ferimon; Fibranova; Fibriko;
2 Fibrimon 24; Fibrimon 56; Finola; Futura 75; Joey; Jutta; Komplti;
3 Kompolti Hybrid TC; Kompolti Sargaszaru; Lovrin 110; Petera; Santhica
4 27; Silesia; UC-RGM; Uniko B; Yvonne; and Zolotonosha 15.

5 (4) In addition to those approved cultivars identified in
6 subsections (2) and (3) of this section, the department must
7 determine and adopt by rule a list of approved seed cultivars. In
8 establishing the list of department-approved seed cultivars, the
9 department should consider the following:

10 (a) Hemp seed cultivars that have been certified after December
11 31, 2012, by member organizations of the association of official seed
12 certifying agencies, including, but not limited to, the Canadian seed
13 growers' association; and

14 (b) Hemp seed cultivars that have been certified after December
15 31, 2012, by the organization of economic cooperation and
16 development.

17 (5) In addition to the hemp seed cultivars identified in
18 subsections (2), (3), and (4) of this section, until January 1, 2022,
19 a licensed hemp producer may produce hemp from any cultivar brought
20 into this state that has planting, growth, and stability records
21 covering at least three years. Any such cultivar is deemed approved
22 for planting.

23 (6) Hemp seeds are subject to the provisions and requirements of
24 RCW 15.49.370, which establishes the general regulatory authority of
25 the department with respect to agricultural seeds. Under this
26 authority, the department may sample, inspect, analyze, and generally
27 regulate the hemp seeds used by licensed growers in this state. The
28 department may also charge fees and special assessments to licensed
29 growers, as established by rule, related to the inspection, testing,
30 and certification of hemp seeds.

31 (7) For the purposes of this chapter and RCW 15.49.370, hemp seed
32 samples collected for inspection and testing purposes must be
33 directly taken into the custody of an authorized employee of the
34 department. Following collection, the department employee must
35 package and transport the seeds in a manner that ensures that the
36 integrity of the sample is maintained until delivery to the testing
37 facility.

38 (8) The department is not responsible for:

39 (a) Determining whether a specific hemp product has been derived
40 from approved hemp cultivars; or

1 (b) Taking any enforcement action requiring the determination of
2 whether a hemp product has been derived from approved hemp cultivars.

3 NEW SECTION. **Sec. 9.** The hemp regulatory account is created in
4 the custody of the state treasurer. All receipts from licensing fees
5 established under this chapter must be deposited into the account.
6 Expenditures from the account may be used only for implementing this
7 chapter. Only the director of the state department of agriculture or
8 the director's designee may authorize expenditures from the account.
9 The account is subject to allotment procedures under chapter 43.88
10 RCW, but an appropriation is not required for expenditures.

11 NEW SECTION. **Sec. 10.** The department must develop and make
12 accessible an internet-based application designed to assist hemp
13 producers by providing regional communications concerning recommended
14 planting times for hemp crops in this state.

15 NEW SECTION. **Sec. 11.** In an effort to prevent cross-pollination
16 between hemp plants produced under this chapter and marijuana plants
17 produced under chapter 69.50 RCW, the department, in consultation
18 with the liquor and cannabis board, must review the state's policy
19 regarding cross-pollination and pollen capture to ensure an
20 appropriate policy is in place, and must modify policies or establish
21 new policies as appropriate. Under any such policy, when a documented
22 conflict involving cross-pollination exists between two farms or
23 production facilities growing or producing hemp or marijuana, the
24 farm or production facility operating first in time shall have the
25 right to continue operating and the farm or production facility
26 operating second in time must cease growing or producing hemp or
27 marijuana, as applicable.

28 NEW SECTION. **Sec. 12.** (1)(a) A legislative task force on the
29 availability of crop insurance for hemp producers is established,
30 with members as provided in this subsection.

31 (i) The president of the senate shall appoint one member from
32 each of the two largest caucuses of the senate.

33 (ii) The speaker of the house of representatives shall appoint
34 one member from each of the two largest caucuses of the house of
35 representatives.

1 (iii) The president of the senate and the speaker of the house of
2 representatives shall jointly appoint the following members:

3 (A) One member who is a representative of the farm services
4 agency within the United States department of agriculture;

5 (B) One member who is a representative of the risk management
6 agency within the United States department of agriculture;

7 (C) One member who represents the Washington state department of
8 agriculture;

9 (D) One member who represents a state farm bureau within the
10 state; and

11 (E) One member who represents the hemp industry.

12 (b) The task force must choose its chair from among its
13 legislative membership. A member appointed under (a)(i) or (ii) of
14 this subsection (1) must convene the initial meeting of the task
15 force.

16 (2) The task force must review the following issue: Ensuring crop
17 insurance is available in this state for hemp producers so hemp
18 production can be expeditiously and successfully integrated into this
19 state's economy and people in this state can take full advantage of
20 the agricultural and economic opportunities created for hemp
21 production and commerce in the agriculture improvement act of 2018,
22 P.L. 115-334.

23 (3) Staff support for the task force must be provided by the
24 house of representatives office of program research and the senate
25 committee services.

26 (4) Legislative members of the task force are reimbursed for
27 travel expenses in accordance with RCW 44.04.120. Nonlegislative
28 members are not entitled to be reimbursed for travel expenses if they
29 are elected officials or are participating on behalf of an employer,
30 governmental entity, or other organization. Any reimbursement for
31 other nonlegislative members is subject to chapter 43.03 RCW.

32 (5) The expenses of the task force must be paid jointly by the
33 senate and the house of representatives. Task force expenditures are
34 subject to approval by the senate facilities and operations committee
35 and the house of representatives executive rules committee, or their
36 successor committees.

37 (6) The task force shall report its findings and recommendations
38 to the speaker of the house of representatives, the president of the
39 senate, the governor, and the appropriate committees of the
40 legislature by December 1, 2020.

1 (7) This section expires June 30, 2021.

2 NEW SECTION. **Sec. 13.** A new section is added to chapter 15.120
3 RCW to read as follows:

4 (1) On the effective date of rules adopted by the department
5 regulating hemp production under chapter 15.--- RCW (the new chapter
6 created in section 18 of this act), a licensed hemp grower under this
7 chapter may immediately produce hemp pursuant to chapter 15.--- RCW
8 (the new chapter created in section 18 of this act) with all the
9 privileges of a hemp producer licensed under chapter 15.--- RCW (the
10 new chapter created in section 18 of this act).

11 (2) This section expires January 1, 2020.

12 **Sec. 14.** RCW 69.50.101 and 2018 c 132 s 2 are each reenacted and
13 amended to read as follows:

14 The definitions in this section apply throughout this chapter
15 unless the context clearly requires otherwise.

16 (a) "Administer" means to apply a controlled substance, whether
17 by injection, inhalation, ingestion, or any other means, directly to
18 the body of a patient or research subject by:

19 (1) a practitioner authorized to prescribe (or, by the
20 practitioner's authorized agent); or

21 (2) the patient or research subject at the direction and in the
22 presence of the practitioner.

23 (b) "Agent" means an authorized person who acts on behalf of or
24 at the direction of a manufacturer, distributor, or dispenser. It
25 does not include a common or contract carrier, public
26 warehouseperson, or employee of the carrier or warehouseperson.

27 (c) "CBD concentration" has the meaning provided in RCW
28 69.51A.010.

29 (d) "CBD product" means any product containing or consisting of
30 cannabidiol.

31 (e) "Commission" means the pharmacy quality assurance commission.

32 (f) "Controlled substance" means a drug, substance, or immediate
33 precursor included in Schedules I through V as set forth in federal
34 or state laws, or federal or commission rules, but does not include
35 hemp as defined in section 2 of this act or industrial hemp as
36 defined in RCW 15.120.010.

1 (g) (1) "Controlled substance analog" means a substance the
2 chemical structure of which is substantially similar to the chemical
3 structure of a controlled substance in Schedule I or II and:

4 (i) that has a stimulant, depressant, or hallucinogenic effect on
5 the central nervous system substantially similar to the stimulant,
6 depressant, or hallucinogenic effect on the central nervous system of
7 a controlled substance included in Schedule I or II; or

8 (ii) with respect to a particular individual, that the individual
9 represents or intends to have a stimulant, depressant, or
10 hallucinogenic effect on the central nervous system substantially
11 similar to the stimulant, depressant, or hallucinogenic effect on the
12 central nervous system of a controlled substance included in Schedule
13 I or II.

14 (2) The term does not include:

15 (i) a controlled substance;

16 (ii) a substance for which there is an approved new drug
17 application;

18 (iii) a substance with respect to which an exemption is in effect
19 for investigational use by a particular person under Section 505 of
20 the federal food, drug, and cosmetic act, 21 U.S.C. Sec. 355, or
21 chapter 69.77 RCW to the extent conduct with respect to the substance
22 is pursuant to the exemption; or

23 (iv) any substance to the extent not intended for human
24 consumption before an exemption takes effect with respect to the
25 substance.

26 (h) "Deliver" or "delivery" means the actual or constructive
27 transfer from one person to another of a substance, whether or not
28 there is an agency relationship.

29 (i) "Department" means the department of health.

30 (j) "Designated provider" has the meaning provided in RCW
31 69.51A.010.

32 (k) "Dispense" means the interpretation of a prescription or
33 order for a controlled substance and, pursuant to that prescription
34 or order, the proper selection, measuring, compounding, labeling, or
35 packaging necessary to prepare that prescription or order for
36 delivery.

37 (l) "Dispenser" means a practitioner who dispenses.

38 (m) "Distribute" means to deliver other than by administering or
39 dispensing a controlled substance.

40 (n) "Distributor" means a person who distributes.

1 (o) "Drug" means (1) a controlled substance recognized as a drug
2 in the official United States pharmacopoeia/national formulary or the
3 official homeopathic pharmacopoeia of the United States, or any
4 supplement to them; (2) controlled substances intended for use in the
5 diagnosis, cure, mitigation, treatment, or prevention of disease in
6 individuals or animals; (3) controlled substances (other than food)
7 intended to affect the structure or any function of the body of
8 individuals or animals; and (4) controlled substances intended for
9 use as a component of any article specified in (1), (2), or (3) of
10 this subsection. The term does not include devices or their
11 components, parts, or accessories.

12 (p) "Drug enforcement administration" means the drug enforcement
13 administration in the United States Department of Justice, or its
14 successor agency.

15 (q) "Electronic communication of prescription information" means
16 the transmission of a prescription or refill authorization for a drug
17 of a practitioner using computer systems. The term does not include a
18 prescription or refill authorization verbally transmitted by
19 telephone nor a facsimile manually signed by the practitioner.

20 (r) "Immature plant or clone" means a plant or clone that has no
21 flowers, is less than twelve inches in height, and is less than
22 twelve inches in diameter.

23 (s) "Immediate precursor" means a substance:

24 (1) that the commission has found to be and by rule designates as
25 being the principal compound commonly used, or produced primarily for
26 use, in the manufacture of a controlled substance;

27 (2) that is an immediate chemical intermediary used or likely to
28 be used in the manufacture of a controlled substance; and

29 (3) the control of which is necessary to prevent, curtail, or
30 limit the manufacture of the controlled substance.

31 (t) "Isomer" means an optical isomer, but in subsection (ff)(5)
32 of this section, RCW 69.50.204(a) (12) and (34), and 69.50.206(b)(4),
33 the term includes any geometrical isomer; in RCW 69.50.204(a) (8) and
34 (42), and 69.50.210(c) the term includes any positional isomer; and
35 in RCW 69.50.204(a)(35), 69.50.204(c), and 69.50.208(a) the term
36 includes any positional or geometric isomer.

37 (u) "Lot" means a definite quantity of marijuana, marijuana
38 concentrates, useable marijuana, or marijuana-infused product
39 identified by a lot number, every portion or package of which is

1 uniform within recognized tolerances for the factors that appear in
2 the labeling.

3 (v) "Lot number" must identify the licensee by business or trade
4 name and Washington state unified business identifier number, and the
5 date of harvest or processing for each lot of marijuana, marijuana
6 concentrates, useable marijuana, or marijuana-infused product.

7 (w) "Manufacture" means the production, preparation, propagation,
8 compounding, conversion, or processing of a controlled substance,
9 either directly or indirectly or by extraction from substances of
10 natural origin, or independently by means of chemical synthesis, or
11 by a combination of extraction and chemical synthesis, and includes
12 any packaging or repackaging of the substance or labeling or
13 relabeling of its container. The term does not include the
14 preparation, compounding, packaging, repackaging, labeling, or
15 relabeling of a controlled substance:

16 (1) by a practitioner as an incident to the practitioner's
17 administering or dispensing of a controlled substance in the course
18 of the practitioner's professional practice; or

19 (2) by a practitioner, or by the practitioner's authorized agent
20 under the practitioner's supervision, for the purpose of, or as an
21 incident to, research, teaching, or chemical analysis and not for
22 sale.

23 (x) "Marijuana" or "marihuana" means all parts of the plant
24 *Cannabis*, whether growing or not, with a THC concentration greater
25 than 0.3 percent on a dry weight basis; the seeds thereof; the resin
26 extracted from any part of the plant; and every compound,
27 manufacture, salt, derivative, mixture, or preparation of the plant,
28 its seeds or resin. The term does not include:

29 (1) The mature stalks of the plant, fiber produced from the
30 stalks, oil or cake made from the seeds of the plant, any other
31 compound, manufacture, salt, derivative, mixture, or preparation of
32 the mature stalks (except the resin extracted therefrom), fiber, oil,
33 or cake, or the sterilized seed of the plant which is incapable of
34 germination; or

35 (2) Hemp as defined in section 2 of this act, seeds used for
36 licensed hemp production under chapter 15.--- RCW (the new chapter
37 created in section 18 of this act), or industrial hemp as defined in
38 RCW 15.120.010.

1 (y) "Marijuana concentrates" means products consisting wholly or
2 in part of the resin extracted from any part of the plant *Cannabis*
3 and having a THC concentration greater than ten percent.

4 (z) "Marijuana processor" means a person licensed by the state
5 liquor and cannabis board to process marijuana into marijuana
6 concentrates, useable marijuana, and marijuana-infused products,
7 package and label marijuana concentrates, useable marijuana, and
8 marijuana-infused products for sale in retail outlets, and sell
9 marijuana concentrates, useable marijuana, and marijuana-infused
10 products at wholesale to marijuana retailers.

11 (aa) "Marijuana producer" means a person licensed by the state
12 liquor and cannabis board to produce and sell marijuana at wholesale
13 to marijuana processors and other marijuana producers.

14 (bb) "Marijuana products" means useable marijuana, marijuana
15 concentrates, and marijuana-infused products as defined in this
16 section.

17 (cc) "Marijuana researcher" means a person licensed by the state
18 liquor and cannabis board to produce, process, and possess marijuana
19 for the purposes of conducting research on marijuana and marijuana-
20 derived drug products.

21 (dd) "Marijuana retailer" means a person licensed by the state
22 liquor and cannabis board to sell marijuana concentrates, useable
23 marijuana, and marijuana-infused products in a retail outlet.

24 (ee) "Marijuana-infused products" means products that contain
25 marijuana or marijuana extracts, are intended for human use, are
26 derived from marijuana as defined in subsection (x) of this section,
27 and have a THC concentration no greater than ten percent. The term
28 "marijuana-infused products" does not include either useable
29 marijuana or marijuana concentrates.

30 (ff) "Narcotic drug" means any of the following, whether produced
31 directly or indirectly by extraction from substances of vegetable
32 origin, or independently by means of chemical synthesis, or by a
33 combination of extraction and chemical synthesis:

34 (1) Opium, opium derivative, and any derivative of opium or opium
35 derivative, including their salts, isomers, and salts of isomers,
36 whenever the existence of the salts, isomers, and salts of isomers is
37 possible within the specific chemical designation. The term does not
38 include the isoquinoline alkaloids of opium.

39 (2) Synthetic opiate and any derivative of synthetic opiate,
40 including their isomers, esters, ethers, salts, and salts of isomers,

1 esters, and ethers, whenever the existence of the isomers, esters,
2 ethers, and salts is possible within the specific chemical
3 designation.

4 (3) Poppy straw and concentrate of poppy straw.

5 (4) Coca leaves, except coca leaves and extracts of coca leaves
6 from which cocaine, ecgonine, and derivatives or ecgonine or their
7 salts have been removed.

8 (5) Cocaine, or any salt, isomer, or salt of isomer thereof.

9 (6) Cocaine base.

10 (7) Ecgonine, or any derivative, salt, isomer, or salt of isomer
11 thereof.

12 (8) Any compound, mixture, or preparation containing any quantity
13 of any substance referred to in subparagraphs (1) through (7).

14 (gg) "Opiate" means any substance having an addiction-forming or
15 addiction-sustaining liability similar to morphine or being capable
16 of conversion into a drug having addiction-forming or addiction-
17 sustaining liability. The term includes opium, substances derived
18 from opium (opium derivatives), and synthetic opiates. The term does
19 not include, unless specifically designated as controlled under RCW
20 69.50.201, the dextrorotatory isomer of 3-methoxy-n-methylmorphinan
21 and its salts (dextromethorphan). The term includes the racemic and
22 levorotatory forms of dextromethorphan.

23 (hh) "Opium poppy" means the plant of the species *Papaver*
24 *somniferum* L., except its seeds.

25 (ii) "Person" means individual, corporation, business trust,
