- AN ACT Relating to prohibiting the location of homeless encampments near schools and early learning facilities; adding a new section to chapter 35.63 RCW; adding a new section to chapter 35A.63 RCW; adding a new section to chapter 36.70 RCW; adding a new section to chapter 36.70A RCW; and creating a new section.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. **Sec. 1.** A new section is added to chapter 35.63 RCW to read as follows:
- 9 (1) No city or town may authorize or through inaction allow for 10 the siting or establishment of a sanctioned or unsanctioned homeless 11 encampment of any kind including, but not limited to, outdoor 12 encampments, temporary small homes on-site, tiny homes sheltering 13 homeless persons, vehicle resident safe parking, or care or feeding 14 areas for homeless persons, within one thousand feet of a public or 15 private school, or an early learning facility.
