16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

17 NEW SECTION. **Sec. 1.** A supplemental capital budget is hereby
18 adopted and, subject to the provisions set forth in this act, the
19 several dollar amounts hereinafter specified, or so much thereof as
20 shall be sufficient to accomplish the purposes designated, are hereby
21 appropriated and authorized to be incurred for capital projects

1 during the period beginning with the effective date of this act and
2 ending June 30, 2021, out of the several funds specified in this act.

6 follows:

7 **FOR THE DEPARTMENT OF COMMERCE**

8 Building Communities Fund Program (30000803)

9 The reappropriation in this section is subject to the following
10 conditions and limitations:

11 (1) \$1,455,000 of the amount reappropriated in this section is
12 provided solely for the Byrd Barr place, formerly known as
13 Centerstone, building renovation project.

14 (2) \$220,000 of the amount reappropriated in this section is
15 provided solely for El Centro de la Raza boiler fan and master plan
16 for rehabilitation. This amount is not subject to the match
17 requirements, pursuant to RCW 43.63A.125.

27 **FOR THE DEPARTMENT OF COMMERCE**

28 2019-21 Housing Trust Fund Program (40000036)

29 The appropriations in this section are subject to the following
30 conditions and limitations:

31 (1) \$129,050,000 of the state taxable building construction
32 account—state appropriation and ~~(\$45,950,000)~~ \$42,950,000 of the
33 state building construction account—state appropriation are provided
34 solely for production and preservation of affordable housing. Of the
35 amounts in this subsection:

1 (a) \$35,000,000 of the appropriation is provided solely for
2 housing projects that provide supportive housing and case-management
3 services to persons with (~~behavioral or~~) chronic mental illness.
4 When evaluating applications for this population, the department must
5 prioritize low-income supportive housing unit proposals that show:

6 (i) Evidence that the application was developed in collaboration
7 with one or more health care entities that provide behavioral health
8 care services to individuals eligible for the housing provided under
9 this subsection;

10 (ii) A commitment by the applicant to provide, directly or
11 through a formal partnership, necessary treatment and supportive
12 services to the tenants and maintain the beds or housing units for at
13 least a forty-year period;

14 (iii) Readiness to begin structural modifications or construction
15 resulting in a fast project completion;

16 (iv) Program requirements that adhere to the key elements of
17 permanent supportive housing programs including choice in housing and
18 living arrangements, functional separation of housing and services,
19 community integration, rights of tenancy, and voluntary recovery-
20 focused services; and

21 (v) To achieve geographic distribution, the department must
22 prioritize projects in rural areas as defined by the department per
23 RCW 43.185.050 and unserved communities with the goal of maximizing
24 the investment and increasing the number of supportive housing units
25 in rural, unserved communities.

26 (b) \$10,000,000 of the appropriation in this section is provided
27 solely for competitive grant awards for modular housing which
28 includes high quality affordable housing projects that will quickly
29 move people from homelessness into secure housing and are
30 significantly less expensive to construct than traditional housing.
31 These funds must be awarded to projects with a total project
32 development cost per housing unit of less than \$125,000, excluding
33 the value of land, off-site infrastructure costs, and any capitalized
34 reserves, compliant with the Americans with disabilities act, and
35 with a commitment by the applicant to maintain the housing units for
36 at least a fifty year period.

37 (c) \$10,000,000 of the appropriation in this section is provided
38 solely for a state match or state matches on private contributions
39 that fund the production and preservation of affordable housing.
40 Awards must be made using a competitive process. If any funding

1 remains unallocated after the first fiscal year during the 2019-2021
2 fiscal biennium, the department may allocate the remaining funding
3 through its annual competitive process for affordable housing
4 projects that serve and benefit low-income and special needs
5 populations in need of housing.

6 (d) (i) \$10,000,000 of the appropriation in this section is
7 provided solely for housing preservation grants or loans to be
8 awarded competitively.

9 (ii) The funds may be provided for major building improvements,
10 preservation, and system replacements, necessary for the existing
11 housing trust fund portfolio to maintain long-term viability. The
12 department must require a capital needs assessment to be provided
13 prior to contract execution. Funds may not be used to add or expand
14 the capacity of the property.

15 (iii) To allocate preservation funds, the department must review
16 applications and evaluate projects based on the following criteria:

17 (A) The age of the property, with priority given to buildings
18 that are more than fifteen years old;

19 (B) The population served, with priority given to projects with
20 at least 50 percent of the housing units being occupied by families
21 and individuals at or below 50 percent area median income;

22 (C) The degree to which the applicant demonstrates that the
23 improvements will result in a reduction of operating or utilities
24 costs, or both;

25 (D) The potential for additional years added to the affordability
26 period of the property; and

27 (E) Other criteria that the department considers necessary to
28 achieve the purpose of this program.

29 (e) (i) \$7,000,000 of the appropriation in this section is
30 provided solely for loans or grants to design and construct ultra-
31 high energy efficient affordable housing projects.

32 (ii) To receive funding, a project must provide a life-cycle cost
33 analysis report to the department and must demonstrate energy-saving
34 and renewable energy systems either designed to reach net-zero energy
35 use after housing is fully occupied or designed to achieve the most
36 recent building standard of the passive house institute US as of the
37 effective date of this section.

38 (iii) The department must consider, at a minimum and in any
39 order, the following factors in assigning a numerical ranking to a
40 project:

1 (A) Whether the proposed design has demonstrated that the project
2 will achieve either net-zero energy use when fully occupied or will
3 achieve the most recent building standard of the passive house
4 institute US as of the effective date of this section;

5 (B) The life-cycle cost of the project;

6 (C) That the project demonstrates a design, use of materials, and
7 construction process that can be replicated by the Washington
8 building industry;

9 (D) The extent to which the project leverages nonstate funds;

10 (E) The extent to which the project is ready to proceed to
11 construction;

12 (F) Whether the project promotes sustainable use of resources and
13 environmental quality;

14 (G) Whether the project is being well managed to fund maintenance
15 and capital depreciation;

16 (H) Reduction of housing and utilities carbon footprint; and

17 (I) Other criteria that the department considers necessary to
18 achieve the purpose of this program.

19 (iv) The department must monitor and track the results of the
20 housing projects that receive ultra-high energy efficiency funding
21 under this section.

22 (f) (~~(\$45,950,000)~~) \$42,950,000 of the appropriation in this
23 section is provided solely for the following list of housing

5 (g) \$6,000,000 of the appropriation for Capitol Hill Housing
6 Broadway (Seattle) in (f) of this subsection is provided solely for
7 the purchase of the three south annex properties. The state board for
8 community and technical colleges must transfer the three south annex
9 properties located at 1530 Broadway, 1534 Broadway, and 909 East Pine
10 street in Seattle to Capitol Hill Housing to provide services and
11 housing for homeless youth or young adults for a minimum of fifty
12 years. The transfer agreement between the state board for community
13 and technical colleges and Capitol Hill Housing must specify a
14 mutually agreed transfer date and require Capitol Hill Housing to
15 cover any closing costs with a total purchase price of nine million
16 dollars for all three properties. The contract between the department
17 and Capitol Hill Housing must provide that Capitol Hill Housing will
18 be responsible for maintaining and securing the property until it is
19 developed. The contract must also specify that, if Capitol Hill
20 Housing does not construct at least seventy affordable housing units
21 on the site by 2028, this funding must be fully repaid to the state
22 or the land must revert back to the state.

23 (h) \$57,050,000 of the appropriation in this section is provided
24 solely for affordable housing projects that serve and benefit low-
25 income and special needs populations in need of housing. Of the
26 amounts appropriated in this subsection, the department must allocate
27 the funds as follows:

28 (i) \$5,000,000 of the appropriation in this section is provided
29 solely for housing for veterans;

30 (ii) \$5,000,000 of the appropriation in this section is provided
31 solely for housing that serves people with developmental
32 disabilities;

33 (iii) \$5,000,000 of the appropriation in this section is provided
34 solely for housing that serves people who are employed as
35 farmworkers; and

36 (iv) (A) \$5,000,000 of the appropriation in this section is
37 provided solely for housing projects that benefit homeownership.

38 (B) During the 2019-2021 fiscal biennium, the department must use
39 a separate application form for applications to provide homeownership

1 opportunities and evaluate homeownership project applications as
2 allowed under chapter 43.185A RCW.

3 (C) In addition to the definition of "first-time home buyer" in
4 RCW 43.185A.010, for the purposes of awarding homeownership projects
5 during the 2019-2021 fiscal biennium "first time home buyer" also
6 includes:

7 (I) A single parent who has only owned a home with a former
8 spouse while married;

9 (II) An individual who is a displaced homemaker as defined in 24
10 C.F.R. Sec. 93.2 as it existed on the effective date of this section,
11 or such subsequent date as may be provided by the department by rule,
12 consistent with the purposes of this section, and has only owned a
13 home with a spouse;

14 (III) An individual who has only owned a principal residence not
15 permanently affixed to a permanent foundation in accordance with
16 applicable regulations; or

17 (IV) An individual who has only owned a property that is
18 discerned by a licensed building inspector as being uninhabitable.

19 (2) In evaluating projects in this section, the department must
20 give preference for applications based on some or all of the criteria
21 in RCW 43.185.070(5).

22 (3)(a) The department must strive to allocate all of the amounts
23 appropriated in this section within the 2019-2021 fiscal biennium in
24 the manner prescribed in subsection (1) of this section. However, if
25 upon review of applications the department determines there are not
26 adequate suitable projects in a category, the department may allocate
27 funds to projects serving other low-income and special needs
28 populations, provided those projects are located in an area with an
29 identified need for the type of housing proposed.

30 (b) By June 30, 2021, the department must report on its web site
31 the following for every previous funding cycle: The number of
32 homeownership and multifamily rental projects funded by housing trust
33 fund moneys; the percentage of housing trust fund investments made to
34 homeownership and multifamily rental projects; and the total number
35 of households being served at up to eighty percent of the area median
36 income, up to fifty percent of the area median income, and up to
37 thirty percent of the area median income, for both homeownership and
38 multifamily rental projects.

39 (4)(a) The department, in cooperation with the housing finance
40 commission, must develop and implement a process for the collection

1 of certified final development cost data from each grant or loan
2 recipient under this section. The department must use this data as
3 part of its cost containment policy.

4 (b) Beginning December 1, 2019, and continuing annually, the
5 department must provide the legislature with a report of its final
6 cost data for each project under this section. Such cost data must,
7 at a minimum, include total development cost per unit for each
8 project completed within the past year, descriptive statistics such
9 as average and median per unit costs, regional cost variation, and
10 other costs that the department deems necessary to improve cost
11 controls and enhance understanding of development costs. The
12 department must coordinate with the housing finance commission to
13 identify relevant development costs data and ensure that the measures
14 are consistent across relevant agencies.

15 (5) \$10,000,000 of the state building construction account—state
16 appropriation is provided solely for the preservation of affordable
17 multifamily housing at risk of losing affordability due to expiration
18 of use restrictions that otherwise require affordability, including,
19 but not limited to, United States department of agriculture funded
20 multifamily housing.

21 (a) Within the amount provided in this subsection (5), the
22 department must implement necessary procedures no later than July 1,
23 2020, to enable rapid commitment of funds on a first-come, first-
24 served basis to qualifying project proposals that satisfy the goal of
25 long-term preservation of Washington's affordable multifamily housing
26 stock, particularly in rural areas of the state.

27 (b) The department must adhere to the following award terms and
28 procedures for the rapid response program created with this
29 appropriation:

30 (i) The department shall evaluate applications for funding based
31 on some or all of the criteria in RCW 43.185.070 (5).

32 (ii) The funding is not subject to the ninety-day application
33 periods in RCW 43.185.070 or 43.185A.050.

34 (iii) Awards must be in the form of a recoverable grant with a
35 forty-year low income housing covenant on the land.

36 (iv) If a capital needs assessment is required, the department
37 must work with the applicant to ensure that this does not create an
38 unnecessary impediment to rapidly accessing these funds.

39 (v) Awards may be used for acquisition, or for acquisition and
40 rehabilitation of, properties to preserve the affordable housing

1 units beyond existing use restrictions and keep them in Washington's
2 housing portfolio.

3 (vi) No single award may exceed \$2,500,000, although the
4 department must consider waivers of this award cap if an applicant
5 demonstrates sufficient need. If the department receives simultaneous
6 applications for funding under this program, proposals that reach the
7 greatest public benefit, as defined by the department, must be
8 prioritized. For purposes of this subsection (5), "greatest public
9 benefit" includes, but is not limited to:

10 (A) The greatest number of units that will be preserved;

11 (B) Whether the project has federally funded rental assistance
12 tied to it;

13 (C) The scarcity of the affordable housing applied for compared
14 to the number of available affordable housing units in the same
15 geographic location; and

16 (D) The program's established funding priorities under RCW
17 43.185.070(5).

18 (vii) The award limit in (vi) of this subsection (5) may only be
19 applied to the awards provided under this subsection (5). The amount
20 awarded from this subsection (5) may not be calculated in award
21 limitations for other housing trust fund awards.

8 **FOR THE DEPARTMENT OF COMMERCE**

9 Clean Energy Transition 4 (40000042)

10 The appropriations in this section are subject to the following
11 conditions and limitations:

12 (1) The appropriations are provided solely for projects that
13 provide a benefit to the public through development, demonstration,
14 and deployment of clean energy technologies that save energy and
15 reduce energy costs, reduce harmful air emissions, or increase energy
16 independence for the state. Priority must be given to projects that
17 benefit vulnerable populations, including tribes and communities with
18 high environmental or energy burden.

19 (2) In soliciting and evaluating proposals, awarding contracts,
20 and monitoring projects under this section, the department must:

21 (a) Ensure that competitive processes, rather than sole source
22 contracting processes, are used to select all projects, except as
23 otherwise noted in this section; and

24 (b) Conduct due diligence activities associated with the use of
25 public funds including, but not limited to, oversight of the project
26 selection process, project monitoring, and ensuring that all
27 applications and contracts fully comply with all applicable laws
28 including disclosure and conflict of interest statutes.

29 (3)(a) Pursuant to chapter 42.52 RCW, the ethics in public
30 service act, the department must require a project applicant to
31 identify in application materials any state of Washington employees
32 or former state employees employed by the firm or on the firm's
33 governing board during the past twenty-four months. Application
34 materials must identify the individual by name, the agency previously
35 or currently employing the individual, job title or position held,
36 and separation date. If it is determined by the department that a
37 conflict of interest exists, the applicant may be disqualified from
38 further consideration for award of funding.

1 (b) If the department finds, after due notice and examination,
2 that there is a violation of chapter 42.52 RCW, or any similar
3 statute involving a grantee who received funding under this section,
4 either in procuring or performing under the grant, the department in
5 its sole discretion may terminate the funding grant by written
6 notice. If the grant is terminated, the department must reserve its
7 right to pursue all available remedies under law to address the
8 violation.

9 (4) The requirements in subsections (2) and (3) of this section
10 must be specified in funding agreements issued by the department.

11 (5) \$6,107,000 of the state building construction account—state
12 appropriation is provided solely for grid modernization grants for
13 projects that: Advance clean and renewable energy technologies and
14 transmission and distribution control systems; support integration of
15 renewable energy sources, deployment of distributed energy resources,
16 and sustainable microgrids; and increase utility customer options for
17 energy sources, energy efficiency, energy equipment, and utility
18 services.

19 (a) Projects must be implemented by public and private electrical
20 utilities that serve retail customers in the state. Priority must be
21 given to: (i) Projects that benefit vulnerable populations, including
22 tribes and communities with high environmental or energy burden; and
23 (ii) projects that have a partner that is a tribe or nonprofit
24 organization that serves community eligible entities. Utilities may
25 partner with other public and private sector research organizations,
26 businesses, tribes, and nonprofit organizations in applying for
27 funding.

28 (b) The department shall develop a grant application process to
29 competitively select projects for grant awards, to include scoring
30 conducted by a group of qualified experts with application of
31 criteria specified by the department. In development of the
32 application criteria, the department shall, to the extent possible,
33 allow smaller utilities or consortia of small utilities to apply for
34 funding.

35 (c) Applications for grants must disclose all sources of public
36 funds invested in a project.

37 (d) \$4,400,000 of the state building construction account—state
38 appropriation is provided solely for providing shore power
39 electrification at terminal five for the northwest seaport alliance.
40 In order to receive this grant, the northwest seaport alliance must

1 demonstrate that they applied to the VW settlement for this project
2 and were denied.

3 (6) (a) \$8,100,000 of the state building construction account—
4 state appropriation is provided solely for competitive grants for
5 strategic research and development for new and emerging clean energy
6 technologies. These grants will be used to match federal or other
7 nonstate funds to research, develop, and demonstrate clean energy
8 technologies.

9 (b) The department shall consult and coordinate with the
10 University of Washington, Washington State University, the Pacific
11 Northwest national laboratory and other clean energy organizations to
12 design the grant program. Clean energy organizations who compete for
13 grants from the program may not participate in the design of the
14 grant program. Criteria for the grant program must include life cycle
15 cost analysis for projects that are part of the competitive process.

16 (c) The program may include, but is not limited to: Solar
17 technologies, advanced bioenergy and biofuels, development of new
18 earth abundant materials or lightweight materials, advanced energy
19 storage, battery components recycling, and new renewable energy and
20 energy efficiency technologies.

21 (d) \$1,000,000 of the state building construction account—state
22 appropriation is provided solely for grants that enhance the
23 viability of dairy digester bioenergy projects, energy efficiency,
24 and resource recovery to demonstrate advanced nutrient recovery
25 systems that produce value added biofertilizers, reduce trucking of
26 lagoon water, and improve soil health and air and water quality.
27 Grants shall include at least one project east of the Cascades and
28 one project west of the Cascades. State agencies must promote and
29 demonstrate the use of such recovered biofertilizers through state
30 procurement and contracts.

31 (7) (a) \$3,000,000 of the state taxable building construction
32 account—state appropriation is provided solely as grants to nonprofit
33 lenders to create a revolving loan fund to support the widespread use
34 of proven energy efficiency and renewable energy technologies by
35 households with high energy burden or environmental health risk now
36 inhibited by lack of access to capital.

37 (b) The department shall provide grant funds to one or more
38 competitively selected nonprofit lenders that will provide matching
39 private capital and will administer the loan fund. The department

1 must select the loan fund administrator or administrators through a
2 competitive process, with scoring conducted by a group of qualified
3 experts, applying criteria specified by the department.

4 (c) The department must establish guidelines that specify
5 applicant eligibility, the screening process, and evaluation and
6 selection criteria. The guidelines must be used by the nonprofit
7 lenders.

8 (8) \$5,000,000 of the state building construction account—state
9 appropriation is provided solely for the Washington Maritime
10 Innovation Center. The center must be used to support technology
11 acceleration and incubation, and act as a focal point for maritime
12 sustainability, including, but not limited to, supporting technology
13 development for maritime decarbonization and electrification.

14 (9) \$8,300,000 of the state taxable construction account—state
15 appropriation is provided solely for scientific instruments to help
16 accelerate research in grid-scale energy storage at the proposed
17 grid-scale energy storage research, development, and testing facility
18 at the Pacific Northwest national laboratory. The state funds are
19 contingent on securing federal funds for the new facility, and are
20 provided as a match to the federal funding. The instruments will
21 support collaborations with the University of Washington and the
22 Washington State University.

23 (10) \$593,000 of the state building construction account—state
24 appropriation is provided solely to the port of Grays Harbor for an
25 offshore ocean wave renewable energy demonstration project.

26 (11) \$1,500,000 of the state building construction account—state
27 appropriation is provided solely to the ((Port of)) Skagit county
28 public works department for the Guemes ferry dock shore power
29 charging infrastructure.

11 one representative from a managed care organization, one

31 funded and persons detained under the involuntary treatment act under
32 chapter 71.05 RCW;

33 (e) A commitment by the applicant to maintain and operate the
34 beds or facility for a time period commensurate to the state
35 investment, but for at least a fifteen-year period;

36 (f) The date upon which structural modifications or construction
37 would begin and the anticipated date of completion of the project;

38 (g) A detailed estimate of the costs associated with opening the
39 beds;

1 (h) A financial plan demonstrating the ability to maintain and
2 operate the facility; and

3 (i) The applicant's commitment to work with local courts and
4 prosecutors to ensure that prosecutors and courts in the area served
5 by the hospital or facility will be available to conduct involuntary
6 commitment hearings and proceedings under chapter 71.05 RCW.

7 (3) In awarding funding for projects in subsection (5) of this
8 section, the department, in consultation with the advisory group
9 established in subsection (1) of this section, must strive for
10 geographic distribution and allocate funding based on population and
11 service needs of an area. The department must consider current
12 services available, anticipated services available based on projects
13 underway, and the service delivery needs of an area.

14 (4) The department must prioritize projects that increase
15 capacity in unserved and underserved areas of the state.

16 (5) \$47,000,000 is provided solely for a competitive process for
17 each category listed and is subject to the criteria in subsections
18 (1), (2), (3), and (4) of this section:

19 (a) \$4,000,000 is provided solely for at least two enhanced
20 service facilities for long-term placement of patients discharged or
21 diverted from the state psychiatric hospitals and that are not
22 subject to federal funding restrictions that apply to institutions of
23 mental diseases;

24 (b) \$10,000,000 is provided solely for enhanced adult residential
25 care facilities for long-term placements of dementia discharged or
26 diverted from the state psychiatric hospitals and are not subject to
27 federal funding restrictions that apply to institutions of mental
28 diseases;

29 (c) \$4,000,000 is provided solely for at least two facilities
30 with secure withdrawal management and stabilization treatment beds
31 that are not subject to federal funding restrictions that apply to
32 institutions of mental diseases;

33 (d) \$2,000,000 is provided solely for one or more crisis
34 diversion or stabilization facilities to add sixteen beds in the
35 Spokane region that will address both urban and rural needs,
36 consistent with the settlement agreement in *A.B, by and through*
37 *Trueblood, et al., v. DSHS, et al.* and that are not subject to
38 federal funding restrictions that apply to institutions of mental
39 diseases;

1 (e) \$5,000,000 is provided solely for at least four mental health
2 peer respite centers that are not subject to federal funding
3 restrictions that apply to institutions of mental diseases. No more
4 than one mental health peer respite center should be funded in each
5 of the nine regions;

6 (f) \$8,000,000 is provided solely for the department to provide
7 grants to community hospitals, freestanding evaluation and treatment
8 providers, or freestanding psychiatric hospitals to develop capacity
9 for beds to serve individuals on ninety-day or one hundred eighty-day
10 civil commitments as an alternative to treatment in the state
11 hospitals. In awarding this funding, the department must coordinate
12 with the department of social and health services, the health care

32 behavioral health treatment facilities for long-term placement of
33 behavioral health patients with complex needs and that are not
34 subject to federal funding restrictions that apply to institutions of
35 mental diseases; and

36 (i) \$2,000,000 is provided solely for grants to community
37 providers to increase behavioral health services and capacity for
38 children and minor youth including, but not limited to, services for
39 substance use disorder treatment, sexual assault and traumatic
40 stress, anxiety, or depression, and interventions for children

1 exhibiting aggressive or depressive behaviors in facilities that are
2 not subject to federal funding restrictions. Consideration must be
3 given to programs that incorporate outreach and treatment for youth
4 dealing with mental health or social isolation issues.

30 section unless and until the nonstate share of project costs have
31 been either expended or firmly committed, or both, in an amount
32 sufficient to complete the project or a distinct phase of the project
33 that is useable to the public for the purpose intended by the
34 legislature. This requirement does not apply to projects where a
35 share of the appropriation is for design costs only.

36 (2) Prior to receiving funds, project recipients must demonstrate
37 that the project site is under control for a minimum of ten years,
38 either through ownership or a long-term lease. This requirement does

1 not apply to appropriations for preconstruction activities or
2 appropriations in which the sole purpose is to purchase real property
3 that does not include a construction or renovation component.

4 (3) Projects funded in this section may be required to comply
5 with Washington's high performance building standards as required by
6 chapter 39.35D RCW.

7 (4) Project funds are available on a reimbursement basis only,
8 and shall not be advanced under any circumstances.

9 (5) In contracts for grants authorized under this section the
10 department shall include provisions which require that capital
11 improvements be held by the grantee for a specified period of time

9 (1) The department shall not expend the appropriations in this
10 section unless and until the nonstate share of project costs have
11 been either expended or firmly committed, or both, in an amount
12 sufficient to complete the project or a distinct phase of the project
13 that is useable to the public for the purpose intended by the
14 legislature. This requirement does not apply to projects where a
15 share of the appropriation is for design costs only.

16 (2) Prior to receiving funds, project recipients must demonstrate
17 that the project site is under control for a minimum of ten years,
18 either through ownership or a long-term lease. This requirement does
19 not apply to appropriations for preconstruction activities or
20 appropriations in which the sole purpose is to purchase real property
21 that does not include a construction or renovation component.

24 (b) The Interbay public development advisory committee is created
25 to make recommendations regarding the highest public benefit and
26 future economic development uses for the Washington army national
27 guard armory facility in the city of Seattle, pier 91 property,
28 located at the descriptions referred to in the quit claim deeds for
29 two parcels of land, 24.75 acres total, dated January 8, 1971, and
30 December 22, 2009.

31 (c) The Interbay advisory committee consists of seven persons
32 appointed as follows:

- 33 (i) One person appointed by the speaker of the house of
34 representatives;
- 35 (ii) One person appointed by the president of the senate; and
- 36 (iii) Five persons appointed by the governor, who must
37 collectively have experience in forming public-private partnerships
38 to develop workforce housing or affordable housing; knowledge of
39 project financing options for public-private partnerships related to

1 housing; architectural design and development experience related to
2 industrial lands and mixed-use zoning to include housing; and
3 experience leading public processes to engage communities and other
4 stakeholders in public discussions regarding economic development
5 decisions.

6 (d) The Interbay public development advisory committee must:

7 (i) Work in collaboration with the military department to
8 determine the needs of the military department if it is relocated
9 from the land described in subsection (1) of this section, including
10 identifying:

11 (A) Current uses;

12 (B) Future needs of the units currently at this location;

13 (C) Potential suitable publicly owned sites in Washington for
14 relocation of current units; and

15 (D) The costs associated with acquisition, construction, and
16 relocation to another site or sites for these units;

17 (ii) Explore the future economic development opportunities if the
18 land described in subsection (1) of this section is vacated by the
19 military department, and make recommendations, including identifying:

20 (A) Suitable and unsuitable future uses for the land;

21 (B) Environmental issues and associated costs;

22 (C) Current public infrastructure availability, future public
23 infrastructure plans by local or regional entities, and potential
24 public infrastructure needs;

25 (D) Transportation corridors in the immediate area and any
26 potential right-of-way needs; and

27 (E) Existing zoning regulations for the land and potential future
28 zoning needs to evaluate workforce housing, affordable housing, and
29 other commercial and industrial development compatible with the
30 Ballard-Interbay manufacturing industrial center designation;

31 (iii) Explore the potential funding sources and partners as well
32 as any needed transactions, and make recommendations, including:

33 (A) Any potential private partners or investors;

34 (B) Necessary real estate transactions;

35 (C) Federal funding opportunities; and

36 (D) State and local funding sources, including any tax-related
37 programs; and

38 (iv) Conduct at least three public meetings at a location within
39 the Ballard-Interbay manufacturing industrial center, where a quorum
40 of the Interbay public development advisory committee members are

1 present, at which members of the public are invited to present to the
2 Interbay advisory committee regarding the future uses of the site and
3 potential issues such as industrial land use, commercial development,
4 residential zoning, and public infrastructure needs.

5 (e) Nothing in this section authorizes the solicitation of
6 interest or bids for work related to the purposes of this section.

7 (f) The department of commerce shall provide staff support to the
8 Interbay advisory committee. The department may contract with outside
9 consultants to provide any needed expertise.

10 (g) Legislative members of the Interbay advisory committee are
11 reimbursed for travel in accordance with RCW 44.04.120.
12 Nonlegislative members are not entitled to be reimbursed for travel
13 expenses if they are elected officials or are participating on behalf
14 of an employer, governmental entity, or other organization. Any
15 reimbursement for other nonlegislative members is subject to chapter
16 43.03 RCW.

17 (11) \$2,000,000 of the appropriation in this section is provided
18 solely to the city of Lakewood for the purchase of property within
19 the federally designated north clear zone at joint base Lewis-
20 McChord. Once acquired, the property must be zoned for use compatible
21 with the mission and activity of McChord airfield. The city may lease
22 or resell the acquired property for fair market value, but any such
23 lease or sale must include restrictions or covenants ensuring that
24 the use of the property is safely compatible with the mission and
25 activity of McChord airfield. If the city subsequently resells,
26 rezones, develops, or leases the property for commercial or
27 industrial uses contrary to the allowed uses in the north clear zone,
28 the city must repay to the state the amount spent on the purchase of

35 stakeholders, develop data-driven economic strategies, and produce a
36 written evaluation; and a tourism enhancement program to develop and
37 inventory the Federal Way area tourism sector, analyze data regarding
38 visitation, and produce a written evaluation.

1 (13) \$400,000 of the appropriation in this section is provided
2 solely for the Northshore athletic field which shall be named "Andy
3 Hill Sports Complex."
