- 1 AN ACT Relating to creating a new health profession for doulas;
- 2 reenacting and amending RCW 18.130.040; adding a new chapter to Title
- 3 18 RCW; and providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The definitions in this section apply
- 6 throughout this chapter unless the context clearly requires
- 7 otherwise.

- (1) "Department" means the department of health.
- 9 (2) "Doula" means a person trained to provide physical,
- 10 emotional, or informational support to a pregnant woman before,
- 11 during, and after delivery of a child including, but not limited to:
- 12 Support and assistance during labor and childbirth; prenatal and
- 13 postpartum education; breastfeeding assistance; parenting education;
- 14 and support in the event that a woman has been or will become
- 15 separated from her child.
- 16 (3) "Secretary" means the secretary of health.
- 17 <u>NEW SECTION.</u> **Sec. 2.** (1) A doula may voluntarily register with
- 18 the department under this section.
- 19 (2) The department shall issue a registration to any applicant

- 1 (a) Submitted a completed application on a form prescribed by the department; and
 - (b) Paid a registration fee established by the secretary in rule.
- 4 (3) The uniform disciplinary act, chapter 18.130 RCW, governs the issuance and denial of registrations and the discipline of registrants under this chapter.

7 <u>NEW SECTION.</u> **Sec. 3.** (1) The secretary shall:

- 8 (a) Establish registration and renewal fees, administrative 9 procedures, administrative requirements, and forms necessary to 10 implement this chapter in accordance with RCW 43.70.250 and 11 43.70.280;
- 12 (b) Maintain a record of all applicants and registrants under 13 this chapter; and
- 14 (c) Hire clerical, administrative, and investigative staff as 15 needed to implement and administer this chapter.
- 16 (2) All fees collected under this chapter must be credited to the 17 health professions account as required under RCW 43.70.320.
- NEW SECTION. Sec. 4. Nothing in this chapter prohibits a person from practicing as a doula without registering under this chapter.
- 20 **Sec. 5.** RCW 18.130.040 and 2019 c 444 s 11, 2019 c 308 s 18, and 21 2019 c 55 s 7 are each reenacted and amended to read as follows:
 - (1) This chapter applies only to the secretary and the boards and commissions having jurisdiction in relation to the professions licensed under the chapters specified in this section. This chapter does not apply to any business or profession not licensed under the chapters specified in this section.

- 34 (xxiii) Genetic counselors licensed under chapter 18.290 RCW;

- 5 (b) The boards and commissions having authority under this 6 chapter are as follows:
- 7 (i) The podiatric medical board as established in chapter 18.22 8 RCW;
- 9 (ii) The chiropractic quality assurance commission as established 10 in chapter 18.25 RCW;
- (iii) The dental quality assurance commission as established in chapter 18.32 RCW governing licenses issued under chapter 18.32 RCW, licenses and registrations issued under chapter 18.260 RCW, and certifications issued under chapter 18.350 RCW;
- 15 (iv) The board of hearing and speech as established in chapter 16 18.35 RCW:
- 17 (v) The board of examiners for nursing home administrators as 18 established in chapter 18.52 RCW;
- 19 (vi) The optometry board as established in chapter 18.54 RCW 20 governing licenses issued under chapter 18.53 RCW;
- (vii) The board of osteopathic medicine and surgery as established in chapter 18.57 RCW governing licenses issued under chapters 18.57 and 18.57A RCW;
- (viii) The pharmacy quality assurance commission as established in chapter 18.64 RCW governing licenses issued under chapters 18.64 and 18.64A RCW;
- (ix) The Washington medical commission as established in chapter 18.71 RCW governing licenses and registrations issued under chapters 18.71 and 18.71A RCW;
- 30 (x) The board of physical therapy as established in chapter 18.74 31 RCW;
- 32 (xi) The board of occupational therapy practice as established in 33 chapter 18.59 RCW;

- 1 (xv) The board of naturopathy established in chapter 18.36A RCW; 2 and
- 3 (xvi) The board of denturists established in chapter 18.30 RCW.
- 4 (3) In addition to the authority to discipline license holders, 5 the disciplining authority has the authority to grant or deny 6 licenses. The disciplining authority may also grant a license subject 7 to conditions.
- 8 (4) All disciplining authorities shall adopt procedures to ensure 9 substantially consistent application of this chapter, the uniform 10 disciplinary act, among the disciplining authorities listed in 11 subsection (2) of this section.
- NEW SECTION. Sec. 6. The secretary may adopt any rules necessary to implement this chapter.
- NEW SECTION. Sec. 7. Sections 1 through 4 and 6 of this act constitute a new chapter in Title 18 RCW.
- NEW SECTION. Sec. 8. Sections 1 through 5 of this act take effect January 1, 2021.
