#### **Senate Bills**

SB 5201 by Senators Palumbo, Rivers, and Mullet

Authorizing marijuana retailers to sell certain products and merchandise.

Authorizes the state liquor and cannabis board to adopt rules regarding: (1) Retail product design and marketing standards for marijuana merchandise and other products sold by licensed retailers; and

(2) The establishment of a retail product design and marketing standards to ensure that marijuana merchandise and other products sold by marijuana retailers are not intended to appeal to minors or otherwise encourage marijuana use by minors.

Jan 16 First reading, referred to Labor & Commerce.

SB 5202 by Senators Palumbo and Rivers

Regarding the ability of business and nonprofit entities to obtain a marijuana license.

Prohibits the issuance of any kind of marijuana-related license to a business entity or nonprofit entity, unless formed under state law or holding a certain certificate of registration.

Requires a person holding more than ten percent interest in the entity to possess the same qualifications required of the licensee, with the exception of any residency requirement.

Authorizes the state liquor and cannabis board to impose additional licensing fees to recover additional costs incurred in investigating a nonresident who is required to be investigated.

Gives discretionary authority to the board to deny a license or license renewal to an entity if, after reasonable efforts, the board is unable to investigate the nonresident, in accordance with the investigatory standards applicable to the investigation of a state resident.

SB 5203 by Senators Palumbo, Wagoner, Nguyen, Mullet, Carlyle, Hunt, Das, Randall, and Wellman

Creating an apprenticeship program for inmates.

Requires the secretary of the department of corrections to award a nongovernmental agency experienced with preapprenticeship training and employment navigation with one hundred thousand dollars annually to establish an apprenticeship opportunity pilot program at the Monroe correctional complex.

Requires the nongovernmental agency partner to: (1) Provide former inmates with the requisite tools and other support services to increase the likelihood of former inmates completing their apprenticeships; and

(2) Track certain information regarding the participating inmate for two years after his or her release. Expires January 1, 2024.

SB 5204 by Senators Palumbo, Wilson, L., Kuderer, and Randall

Preventing breed-based dog regulations.

Prohibits a city or county from: (1) Prohibiting the possession of a dog based upon its breed;

(2) Imposing requirements specific to possession of a dog based upon its breed; or

(3) Declaring a dog dangerous or potentially dangerous based upon its breed.

SB 5205 by Senators Dhingra, King, Frockt, Zeiger, Pedersen, Das, Rolfes, Palumbo, Kuderer, Keiser, Wellman, Hunt, Mullet, and Saldaña

Concerning provisions governing firearms possession by persons who have been found incompetent to stand trial and who have a history of one or more violent acts.

Prohibits a person from possessing a firearm if his or her charges are dismissed based on incompetency to stand trial and the court makes a finding indicating that the person has a history of one or more violent acts.

Providing a sales and use tax exemption for certain feminine hygiene products.

Provides a sales and use tax exemption for certain feminine hygiene products.

SB 5207 by Senators Dhingra, Hunt, Saldaña, Darneille,
Das, Cleveland, Kuderer, Pedersen, Salomon,

Concerning notification of felony voting rights and restoration.

Requires the department of corrections to notify an inmate of the process for provisional and permanent restoration of voting rights before the termination of authority over the inmate.

SB 5208 by Senators Palumbo, Wilson, L., Mullet, Wilson, C., Carlyle, Cleveland, Kuderer, Zeiger, Liias, Das, and Frockt

Concerning emergency medical services for animals.

Authorizes an emergency medical services provider, in an emergency medical or fire response or response to aid law enforcement, to provide certain emergency medical services to an animal before or during transfer for further treatment by a licensed veterinarian.

Jan 16 First reading, referred to Health & Long Term Care.

SB 5209 by Senators Palumbo, Rolfes, Hunt, Liias, and Pedersen

Concerning retail pet stores.

Prohibits a retail pet store from selling or offering for sale, a dog or cat, unless the dog or cat has been: (1) Obtained from an animal care and control agency or animal rescue group; and

(2) Spayed or neutered, or will be spayed or neutered

before the buyer takes possession of the animal.

Authorizes a retail pet store to enter into a cooperative agreement with an animal care and control agency or animal rescue group to showcase or display dogs or cats available for adoption.

SB 5210 by Senators Palumbo, Bailey, Rolfes, Wilson, C., Randall, Hunt, Das, and Keiser

Notifying purchasers of hearing instruments about uses and benefits of telecoil and bluetooth technology.

Requires a person who engages in fitting and dispensing of hearing instruments to: (1) Before initial fitting and purchase, notify a person seeking to purchase a hearing instrument, about the uses, benefits, and limitations of hearing instruments that are telecoil-enabled and compatible with assistive listening systems and that use bluetooth technology or other short range one-to-one technology similar to bluetooth; and

(2) Provide a receipt to each person who enters into an agreement to purchase a hearing instrument, containing language that verifies that before initial fitting and purchase the consumer was informed about the uses, benefits, and limitations of telecoil-enabled and bluetooth-enabled hearing instruments.

Requires the office of deaf and hard of hearing to develop educational materials to be distributed by hearing aid dispensers to persons with hearing loss that explain: (1) The uses, benefits, and limitations of current hearing assistive technology, including telecoil and bluetooth; and

(2) How a person can access assistive listening systems using telecoil-enabled hearing instruments.

SB 5211 by Senators Palumbo, Rolfes, Hunt, and Zeiger

Prohibiting the use of live animals to practice invasive medical procedures in paramedic training programs.

Authorizes paramedic training programs that train individuals in the medical treatment of persons to: (1) Only use human-based training methods; and

(2) Not use pigs or other live animals.

Makes an appropriation from the general fund to the Michael K. Copass paramedic training program at Harborview medical center to develop and produce simulator models for the use of paramedic trainees and practicing paramedics in their initial and ongoing training.

SB 5212 by Senators Palumbo, Wilson, L., Rolfes, Mullet, Wilson, C., Hunt, and Kuderer

Concerning the adoption of dogs and cats used for science or research purposes.

Requires certain higher education research facilities that use dogs or cats for scientific or research purposes and plan on euthanizing a dog or cat used for those purposes, to first offer the dog or cat for adoption.

SB 5213 by Senator Hobbs; by request of Office of Financial Management

Making 2017-2019 supplemental transportation appropriations.

Makes 2017-2019 supplemental transportation appropriations.

Jan 16 First reading, referred to Transportation.

SB 5214 by Senators Hobbs and Palumbo; by request of Office of Financial Management

Making transportation appropriations for the 2019-2021 fiscal biennium.

Makes transportation appropriations for the 2019-2021 fiscal biennium.

-- 2019 REGULAR SESSION --

Jan 16 First reading, referred to Transportation.

SB 5215 by Senators O'Ban, Rivers, Becker, Braun, Padden, Holy, Zeiger, Wilson, L., Brown, Schoesler, Warnick, and Short

Encouraging economic growth by providing a state business tax credit for new employment positions.

Provides a business and occupation tax credit for: (1) New employees hired for new positions created after July 1, 2019; and

(2) New positions filled by existing employees if the position vacated by the existing employee is filled by a new hire.

Requires the department of revenue to determine eligible areas for the following calendar year.

Requires the employment security department to provide the department of revenue with any information needed to verify eligibility.

Jan 16 First reading, referred to Financial Institutions, Economic Development & Trade.

#### SB 5216 by Senators O'Ban and Frockt

Developing multistage threat assessments to increase safety in K-12 schools and institutions of higher education.

Requires school districts and institutions of higher education to develop and implement a multistage threat assessment process that meets local safety needs and aligns with an evidence-based model.

Defines a threat assessment as a multistage structured team process used to evaluate the risk posed by a student, individuals, or groups typically as a response to an actual or perceived threat or concerning behavior.

Requires educational service districts to develop and maintain the capacity to offer training, coordination, and evaluation on the multistage threat assessment process.

Requires the reengagement plan to be communicated with law enforcement and service providers as appropriate.

SB 5217 by Senators Keiser, Conway, Kuderer, Frockt, and Saldaña

Concerning industrial insurance wage loss.

Revises the state industrial insurance act regarding the computation of wages and lost earning capacity of workers, and additional payments for prior pensioners.

Requires an employer insured with the department of labor and industries, who pays a worker's portion of a health insurance premium in addition to the employer portion, to be eligible for reimbursement of the amount he or she paid for the worker's portion of the premium.

SB 5218 by Senators Zeiger, Takko, and King

Concerning mobile food units.

Requires a local regulatory authority to grant a permit to operate a mobile food unit to an applicant in the authority's jurisdiction if the applicant: (1) Has obtained a valid permit to operate the mobile food unit from another local regulatory authority; and

(2) Provides certain information to the local regulatory authority from which the applicant is seeking a permit.

Requires the department of health and the state board of health to adopt rules to implement this act.

SB 5219 by Senators Padden, Pedersen, Becker, Palumbo, Zeiger, Van De Wege, Holy, Dhingra, Braun, Schoesler, Warnick, Ericksen, Honeyford, Bailey, Brown, Short, Sheldon, Fortunato, O'Ban, Das, Mullet, Wellman, and Wilson, L.

Concerning condominium construction warranties.

States that condominium construction warranties, under the state uniform common interest ownership act, do not apply to condominiums with less than seven units.

SB 5220 by Senators O'Ban, Palumbo, Conway, Becker, and Zeiger

Modifying the election and authority of regional transit authority board members.

Revises certain regional transit authority provisions regarding the authority, accountability, and election of board members.

Requires a five-member districting commission appointed by the governor to define the districts as soon as possible, but no later than December 31, 2019.

Jan 16 First reading, referred to Transportation.

SB 5221 by Senators Palumbo, Rivers, Billig, Wellman, Rolfes, Frockt, Hasegawa, Hunt, Kuderer, Mullet, Pedersen, and Saldaña

Concerning disclosure of contributions from political committees to other political committees.

Revises the fair campaign practices act regarding political action committees avoiding the requirement that political advertisements disclose the sponsor and the sponsor's top five donors.

Jan 16 First reading, referred to State Government, Tribal Relations & Elections.

SB 5222 by Senators Hasegawa, Hunt, and Keiser

Creating the whole Washington health trust.

Creates a single nonprofit health financing entity called the whole Washington health trust that will simplify health care financing, eliminate administrative waste for providers, promote a health care delivery system that is responsive to the essential health needs of each county, and guarantee all residents may enroll for coverage of a single comprehensive set of essential health benefits.

SB 5223 by Senators Palumbo, Rivers, Rolfes, King, Carlyle, Mullet, McCoy, Wellman, Das, Nguyen, Randall, Frockt, Salomon, Keiser, Wilson, C., Kuderer, Darneille, Cleveland, Saldaña, Dhingra, Pedersen, Conway, and Van De Wege

Concerning net metering.

Modifies certain net metering of electricity provisions regarding the cumulative generating capacity available; unused kilowatt-hour credits used to assist qualified low-income residential customers; and kilowatt-hours of electricity consumed for the most recent twelve-month period required on customer billing statements.

Requires the state building code council, in consultation with the department of commerce and local governments, to conduct a study of the state building code and adopt changes necessary to encourage greater use of renewable energy systems.

Requires the department of commerce to convene a work group to identify issues and laws associated with the future of net metering.

Provides a June 30, 2021, expiration date for the work group.

SB 5224 by Senators Kuderer, Hunt, Takko, Keiser, Nguyen, Darneille, Das, Wellman, Saldaña, McCoy, Hasegawa, and Pedersen

Concerning advisory votes.

Removes the advisory vote from the election statutes.

Jan 16 First reading, referred to State Government, Tribal Relations & Elections.

SB 5225 by Senators Takko and Short

Clarifying the contracting procedures for cities.

Provides a definition for "lowest responsible bidder" to clarify the contracting procedures for cities.

-- 2019 REGULAR SESSION --

Jan 16 First reading, referred to Local Government.

SB 5226 by Senators Kuderer, Conway, and Keiser

Concerning the off-duty conduct of an employee or a prospective employee.

Prohibits an employer from failing or refusing to hire an individual; discharging or barring a person from employment; or discriminating against a person in compensation or in other terms or conditions of employment, because the employee or prospective employee participates in or has participated in certain activities.

SB 5227 by Senators Kuderer, Hunt, Takko, Nguyen, and Billig

Concerning deadlines for receipt of voter registrations by election officials.

Requires voter registration applications to be received by an election official by the required voter registration deadline.

Provides information on how to submit a change of address.

Jan 16 First reading, referred to State Government, Tribal Relations & Elections.

SB 5228 by Senators Takko and Saldaña

Concerning the authorization to impose special excise taxes on the sale of lodging.

Addresses the imposition of special excise taxes on the sale of lodging.

Jan 16 First reading, referred to Local Government.

SB 5229 by Senators Zeiger, Hunt, Mullet, Palumbo, and Saldaña; by request of Secretary of State

Concerning the presidential primary.

Changes the dates for the presidential primary and for which the secretary of state may propose an alternative date for the primary.

Jan 16 First reading, referred to State Government, Tribal Relations & Elections.

SB 5230 by Senators Wilson, C. and Wilson, L.; by request of Department of Licensing

Amending motor vehicle laws to align with federal definitions, make technical corrections, and move an effective date to meet a federal timeline.

Revises certain motor vehicle laws to align with federal definitions; makes technical corrections; and delays an effective date to meet a federal timeline.

-- 2019 REGULAR SESSION --

Jan 16 First reading, referred to Transportation.

SB 5231 by Senators Bailey, Wagoner, Becker, Zeiger, Honeyford, Padden, Short, and Wilson, L.

Concerning veteran survivor tuition waiver eligibility.

Addresses college and university fee provisions regarding tuition waiver eligibility for veteran survivors and national guard member survivors.

Jan 16 First reading, referred to Higher Education & Workforce Development.

SB 5232 by Senators Bailey, Wagoner, Zeiger, Becker, and Honeyford

Concerning the qualifications of a legal newspaper.

Modifies legal publications provisions by requiring a newspaper to have the ability to verify circulation by an independent certified circulation audit, in order to be considered a legal newspaper.

## SB 5233 by Senators Keiser and Conway

Creating an alternative process for sick leave benefits for workers represented by collective bargaining agreements.

Allows workers covered under a collective bargaining agreement for the construction industry to negotiate comparable benefits that ensure that: (1) Eligibility can be achieved; and

(2) The benefits are portable from employer to employer.

Jan 16 First reading, referred to Labor & Commerce.

SB 5234 by Senators Keiser, Palumbo, Rivers, and Short

Modifying the excise tax for medical marijuana patients with recognition cards for products identified as beneficial for medical use.

Provides that, the marijuana excise tax does not apply to sales of the following, when sold by certain marijuana retailers: Marijuana concentrates, useable marijuana, or marijuana-infused products, identified by the department of health to be beneficial for medical use.

Requires each seller making exempt sales to maintain information establishing eligibility for the exemption in the form and manner required by the state liquor and cannabis board.

SB 5235 by Senators Keiser, King, Saldaña, Conway, Hasegawa, and Fortunato

Concerning plumbing.

Revises the plumbing laws.

SB 5236 by Senators Keiser, Conway, Wellman, Braun, Saldaña, Hasegawa, Wilson, C., Kuderer, Takko, Das, and Frockt

Encouraging apprenticeships.

Requires the following to employ a coordinator to do outreach and assist in establishing registered apprenticeship programs where they do not exist in state government, public education, and the health care industry: (1) The department of labor and industries, through the supervisor of apprenticeship;

(2) The office of financial management;

(3) The office of the superintendent of public instruction; and

(4) The department of health.

Includes "hours of work and instruction as a registered apprentice" in the definition of "prior learning," for purposes of academic credit.

SB 5237 by Senators Carlyle, Hunt, Saldaña, Nguyen, and Mullet

Creating a work group to replace certain Marcus Whitman statues

Creates a work group to study and make recommendations on an appropriate historical figure to represent the state in the state capitol and the national statuary hall in the United States capitol.

Provides a November 1, 2020, expiration date for the work group.

Jan 16 First reading, referred to State Government, Tribal Relations & Elections.

SB 5238 by Senators Carlyle, Randall, Wilson, C., Das, Frockt, and Keiser

Concerning concussions in youth sports.

Requires the University of Washington medicine sports health and safety institute and the Harborview injury prevention and research center to collect and synthesize: (1) The most current scientific research, data, evidence-based best practices to improve concussion recognition, and to educate parents, teachers, coaches, and other supervising adults to intervene when a sports concussion is suspected;

- (2) The most current research and data on the impact of concussions to female youth athletes and youth athletes participating in other than high-impact contact sports; and
- (3) Materials for licensed health care providers regarding concussion care.

Requires the University of Washington medicine sports health and safety institute to: (1) Develop and maintain a web site to serve as a repository for the collected information; and

(2) Work in conjunction with the Washington interscholastic activities association to promote the developed web site throughout the state.

Requires the University of Washington to maintain a web site of up-to-date, concussion-related information and resources.

SB 5239 by Senators Carlyle, Pedersen, Palumbo, and Mullet

Concerning commercial transportation services freight deliverers.

Revises certain definitions for purposes of chapter 48.177 RCW (commercial transportation services).

Jan 16 First reading, referred to Labor & Commerce.

## SB 5240 by Senators Carlyle and Braun

Authorizing the state investment board to invest the assets of the first-class cities' retirement systems.

Authorizes the state investment board to enter into agreements with the city councils or commissions of first-class cities to assume the duties of investing the retirement funds of the first-class cities' retirement systems.

Changes the composition of the state investment board.

Jan 16 First reading, referred to Ways & Means.

SB 5241 by Senators Short, Takko, Brown, and Mullet

Expanding the operable intent of RCW 34.05.271 and 34.05.272 to certain activities of natural resources agencies.

Requires the department of natural resources, before enacting a significant legislative rule, giving final approval to technical guidance documents, or finalizing habitat conservation plans, to identify the sources of scientific information reviewed and relied upon by the agency in the course of preparing to take the activity.

Requires the forest practices board, before enacting a significant legislative rule or giving final approval to technical guidance documents, to identify the sources of scientific information reviewed and relied upon by the board in the course of preparing to take the activity.

#### SB 5242 by Senators Short and Wilson, L.

Concerning the economic development of rural counties.

Revises the growth management act regarding the removal of a county and the cities within the county from the requirements to plan under that act.

#### SB 5243 by Senators Short and Wilson, L.

Concerning standing before the growth management hearings board.

Revises the growth management act regarding standing before the growth management hearings board.

-- 2019 REGULAR SESSION --

Jan 16 First reading, referred to Local Government.

SB 5244 by Senators Short, Dhingra, Wilson, L., and Das

Creating a domestic violence offender registry.

Requires the court, when a person is convicted of a qualifying domestic violence offense, to enter an order designating the person a serious domestic violence offender and requiring the person to appear on the serious domestic violence offender registry.

Requires the Washington state patrol to: (1) Maintain a central registry of serious domestic violence offenders;

- (2) Upon request of a person who appears on the registry, investigate whether the person's registration period has ended by operation of law;
- (3) Notify registered serious domestic violence offenders of any changes to the registration requirements; and
- (4) Notify an offender included on the registry for one or more offenses committed exclusively when the offender was a juvenile of his or her ability to petition for relief from registration.

Clarifying what science may be used by cities and counties to designate critical areas.

SB 5246 by Senators Hunt and Zeiger

Government.

Concerning sunshine committee recommendations.

Addresses recommendations of the sunshine committee on the public records act.

Exempts the following from public inspection and copying: (1) Applications for public employment other than for vacancies in elective office;

(2) Certain residential addresses but not including city, state, and zip codes, passports, and visa numbers;

- (3) Proprietary data, trade secrets, or other information that is submitted by a vendor to the department of social and health services for purposes of the development, acquisition, or implementation of state purchased health care:
  - (4) Trade secrets; and
- (5) Bids, quotations, or proposals submitted to an agency for goods or services in response to a solicitation issued for the goods or services until the agency announces the apparent successful bidder based on predetermined criteria or decides not to accept any bids, quotations, or proposals.

Addressing catastrophic incidents that are natural or human-caused emergencies by providing guidance that may be used by state public schools to plan for seismic catastrophic incidents.

Requires the adjutant general of the state military department to develop guidance, in consultation with the office of the superintendent of public instruction, that may be used by local school districts in developing, maintaining, training, and exercising catastrophic incident plans.

SB 5250 by Senators Mullet, Palumbo, Billig, Das, and Hunt

Concerning permanent daylight saving time in Washington state.

Requires the standard time for the state to be permanent daylight saving time year-round, which is that of the fifth zone designated by federal law as Pacific Standard Time, 15 U.S.C. Secs. 261 and 263, advanced by one hour.

Provides for submission of this act to a vote of the people.

Concerning prescription drug cost transparency.

(2) A pharmacy benefit manager; and

(3) A pharmacy services administrative organization representing a pharmacy or pharmacy chain in the state.

Requires a manufacturer to submit written notice informing the state health care authority that the manufacturer has filed the following with the federal food and drug administration: (1) A new drug application or biologics license application for a pipeline drug; or

(2) A biologics license application for a biological product or biosimilar drug.

Requires the state health care authority to prepare a list of ten prescription drugs that have a significant impact on state expenditures or are critical to public health.

Providing for approval of school district bonds by fiftyfive percent of the voters voting.

Takes effect if the proposed amendment to Article VII, section 2 of the state Constitution, providing for approval by fifty-five percent of voters voting to authorize school district bonds, is approved by the voters at the next general election and certified by the secretary of state.

#### SB 5253 by Senators Sheldon and Kuderer

Concerning the use of "van accessible" parking spots.

Includes the following in the definition of "unauthorized use," for purposes of this act: Use of a parking placard, special license plate, special year tab, or identification card to park in a "van accessible" parking space when not actually parking an eligible vehicle.

Modifying the operation of motorcycles on roadways laned for traffic.

Requires the department of transportation, once it has opened the use of the shoulder of a limited access facility for public transportation vehicles, to allow motorcycles to use the shoulder during the same time periods and conditions.

Prohibiting road usage charges in rural counties.

- (2) Provide mandatory training to the managers, supervisors, and employees;
- (3) Provide a list of resources for the employees to use; and
- (4) Provide a panic button to each worker that spends most of his or her working hours alongside two or fewer coworkers at a location that is not his or her home.

Requires the director of the department of labor and industries to establish procedures for licensing property service contractors.
