20 affordable housing and facilities where housing-related programs are
21 provided, or newly constructed evaluation and treatment centers."

20 (II) Revenue bonds issued pursuant to RCW 67.28.160 to finance a
21 fund to make such contracts, loans, or grants; or

22 (III) Revenue bonds issued pursuant to RCW 67.28.160 to finance
23 projects authorized by an authority under chapter 43.167 RCW to
24 promote sustainable workplace opportunities near a community impacted
25 by the construction or operation of tourism-related facilities.

26 (iii) The remainder must be used for capital or operating
27 programs that promote tourism and attract tourists to the county.
