1 On page 5, after line 40, insert the following:

2 "NEW SECTION. **Sec. 4.** A new section is added to chapter 28A.310
3 RCW to read as follows:

4 (1) The office of the superintendent of public instruction, in
5 collaboration with the association of educational service districts,
6 must select the educational service district with the most rural
7 counties to develop, and support local implementation of, two
8 apprenticeship preparation programs that provide high school students
9 with opportunities to earn college credit and that lead to industry-
10 recognized credentials.

11 (2)(a) The selected educational service district must collaborate
12 with state and local entities to develop and implement two
13 apprenticeship preparation program pathways: one in architecture and
14 construction and the other in skilled trades.

15 (b) The state and local entities to be collaborated with may
16 include the office of the superintendent of public instruction, the
17 Washington state apprenticeship and training council, the workforce
18 training and education coordinating board, Washington association for
19 career and technical education, the state board for community and
20 technical colleges, local school districts and high schools, local
21 labor unions, local Washington state apprenticeship and training
22 council registered apprenticeship programs, and local industry groups.

23 (3) The two apprenticeship preparation program pathways must meet
24 the following requirements:

25 (a) Meet the requirements for an approved preparatory secondary
26 career and technical education program under RCW 28A.700.030; and

1 (b) Seek formal recognition from the Washington apprenticeship and
2 training council as a recognized apprenticeship preparation program.

3 (4) For the 2022-23 and 2023-24 school years, the office of the
4 superintendent of public instruction must allocate funding to the
5 selected educational service district to hire a full-time certificated
6 instructional staff person to lead the development of the
7 apprenticeship preparation program pathways and to support the
8 implementation of the apprenticeship preparation program pathways in
9 the selected school districts.

10 (5) The selected educational service district must select two of
11 its school districts with student populations that are at least 25
12 percent non-white to implement the two apprenticeship preparation
13 program pathways beginning in the 2023-24 school year. Other school
14 districts are permitted to implement one or both of the apprenticeship
15 preparation program pathways.

16 (6) By October 15, 2025, and in accordance with RCW 43.01.036, the
17 office of the superintendent of public, in collaboration with the
18 selected educational service district and school districts
19 implementing the apprenticeship preparation program pathways, must
20 submit a report to the appropriate committees of the legislature on
21 the development and implementation of the apprenticeship preparation
22 program pathways. The report must:

23 (a) Describe best practices learned for developing pathways
24 through an educational service district;

25 (b) Describe each pathway developed, including skills taught, high
26 school and college credits offered, and options for earning industry-
27 recognized credentials;

28 (c) Include data on pathway implementation, including data on the
29 number and demographics of participating students and school
30 districts; and

31 (d) Recommend whether and how to expand implementation of the
32 pathways."

EFFECT: Requires the educational service district with the most rural counties to develop, and temporarily support local implementation of, two apprenticeship preparation programs that provide high school students with opportunities to earn college credit and that lead to industry-recognized credentials. Requires a report on the development and implementation of the apprenticeship preparation program pathways be submitted to the Legislature by October 15, 2025.
