12	On page 444, after line 22, insert the following:
13	"NEW SECTION. Sec. 951. A new section is added to chapter 4.92 RCW
14	to read as follows:
15	(1) The state digital data breach account is created in the
16	custody of the state treasurer. Revenues to the account consist of
17	legislative appropriations and transfers and other revenues provided
18	by law. Expenditures from the account may only be used for the payment
19	of eligible claims as provided in subsection (2) of this section. Only
20	the director or the director's designee may authorize expenditures
21	from the account. The account is subject to allotment procedures under
22	chapter 43.88 RCW, but an appropriation is not required for
23	expenditure.
24	(2) Expenditures from the account may only be used for the
25	department of enterprise services' office of risk management to
26	operate a digital data breach reimbursement claims program. In the
27	event of a breach of the security of the system owned or operated by

- 1 the state that results in the release of personal information,
- 2 individuals whose personal information was released may submit a claim
- 3 for reimbursement to the office of risk management for the following
- 4 costs incurred within one year of the date of the breach:
- 5 (a) Identity restoration services if an individual discovers
- 6 unauthorized use of their personal information as a result of the
- 7 state data breach;
- 8 (b) Losses from unauthorized charges to financial accounts that
- 9 result in direct financial harm to the individual;
- 10 (c) The cost for a new driver's license; and
- 11 (d) Costs for one year of credit monitoring.
- 12 (3) All claims brought under the digital data breach reimbursement
- 13 claims program created in subsection (2) of this section against the
- 14 state, or against the state's officers, employees, or volunteers,
- 15 acting in such capacity, for damages, must be presented to the office
- 16 of risk management within one year of the breach. A claim is deemed
- 17 presented when the claim form is delivered in person or by regular
- 18 mail, registered mail, or certified mail, with return receipt
- 19 requested, or as an attachment to email or by fax, to the office of
- 20 risk management. The office of risk management must develop a
- 21 standardized claim form for individuals to use to submit a claim. The
- 22 office must review all claims and determine if the claim is eligible
- 23 for payment.
- 24 (4) For the purposes of this section, "breach of the security of
- 25 the system" and "personal information" have the meanings defined in
- 26 RCW 19.255.005."

<u>EFFECT:</u> Creates the State Digital Data Breach Program Account and appropriates \$75.0 million General Fund-State into the account.

Provides that expenditures from the account may be used for the Department of Enterprise Services Office of Risk Management to administer a digital data breach reimbursement claims program.

Increases General Fund - State by \$75,000,000.
