Payments for state and federal medical 19 assistance programs for services provided by such a hospital, 20 regardless of the beneficiary's managed care enrollment status, must 21 be increased to one hundred fifty percent of the hospital's fee-for-22 service rates beginning July 1, 2021. The authority must discontinue 23 this rate increase after June 30, 2023, and return to the payment 24 levels and methodology for these hospitals that were in place as of 25 June 30, 2020. A hospital qualifying for this rate increase must:

- 1 (a) Have fewer than seventy available acute beds as reported in 2 the hospital's 2018 department of health year-end report;
- 3 (b) Not be currently designated as a critical access hospital,

- 6 (c) Not be a certified public expenditure hospital; and
- 7 (d) Have combined medicare and medicaid inpatient days greater
- 8 than eighty percent as reported in the hospital's 2018 cost report."

10 Renumber the remaining subsections consecutively and correct any

11 internal references accordingly.

<u>EFFECT:</u> Increases funding for the Health Care Authority to increase rates for Astria Toppenish Hospital to 150 percent of the Medicaid fee schedule for FY 2022 and 2023.
