- 18 (3) An individual, by virtue of their race or sex, is inherently
- 19 racist, sexist, or oppressive;
- 20 (4) An individual should be discriminated against or receive
- 21 adverse treatment solely or partly because of their race or sex;
- 22 (5) An individual's moral character is determined by their race or
- 23 sex;
- 24 (6) An individual, by virtue of their race or sex, bears
- 25 responsibility for actions committed in the past by other members of
- 26 the same race or sex;

- 1 (7) Any individual should feel discomfort, guilt, anguish, or any 2 other form of psychological distress on account of their race or sex;
- 3 (8) Meritocracy or traits such as a hard work ethic are racist or 4 sexist, or were created by a particular race to oppress another race; 5 or
- (9) Any other form of race or sex stereotyping or any other form 7 of race or sex scapegoating. For the purposes of this subsection, 8 "race or sex stereotyping" means ascribing character traits, values, 9 moral and ethical codes, privileges, status, or beliefs to a race or 10 sex, or to an individual because of their race or sex, and "race or 11 sex scapegoating" means assigning fault, blame, or bias to a race or 12 sex, or to members of a race or sex because of their race or sex. It 13 similarly encompasses any claim that, consciously or unconsciously, 14 and by virtue of their race or sex, members of any race are inherently 15 racist or are inherently inclined to oppress others, or that members 16 of a sex are inherently sexist or inclined to oppress others."

EFFECT:

- Specifies that the diversity, equity, inclusion, and antiracism trainings for faculty, staff, and students may not contain, or instruct on, any of the nine listed topics.
- Defines the terms "race or sex stereotyping" and "race or sex scapegoating."
